- ❑ **Tax** = Gambling tax (gambling tax levied and collected by Provincial Licensing Authorities)
- ❑ **RTP** = Return to Player is an average achieved over a significant number of game plays and not each time the gaming machine is played (Total amount returned to players / Total amount wagered by players x 100)

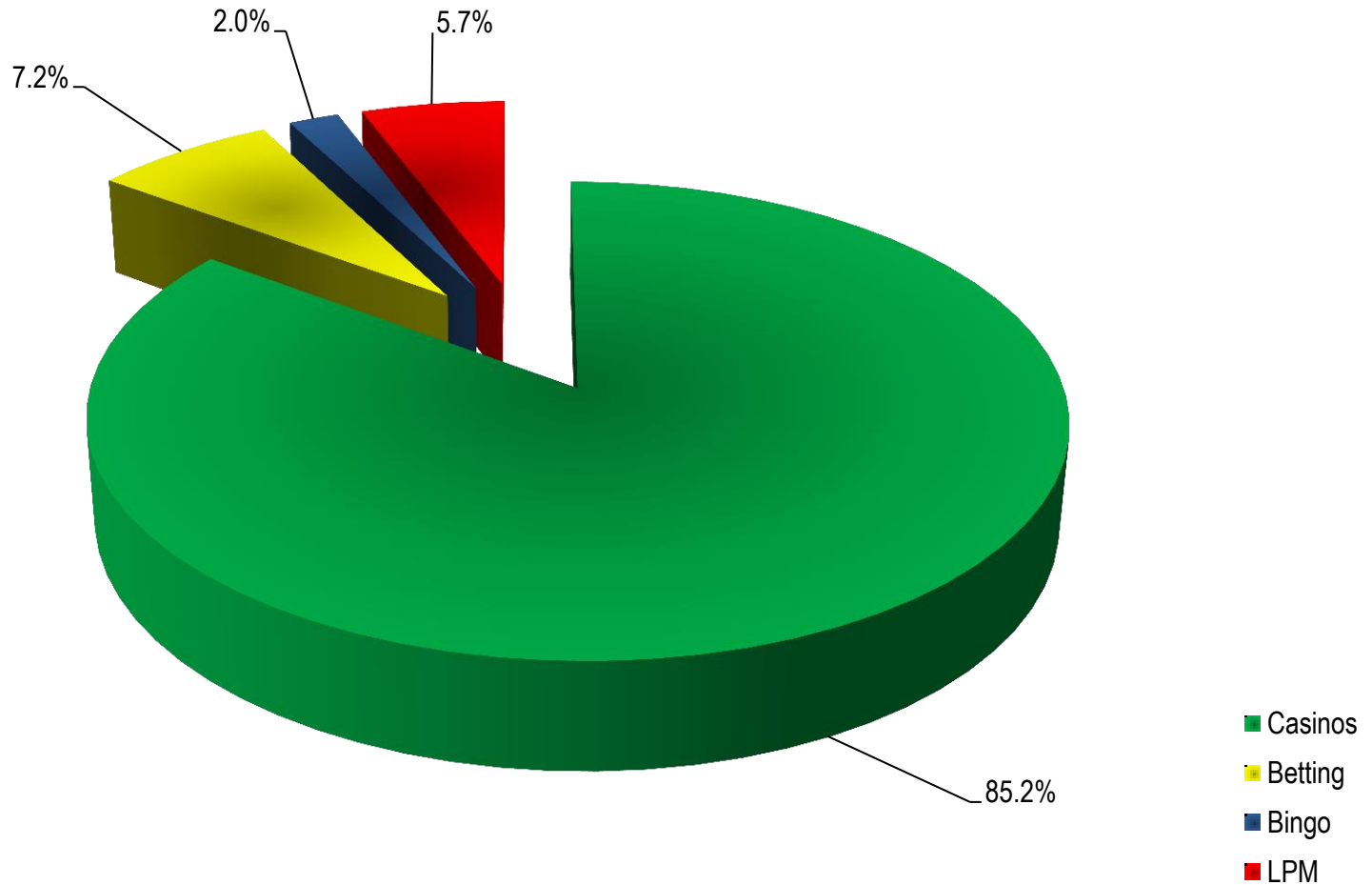

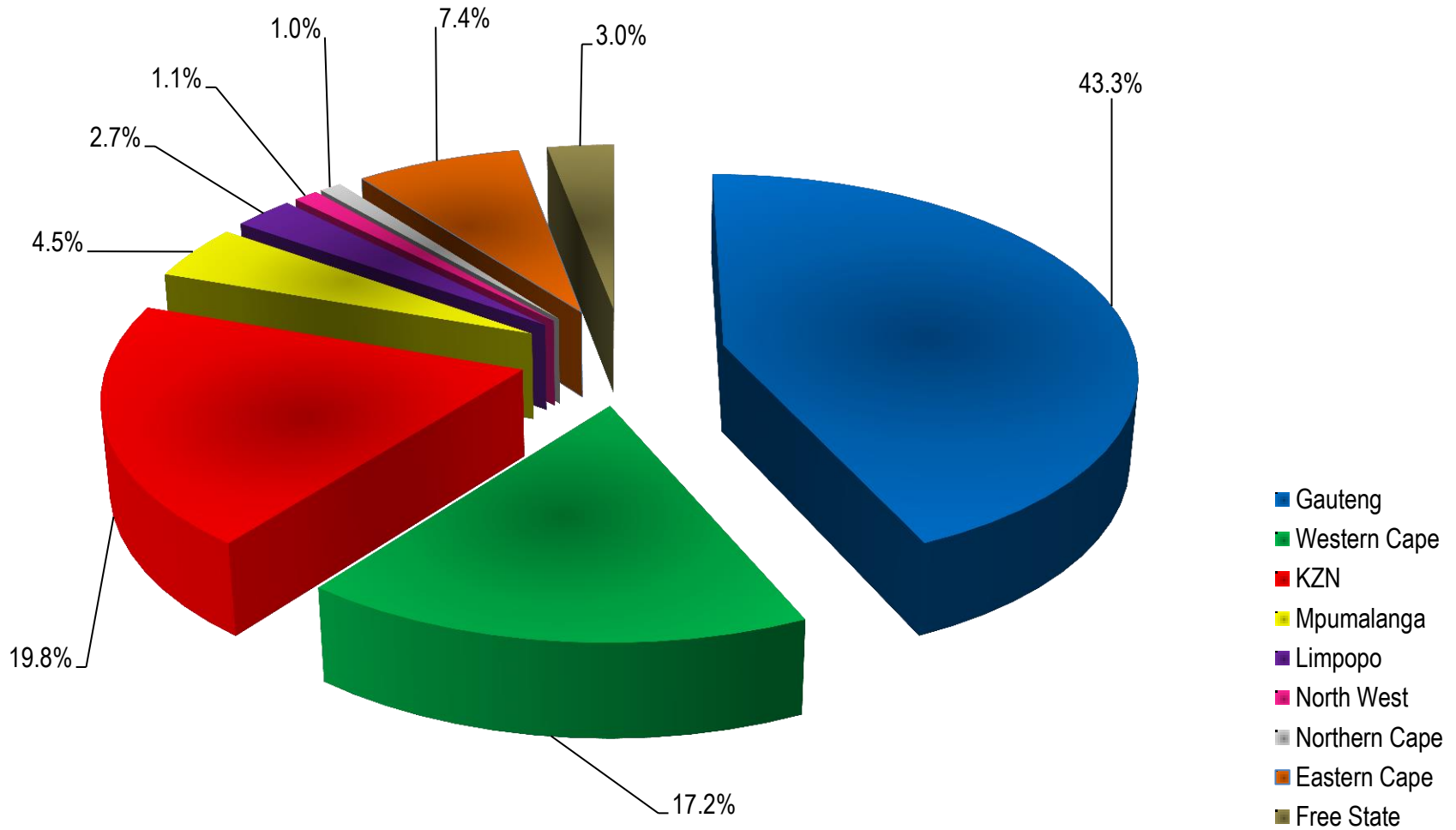
Turnover per gambling mode – FY2013

Turnover per province - FY2013

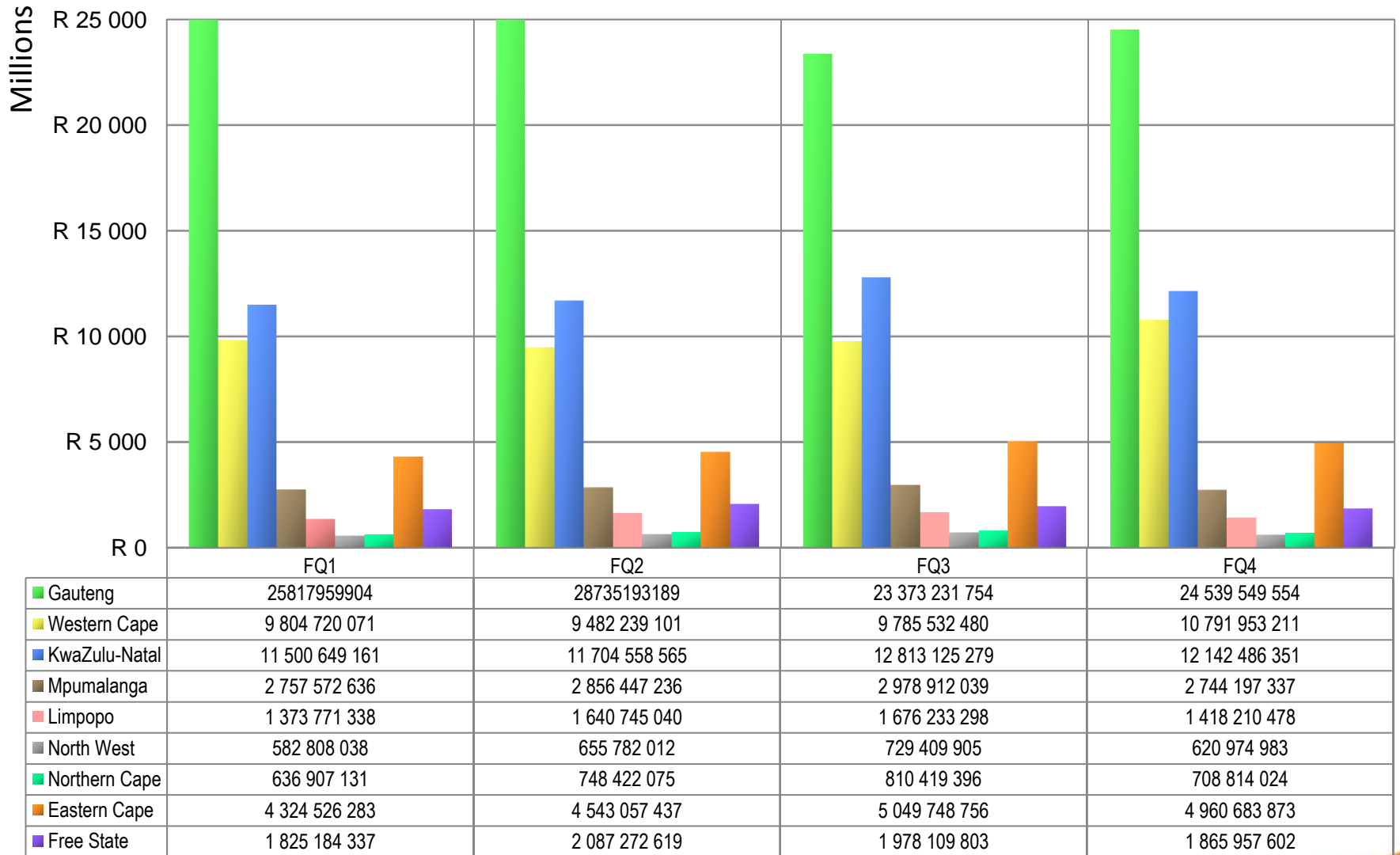

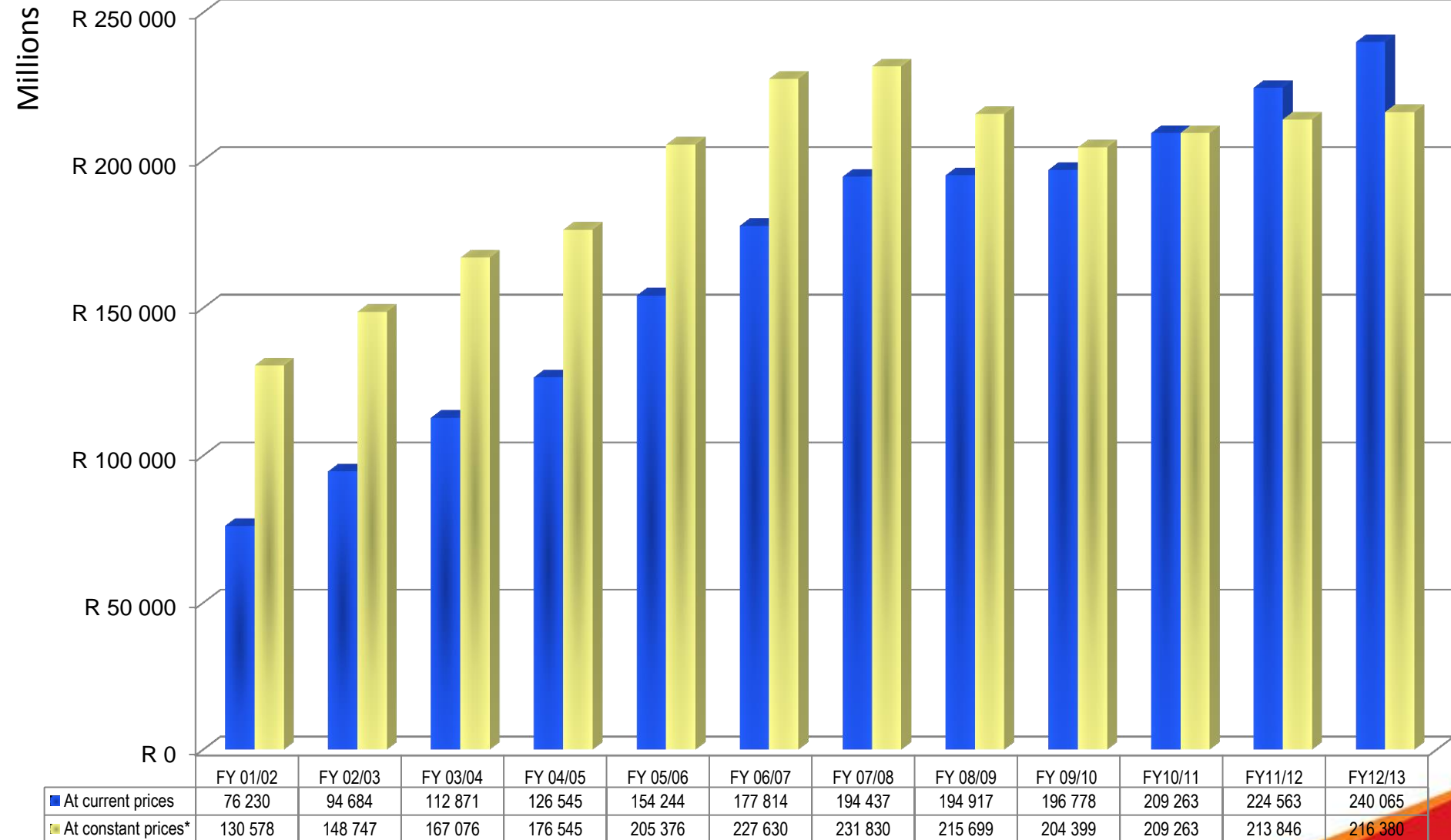
Quarterly casino turnover - FY2013

Trend in turnover casinos – FY01/02 to FY12/13

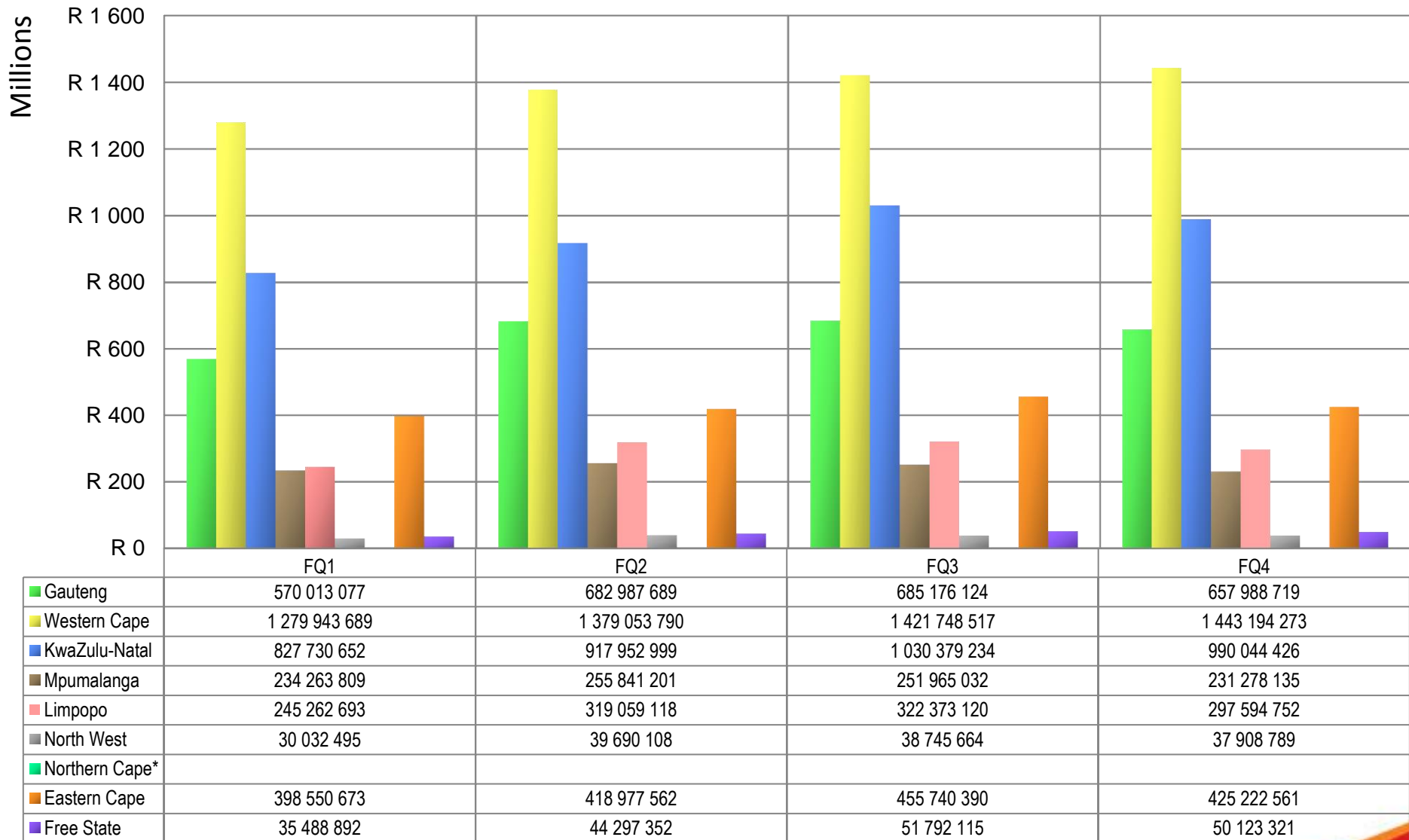

Quarterly LPM turnover - FY2013

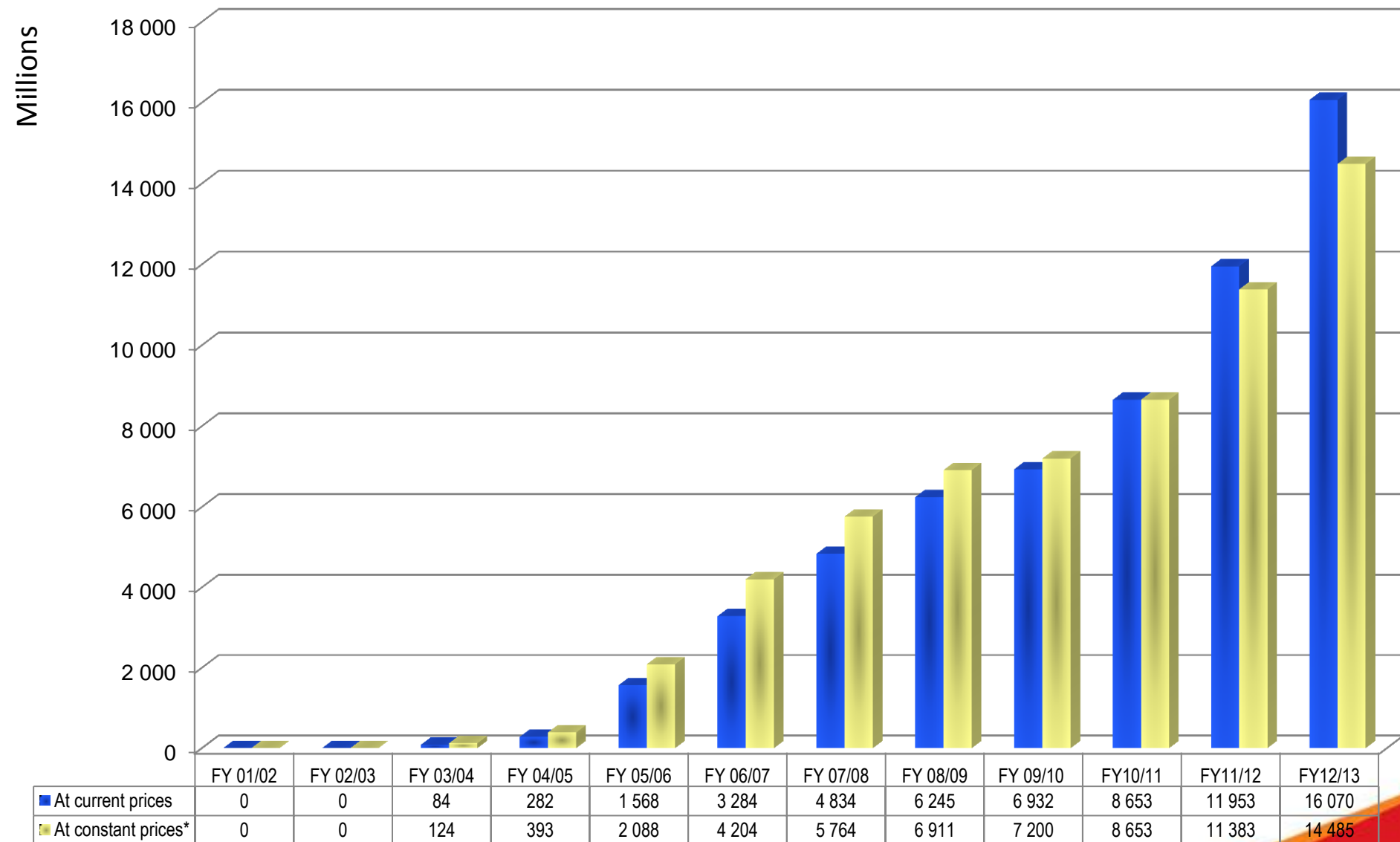

Trend in turnover LPMs – FY01/02 to FY12/13

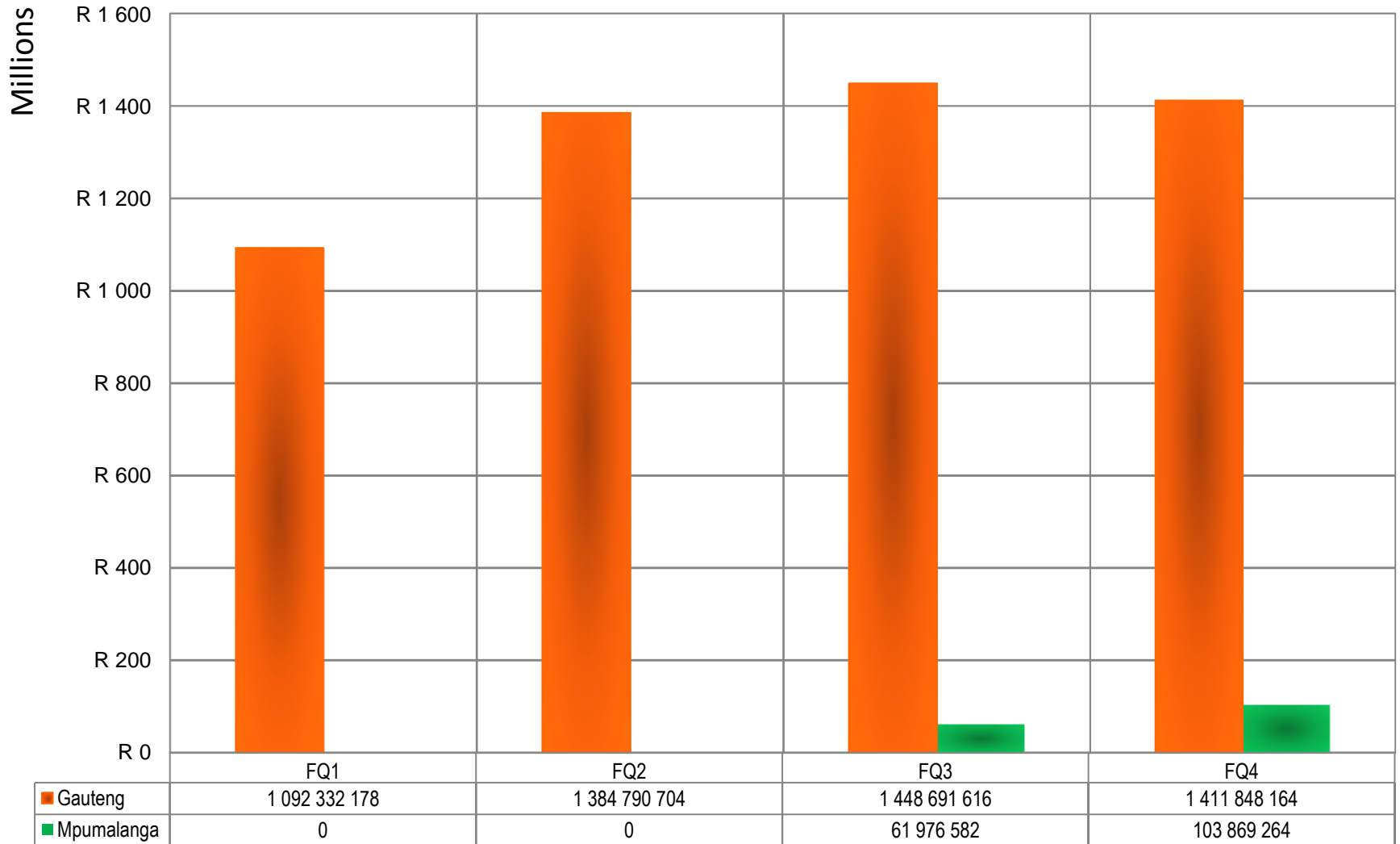

Quarterly bingo turnover - FY2013*

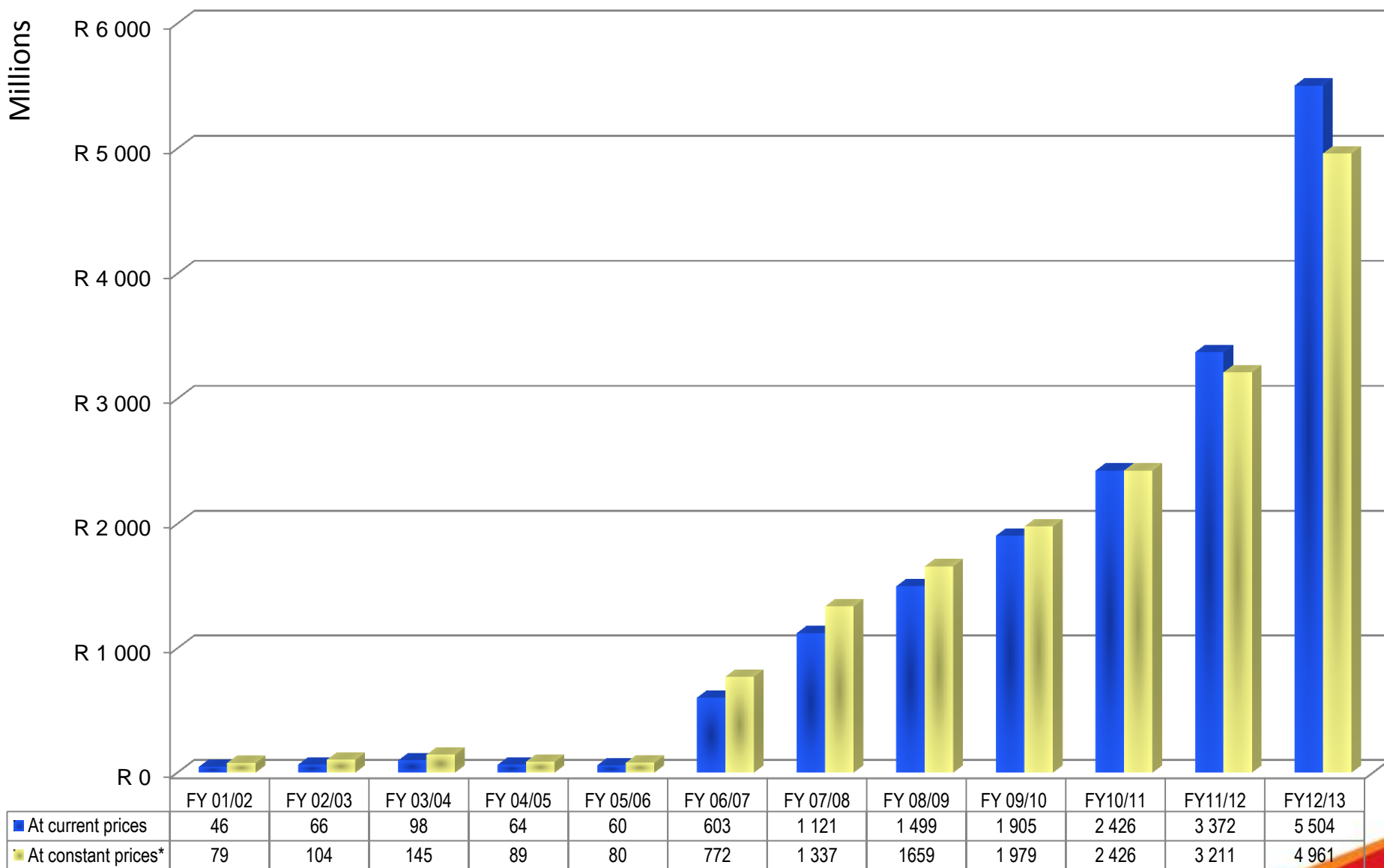

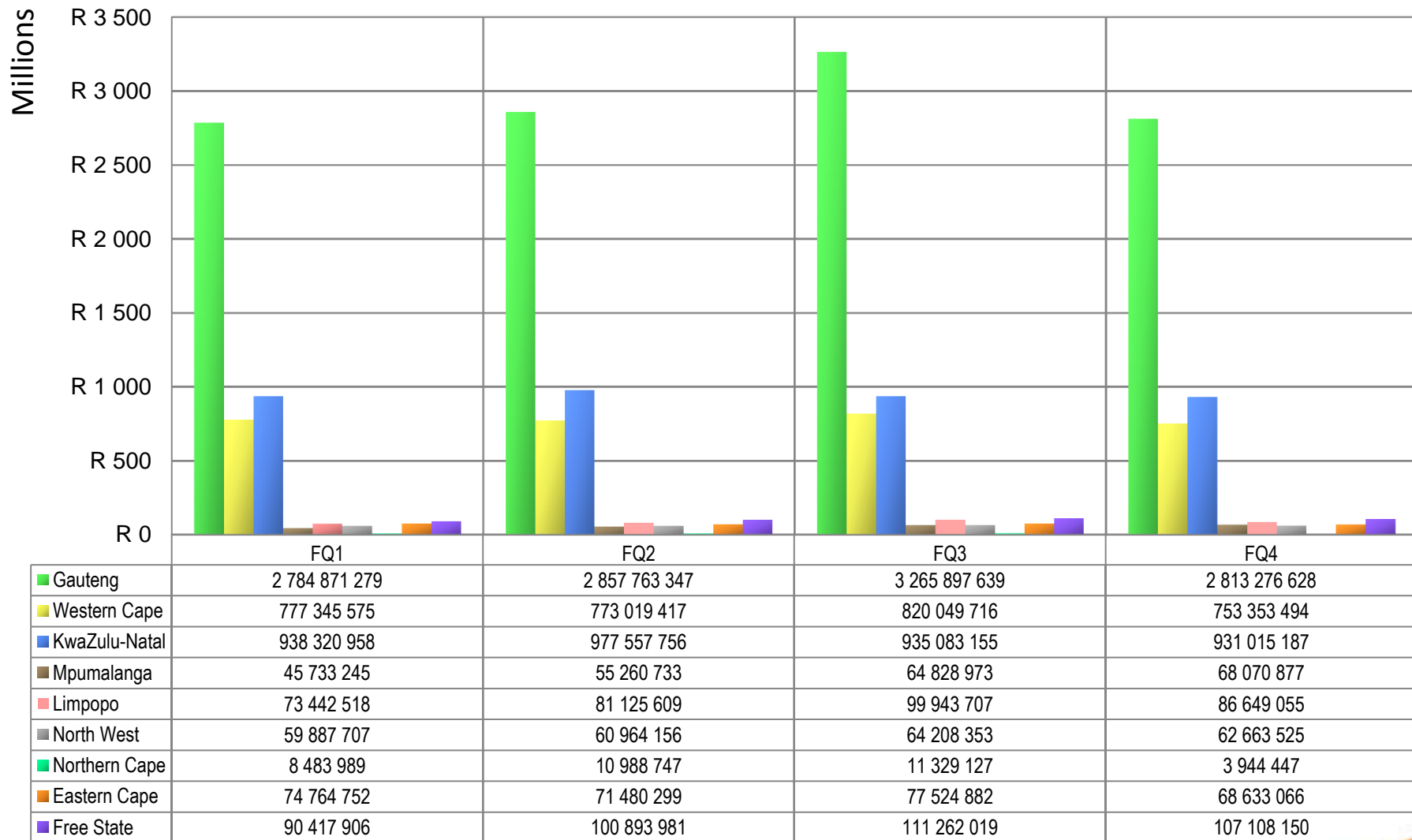

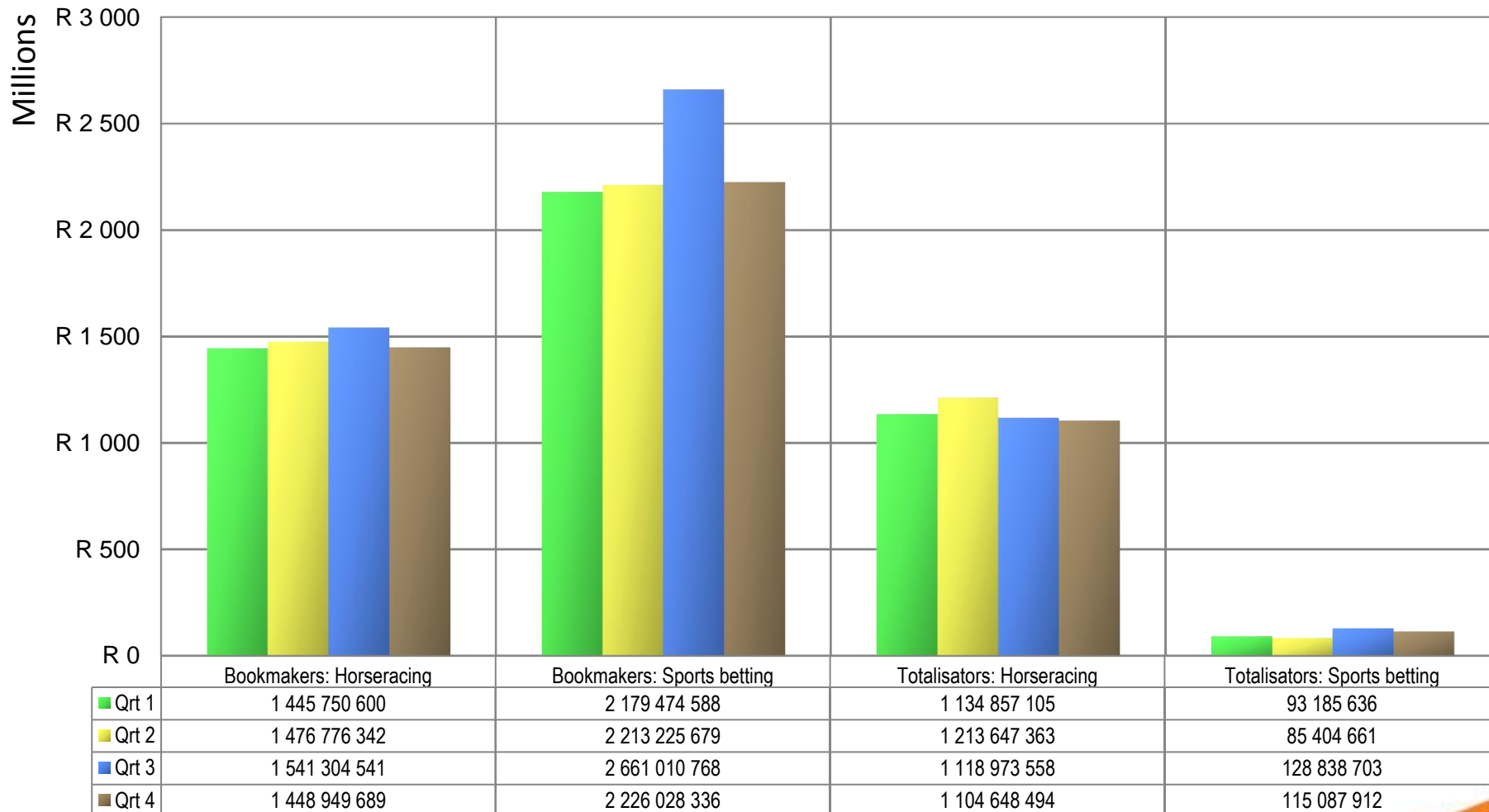

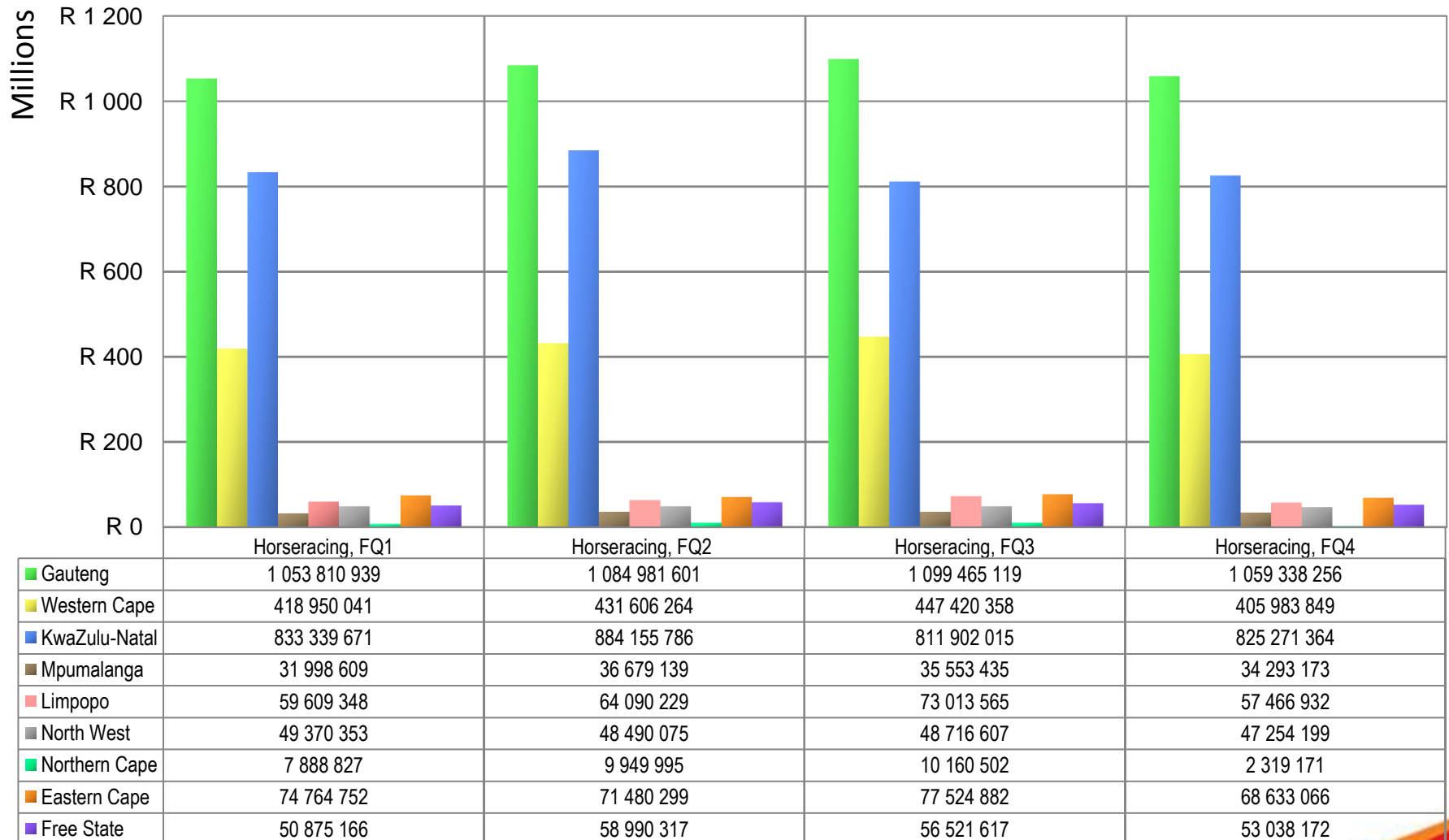

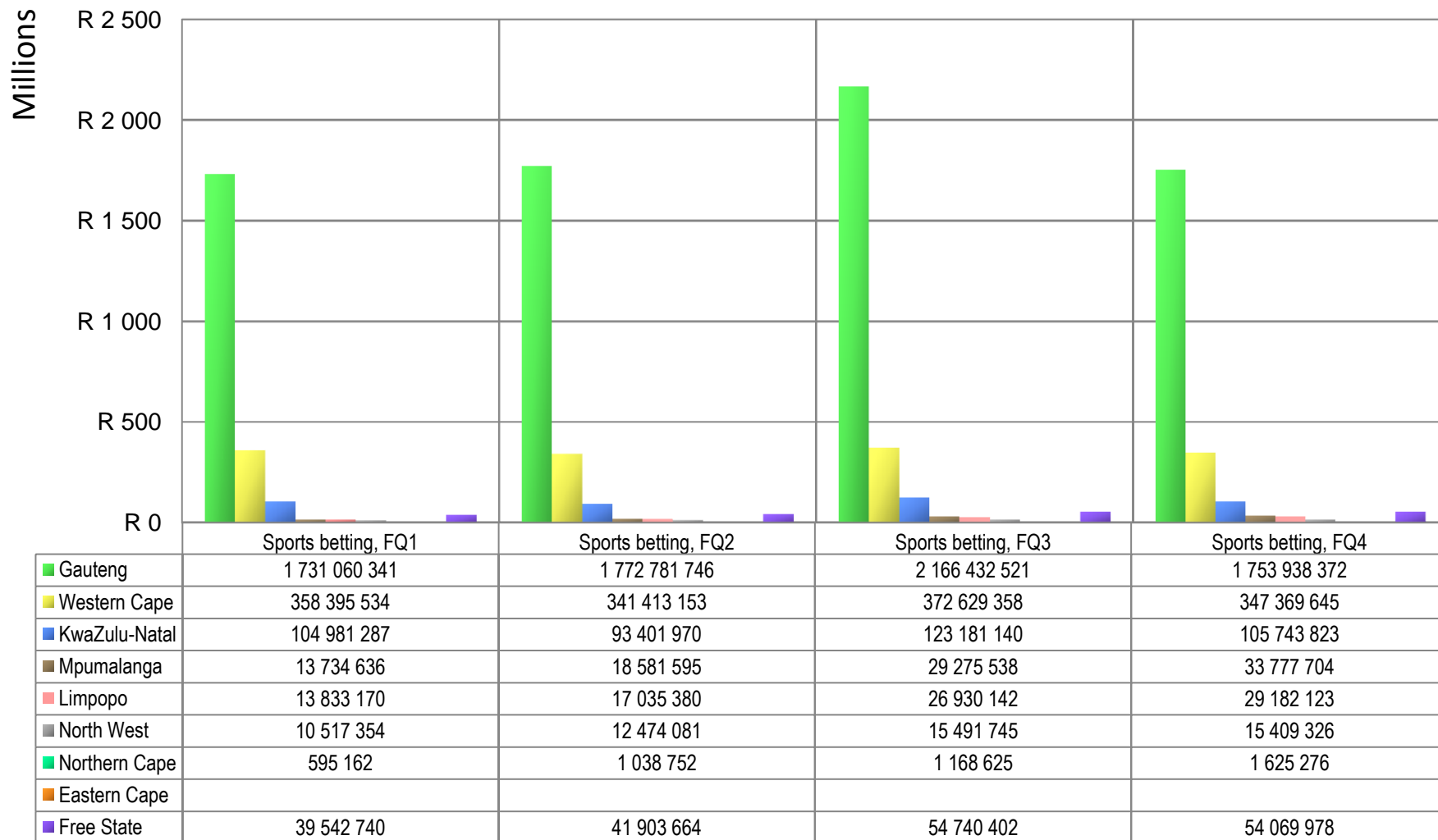

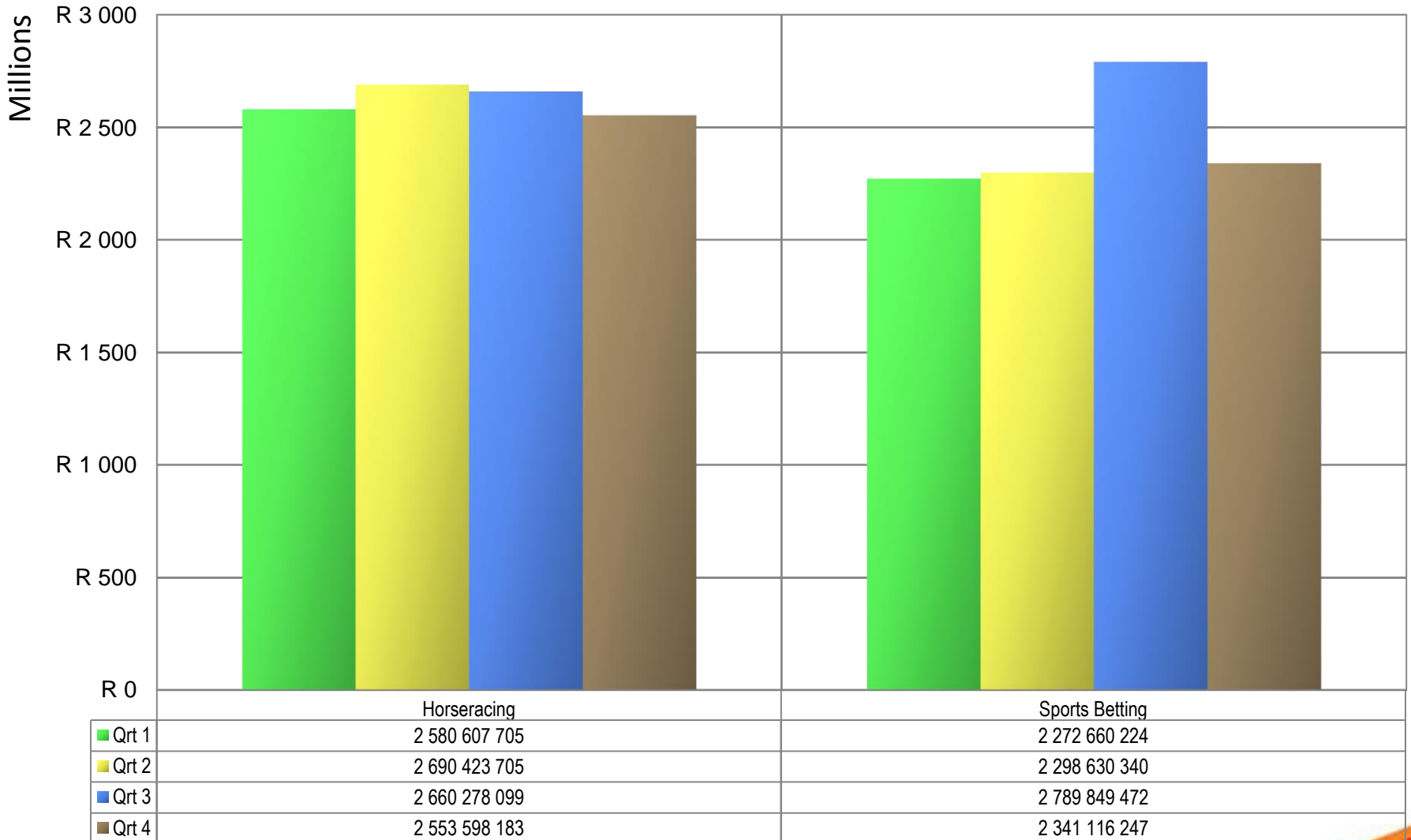

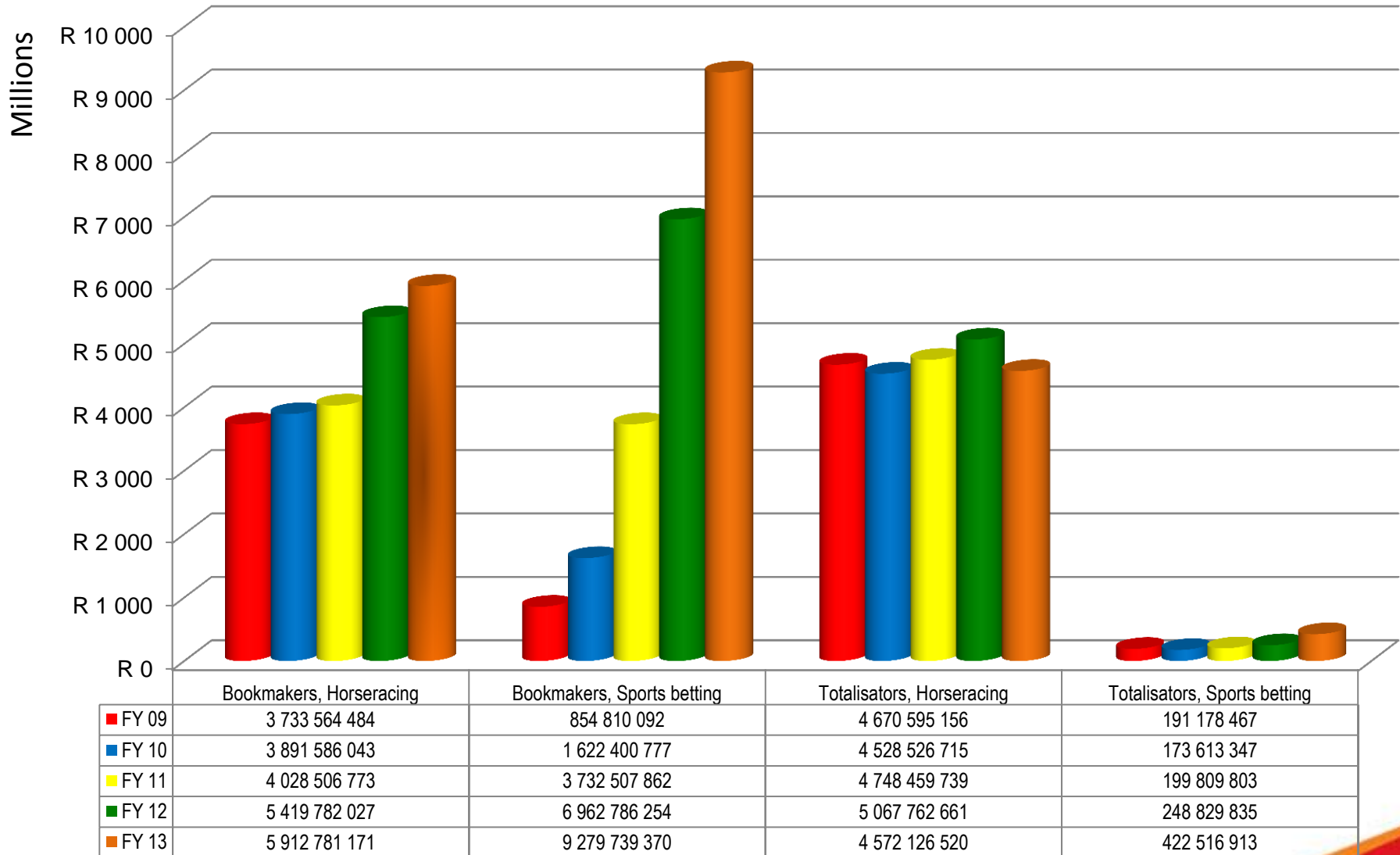

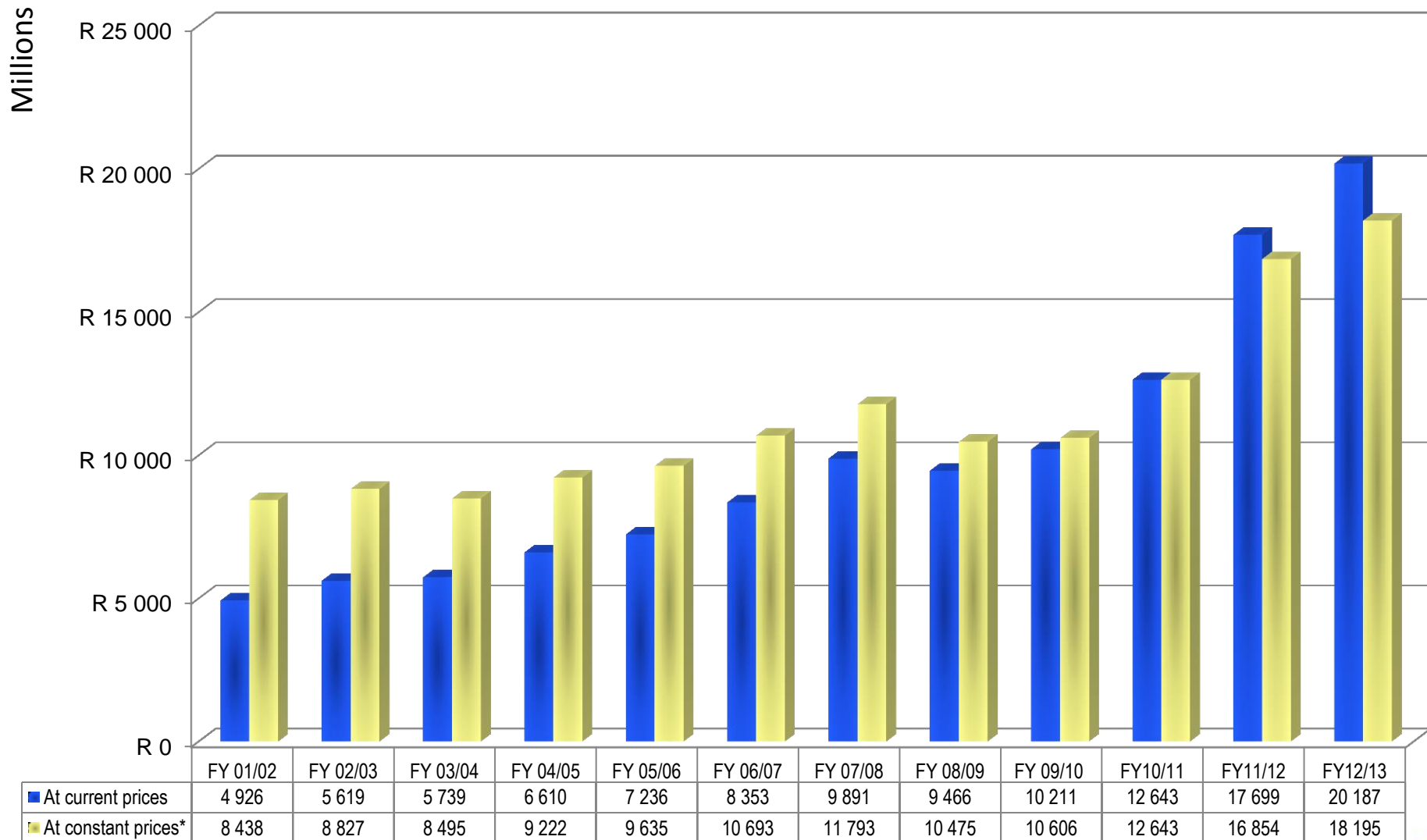
Trend in turnover, bookmakers & totalisators, FY09 to FY13

Trend in turnover, betting – FY01/02 to FY12/13

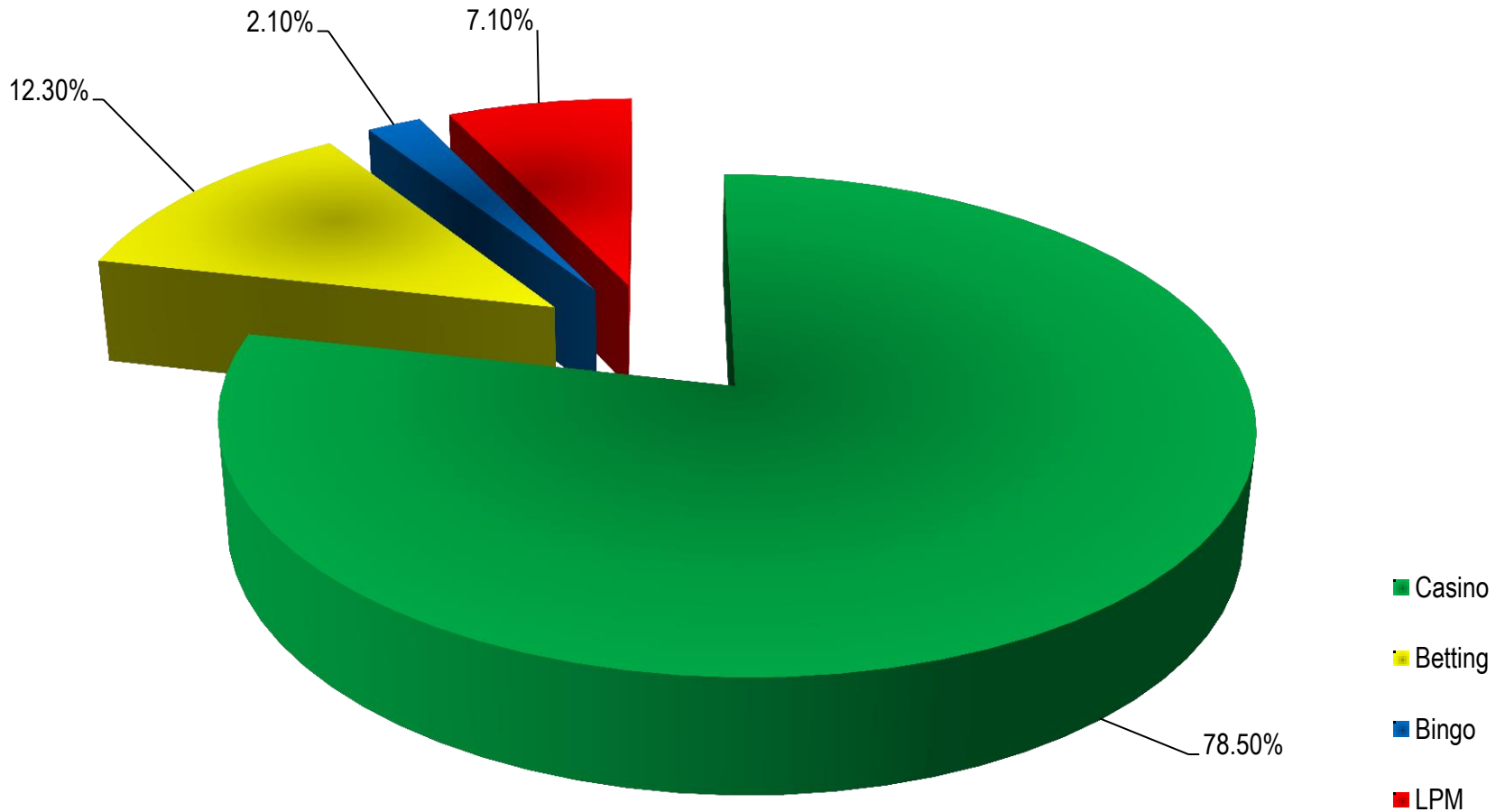

GGR per gambling mode – FY2013

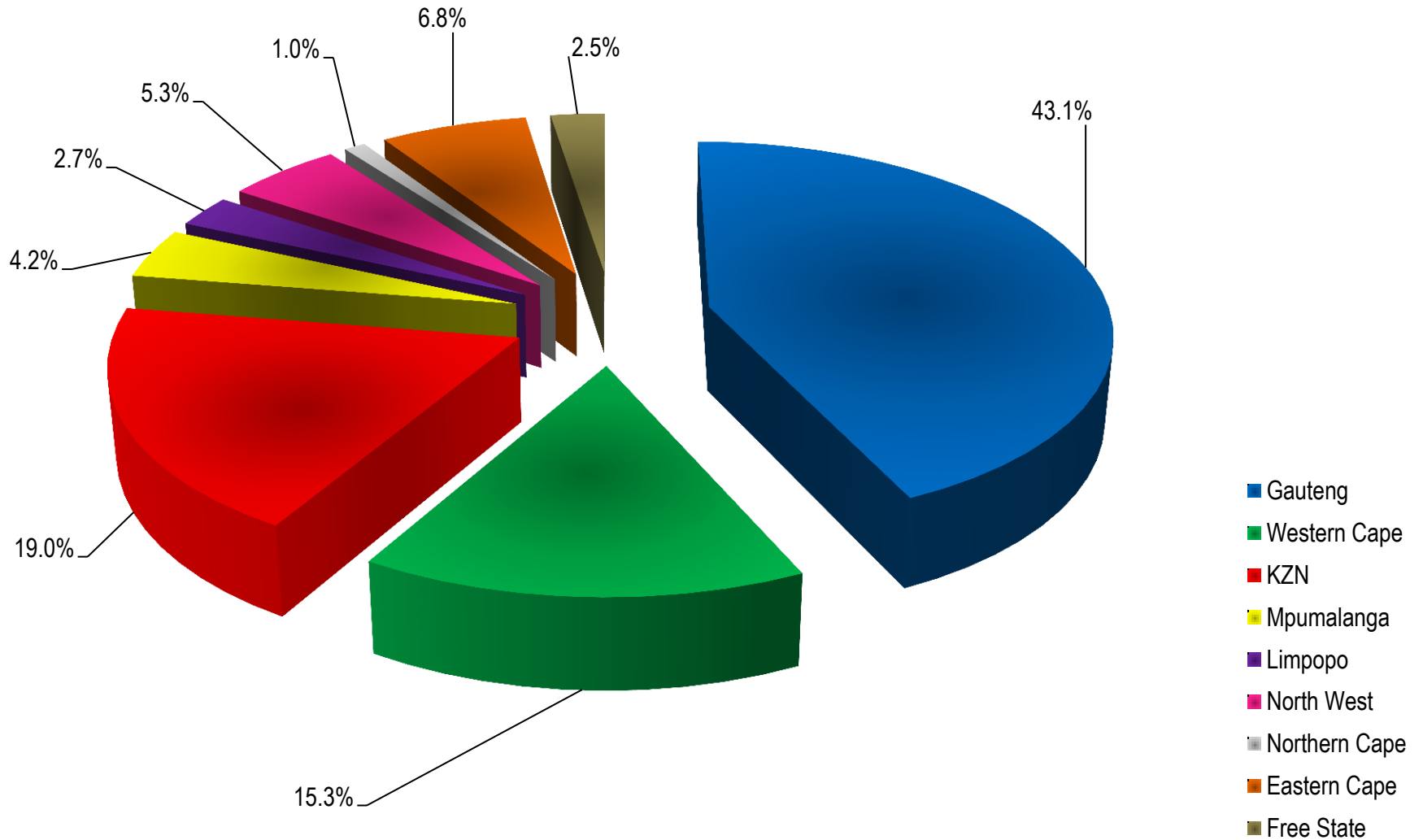

GGR per province - FY2013

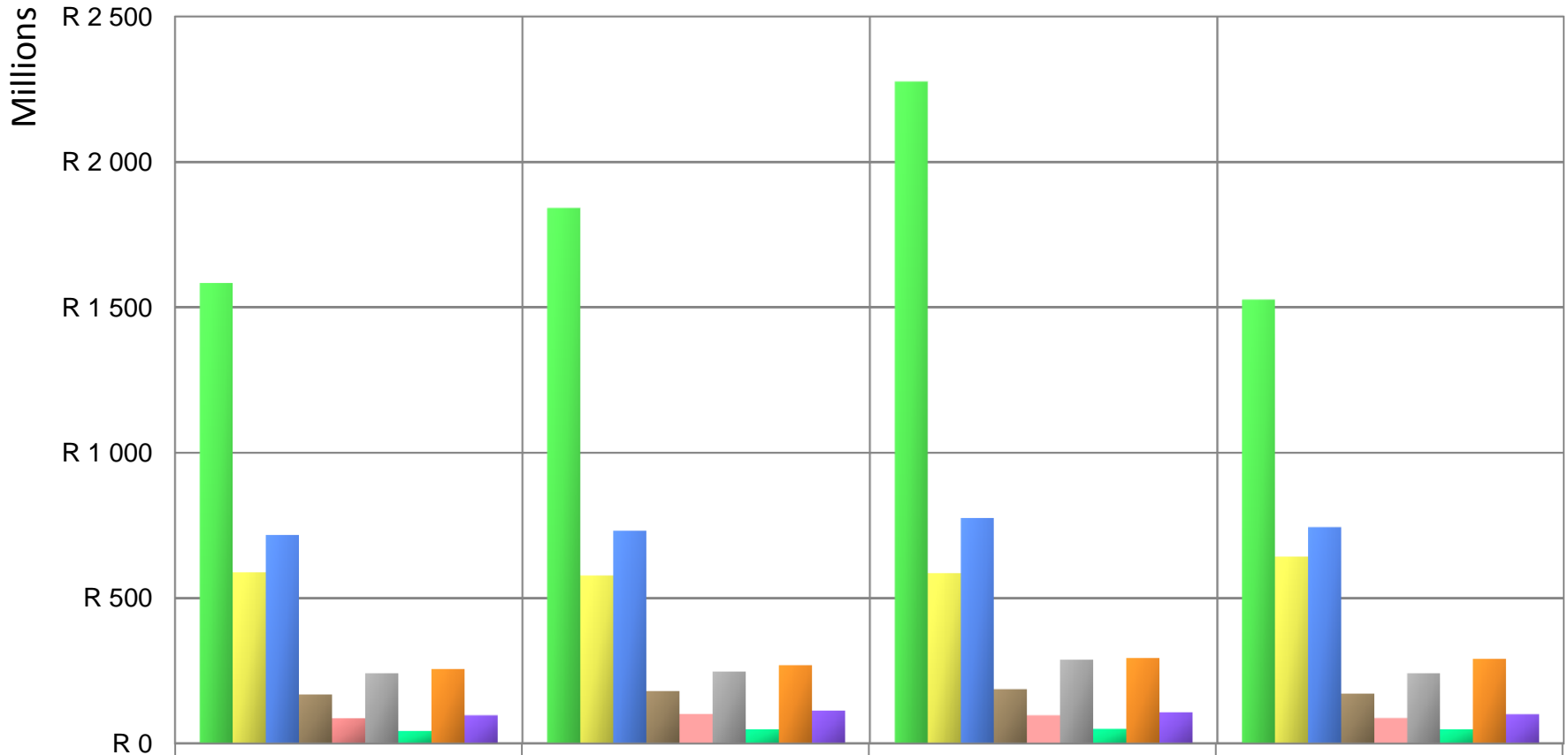

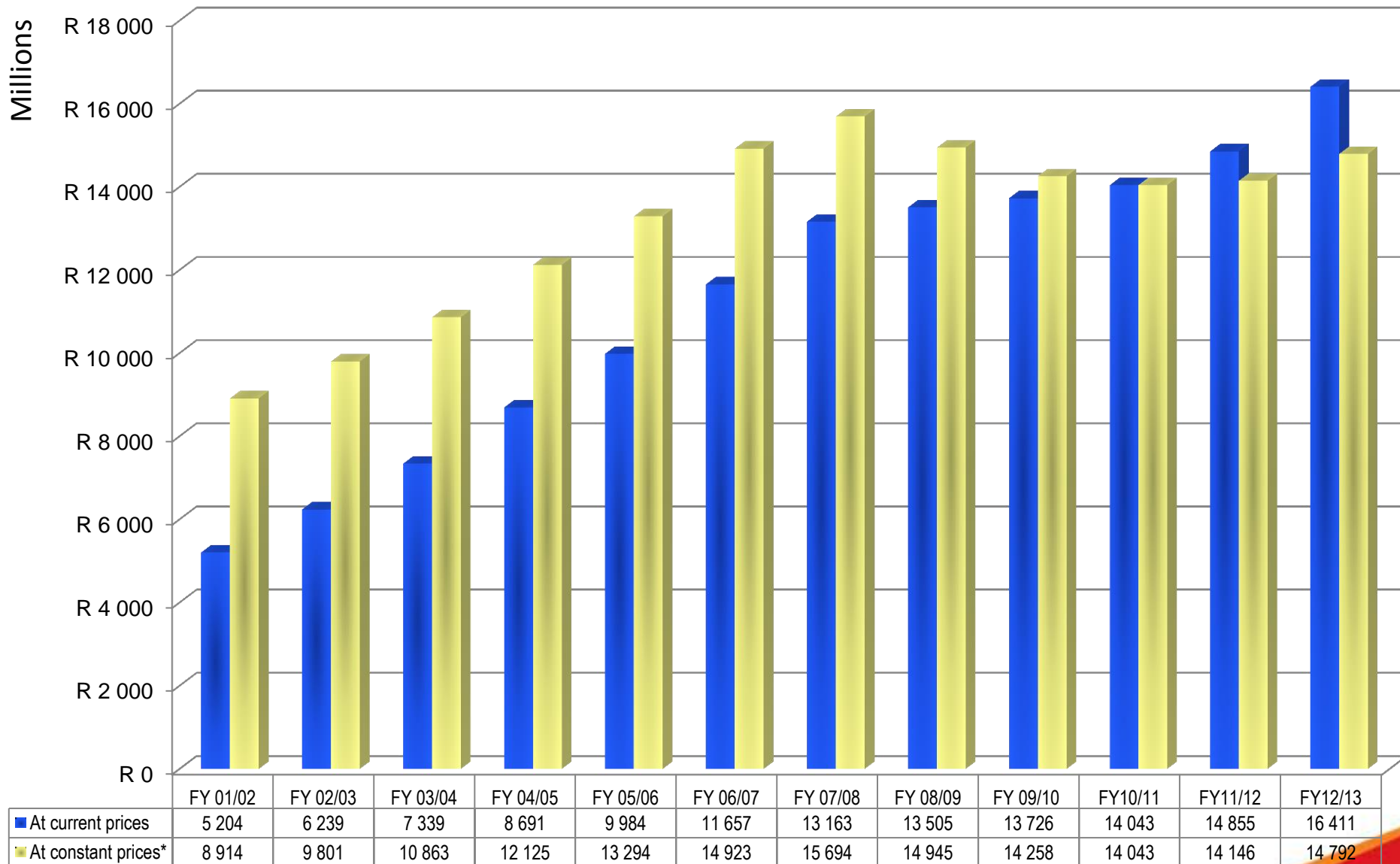

Trend in GGR casinos – FY01/02 to FY12/13

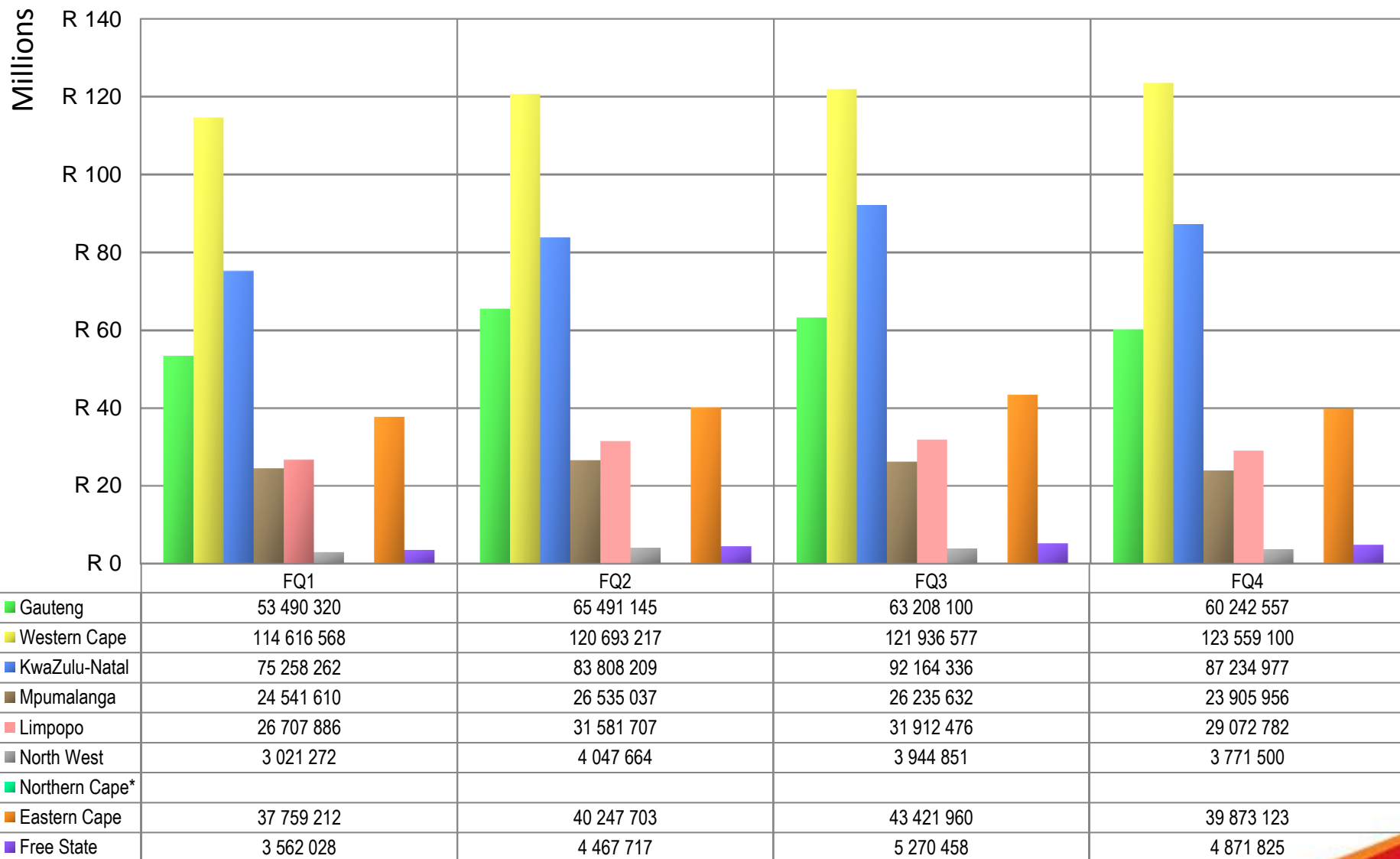

Quarterly LPM GGR - FY2013

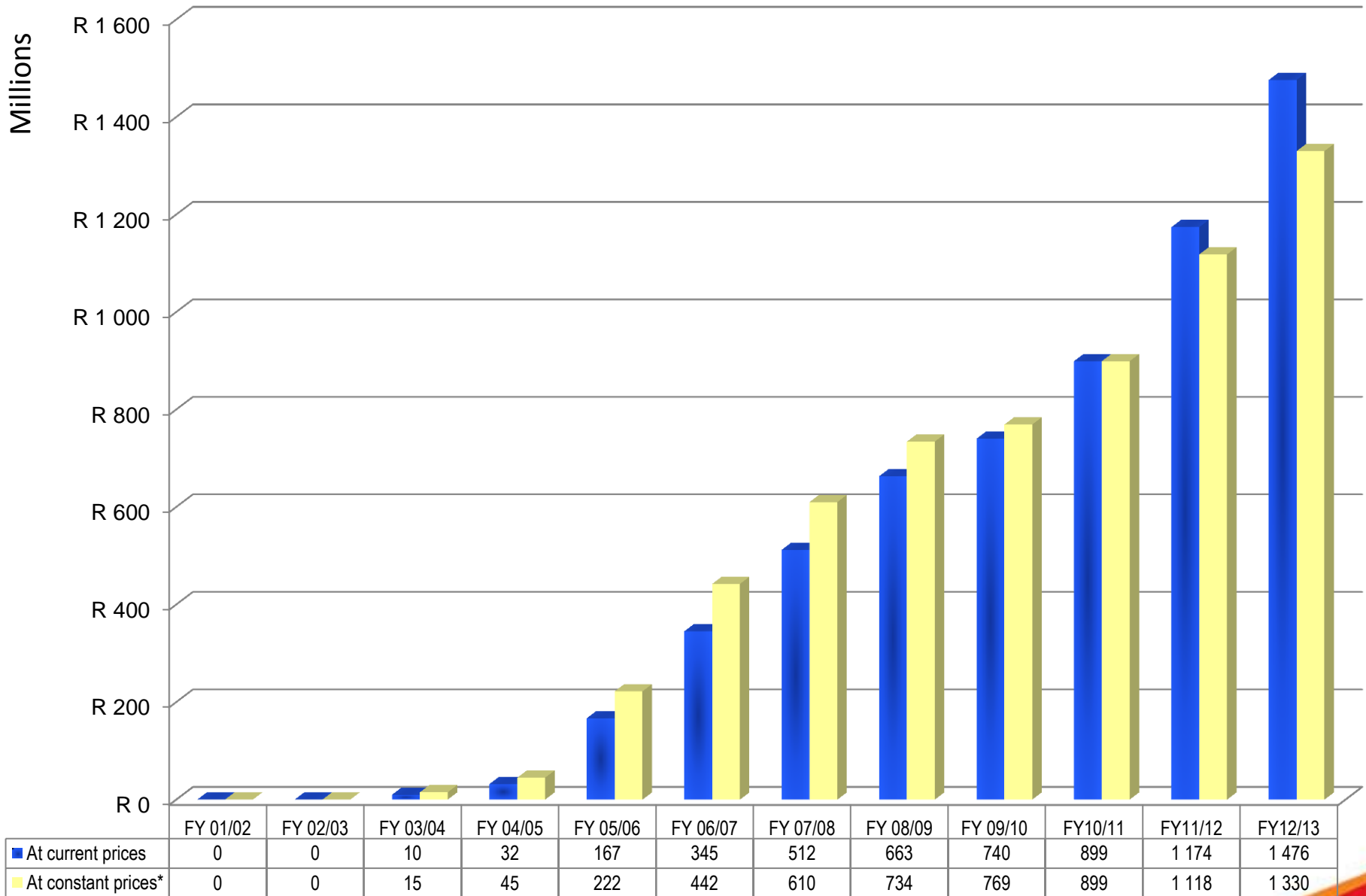

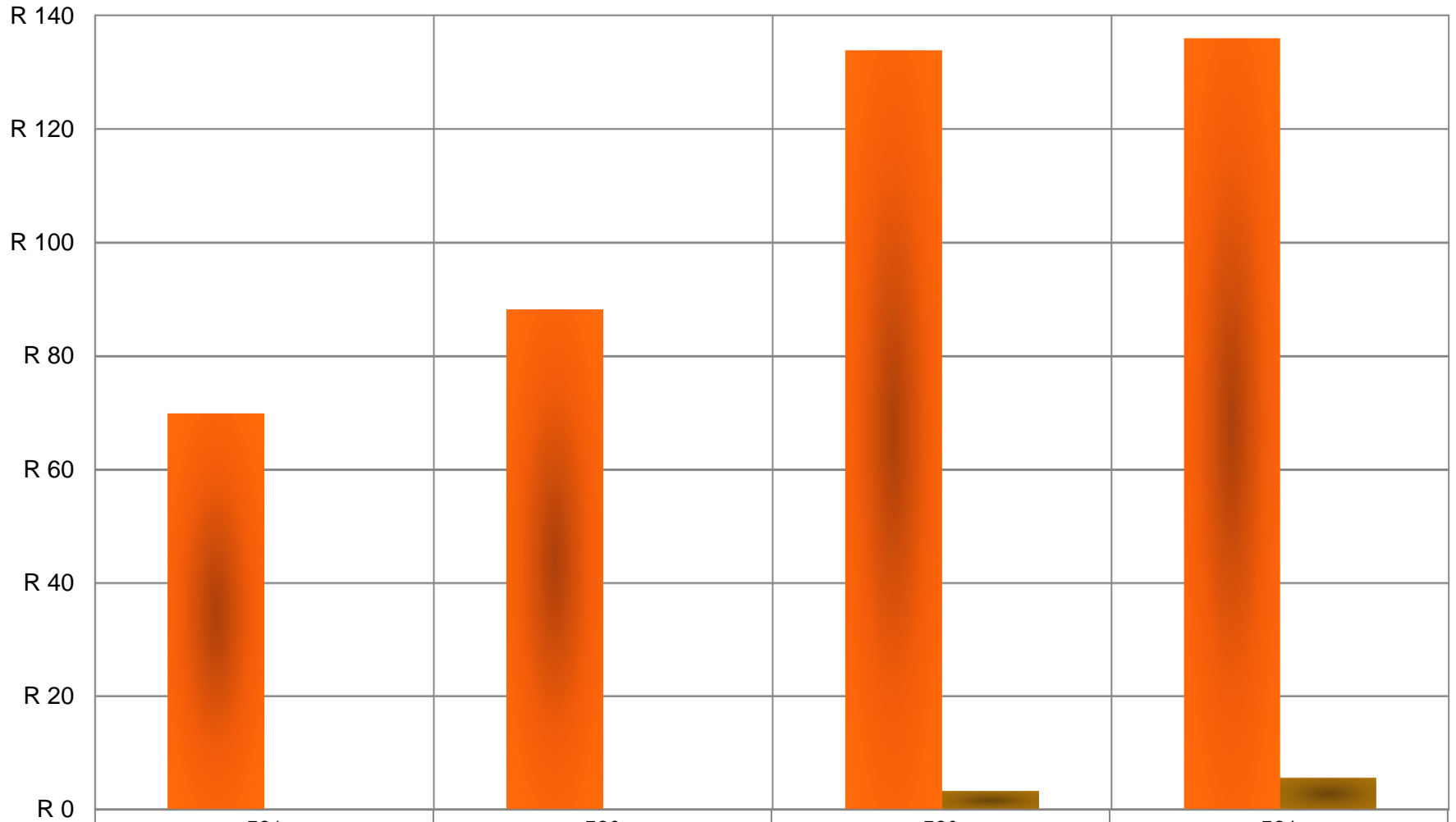

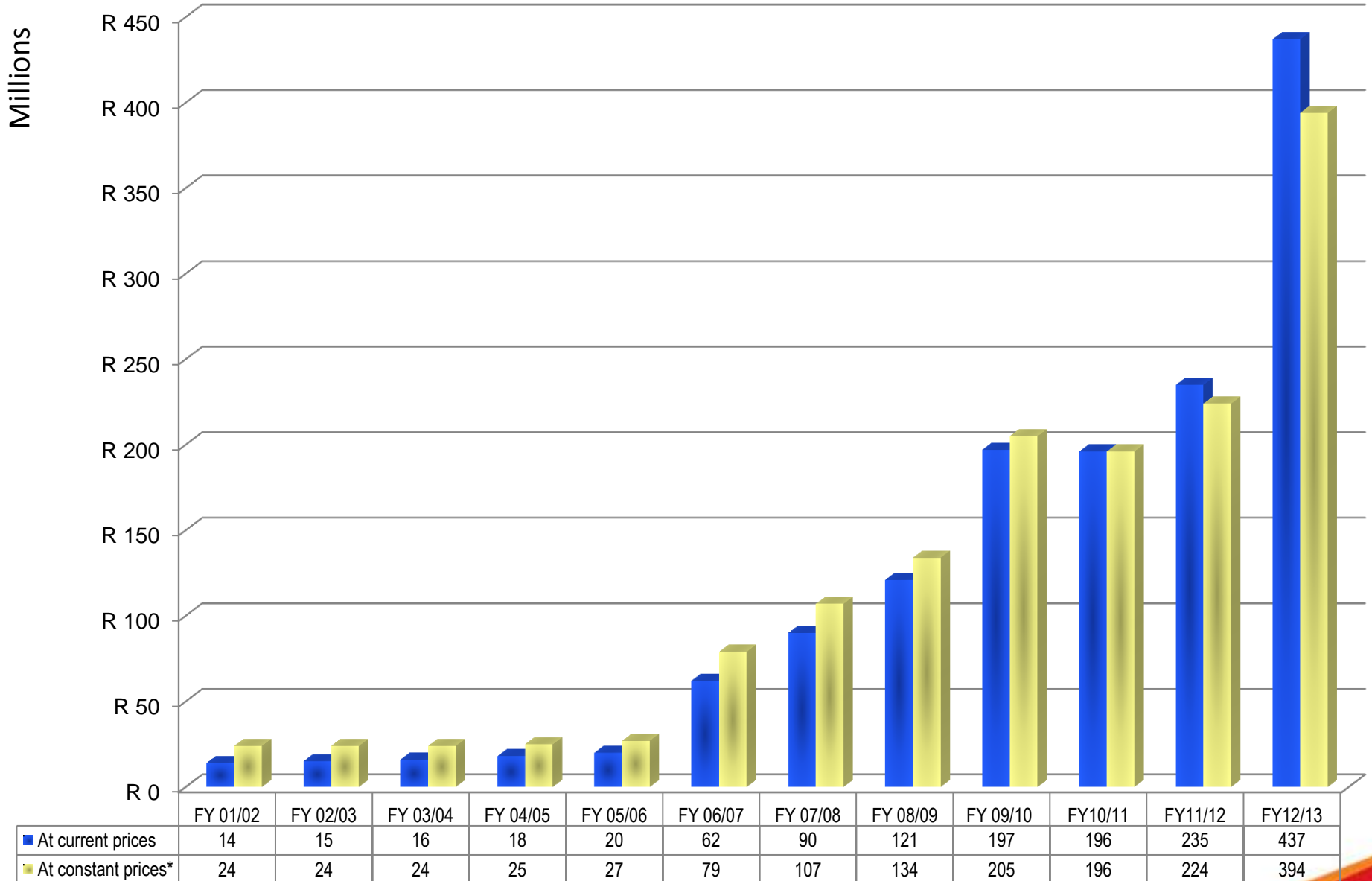

Rand value of the gross revenue of an operator



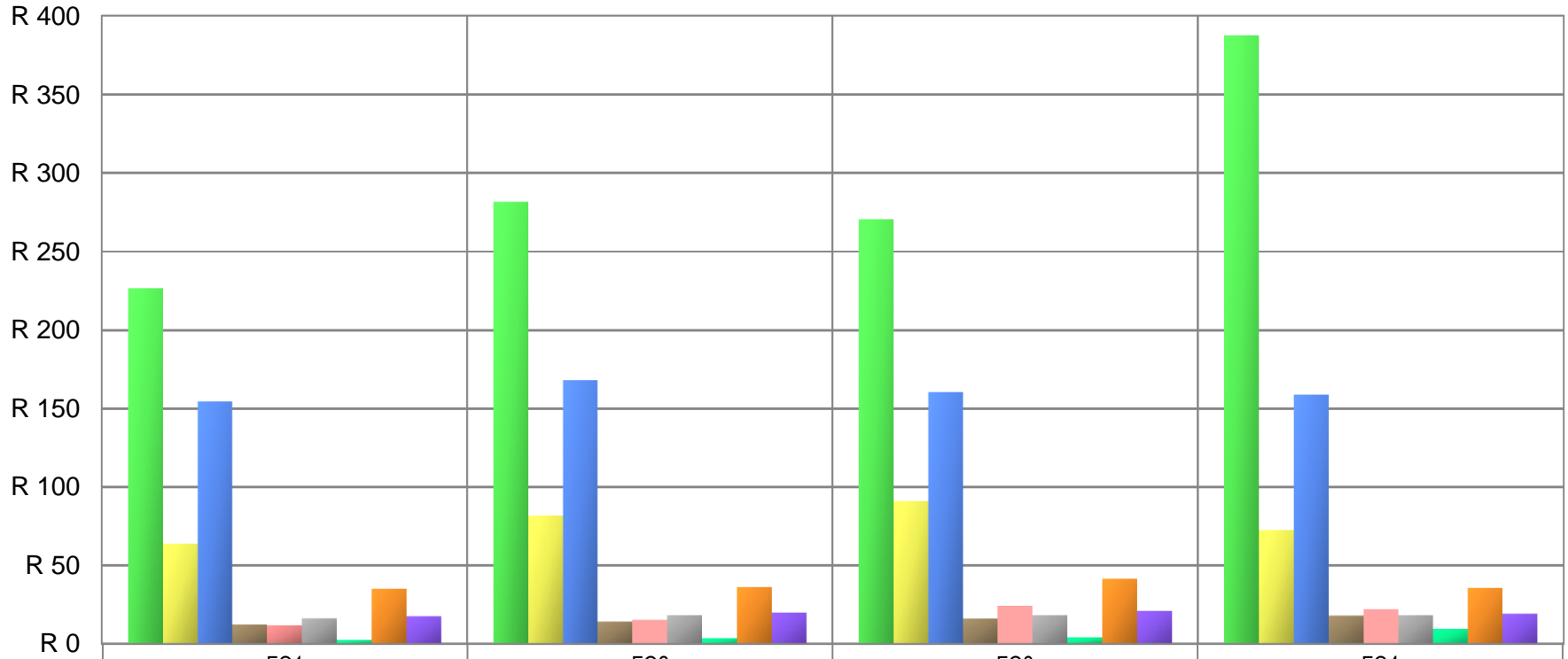

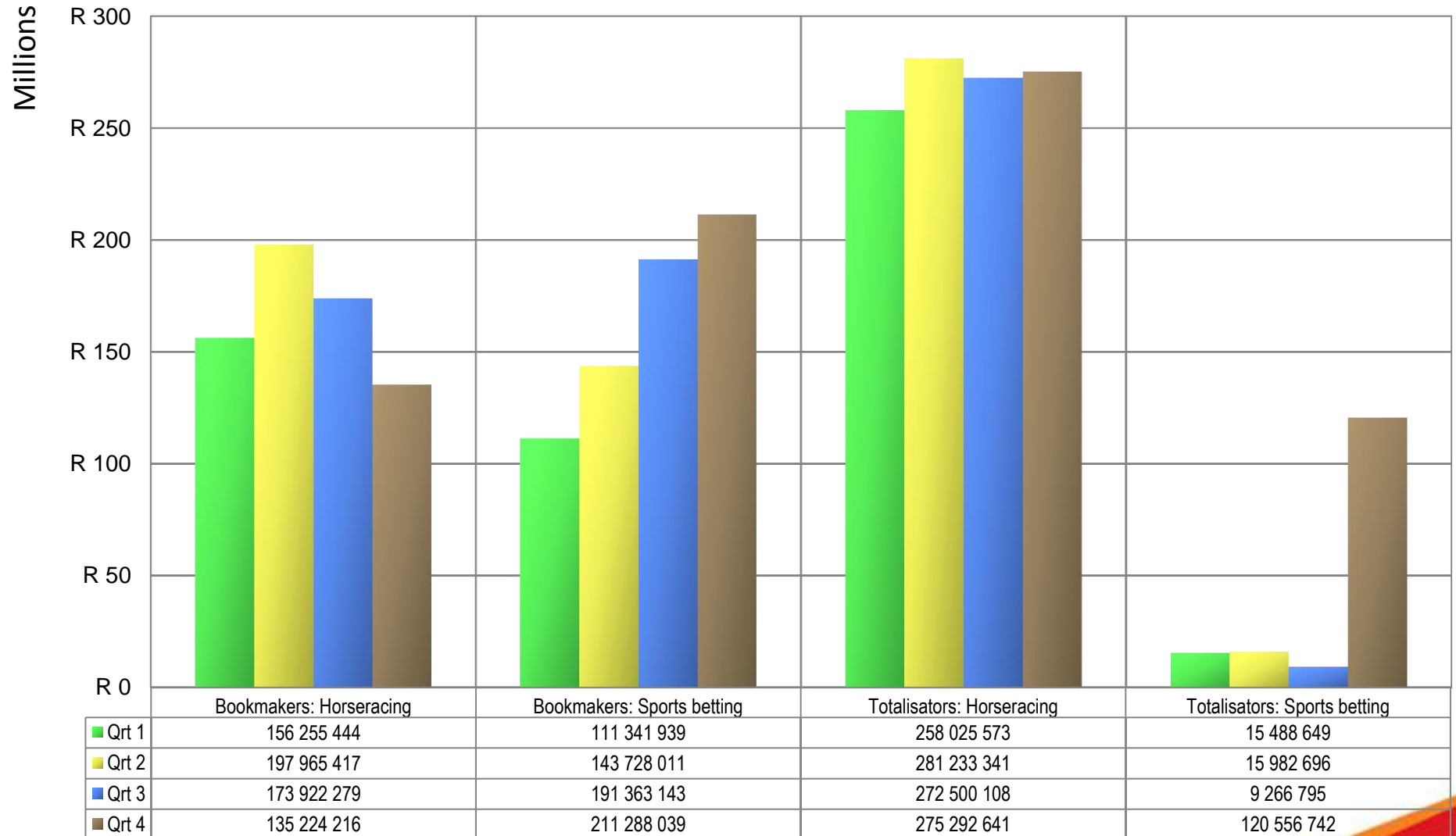

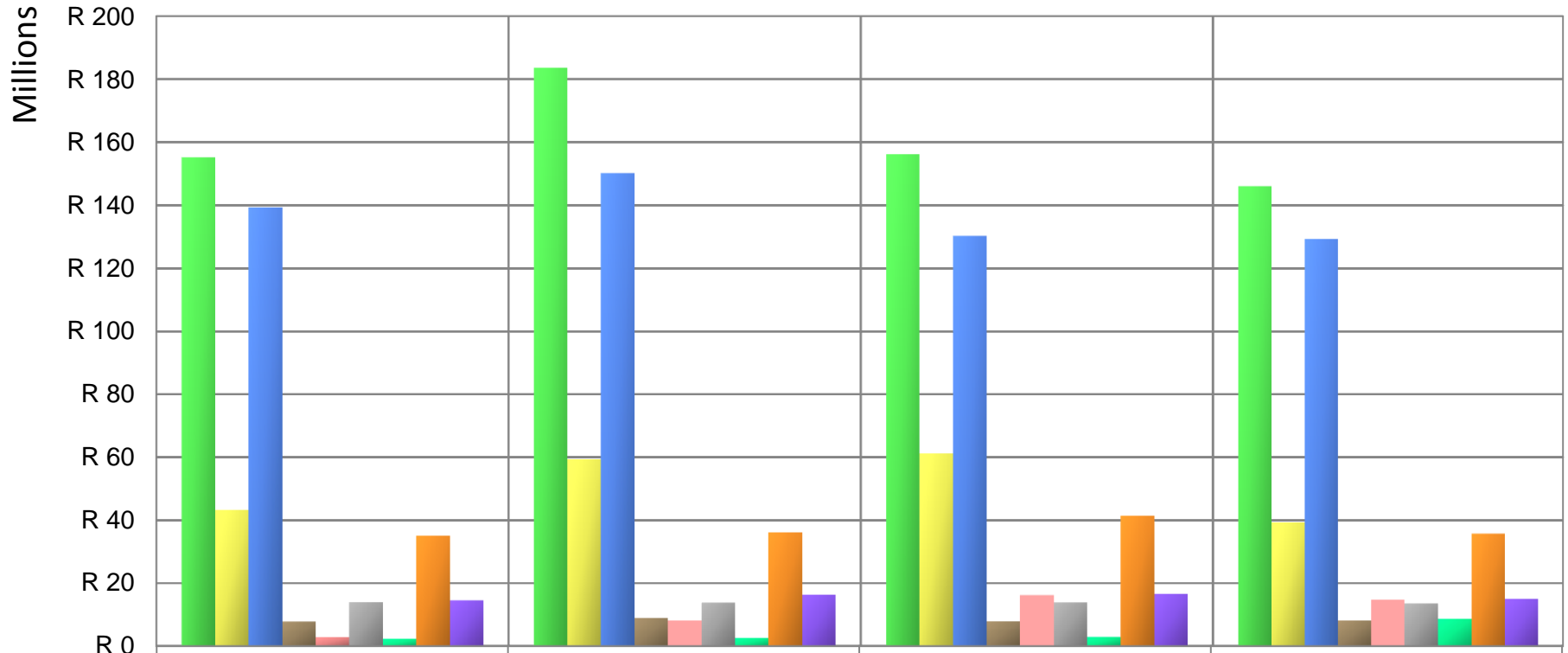
Rand value of the gross revenue of an operator

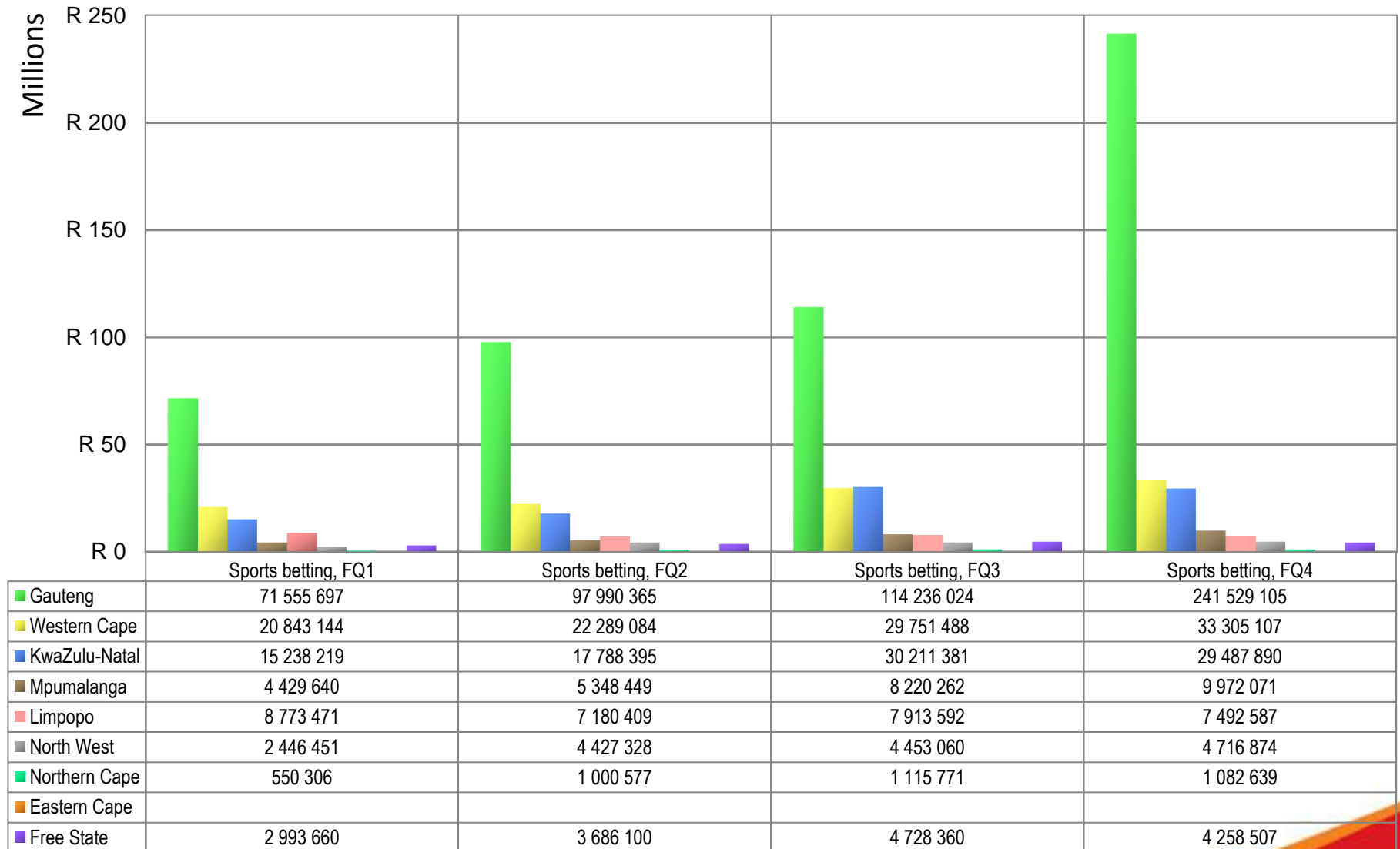

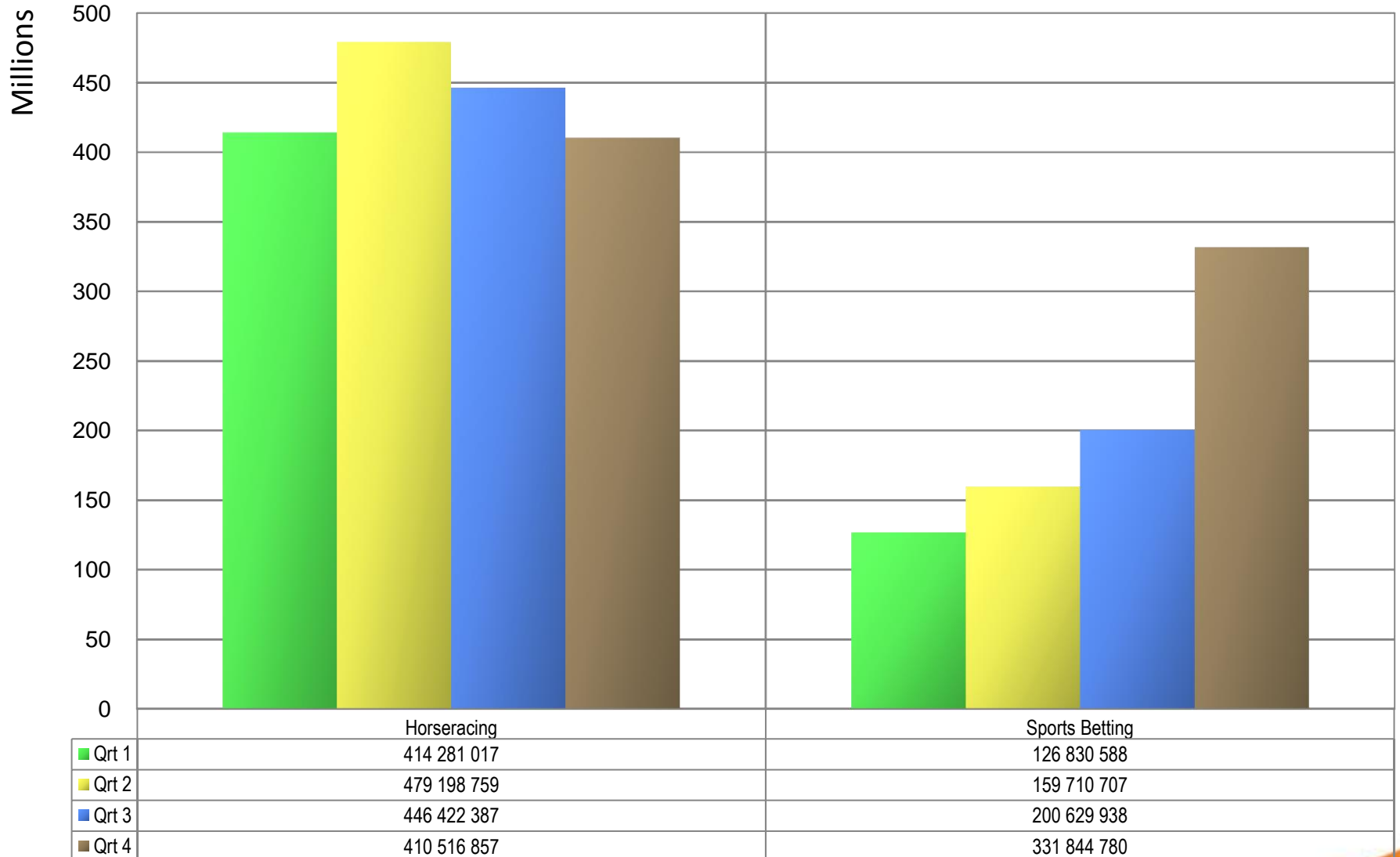
Rand value of the gross revenue by an operator

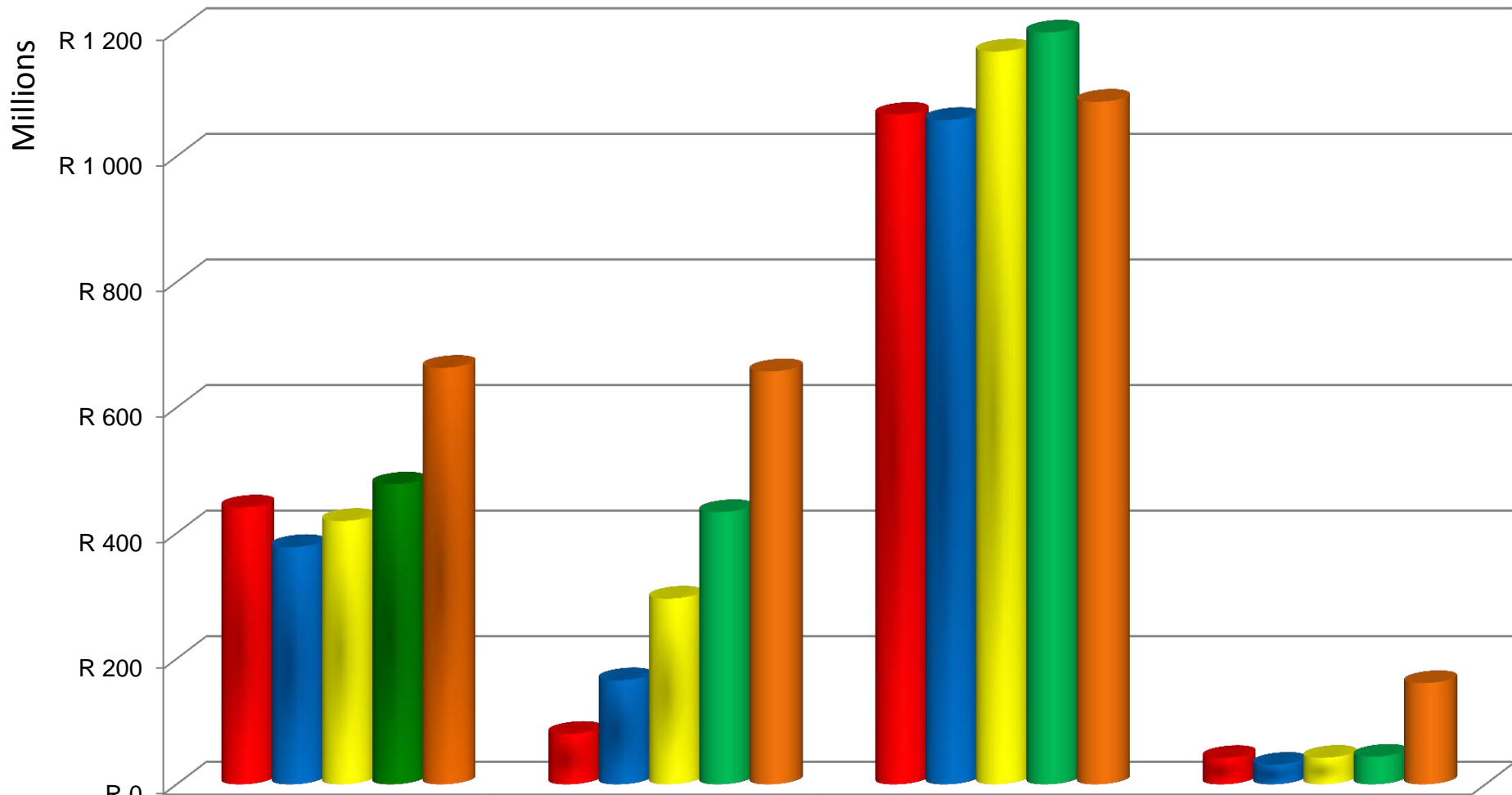

Trend in GGR, bookmakers & totalisators - FY09 to FY13

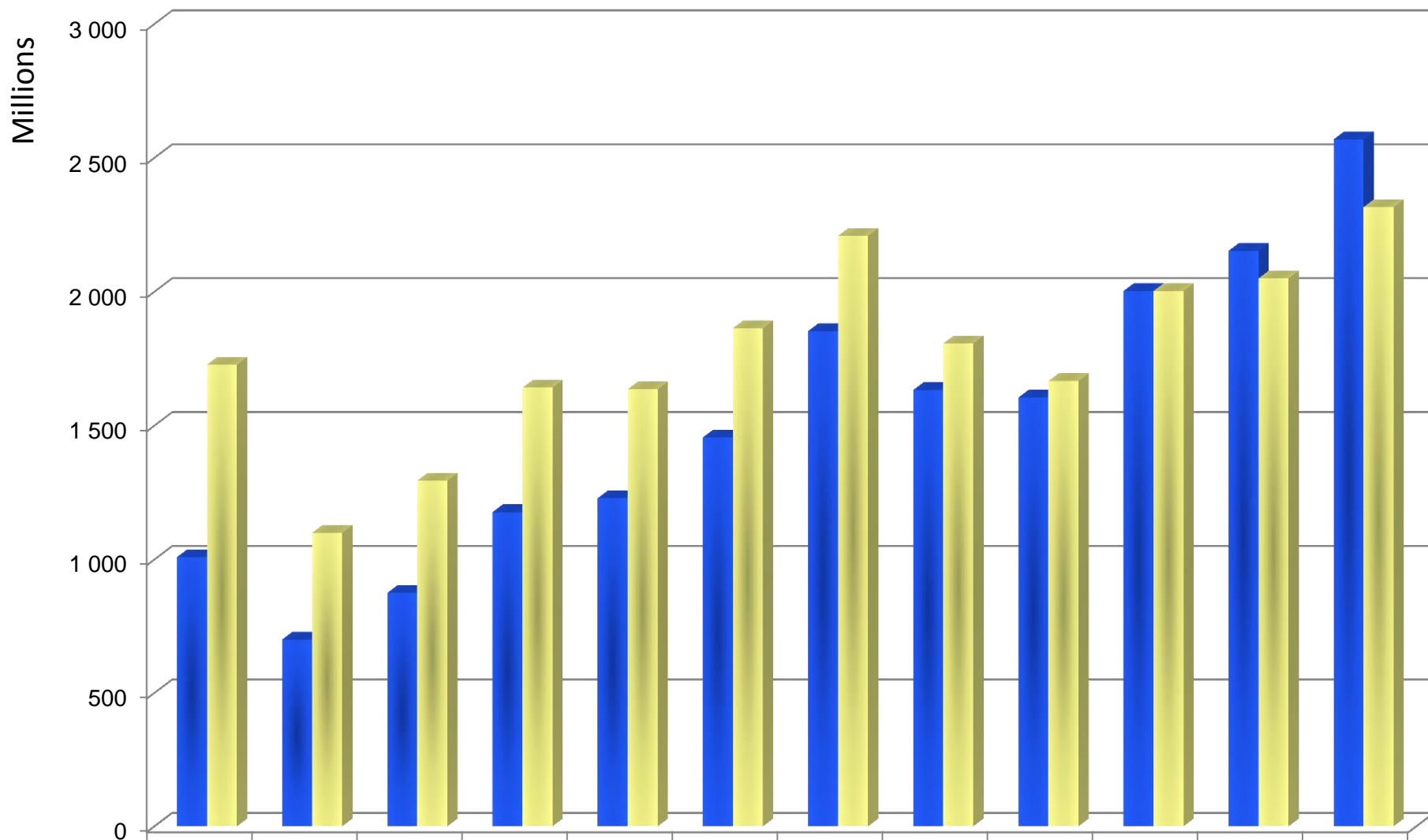

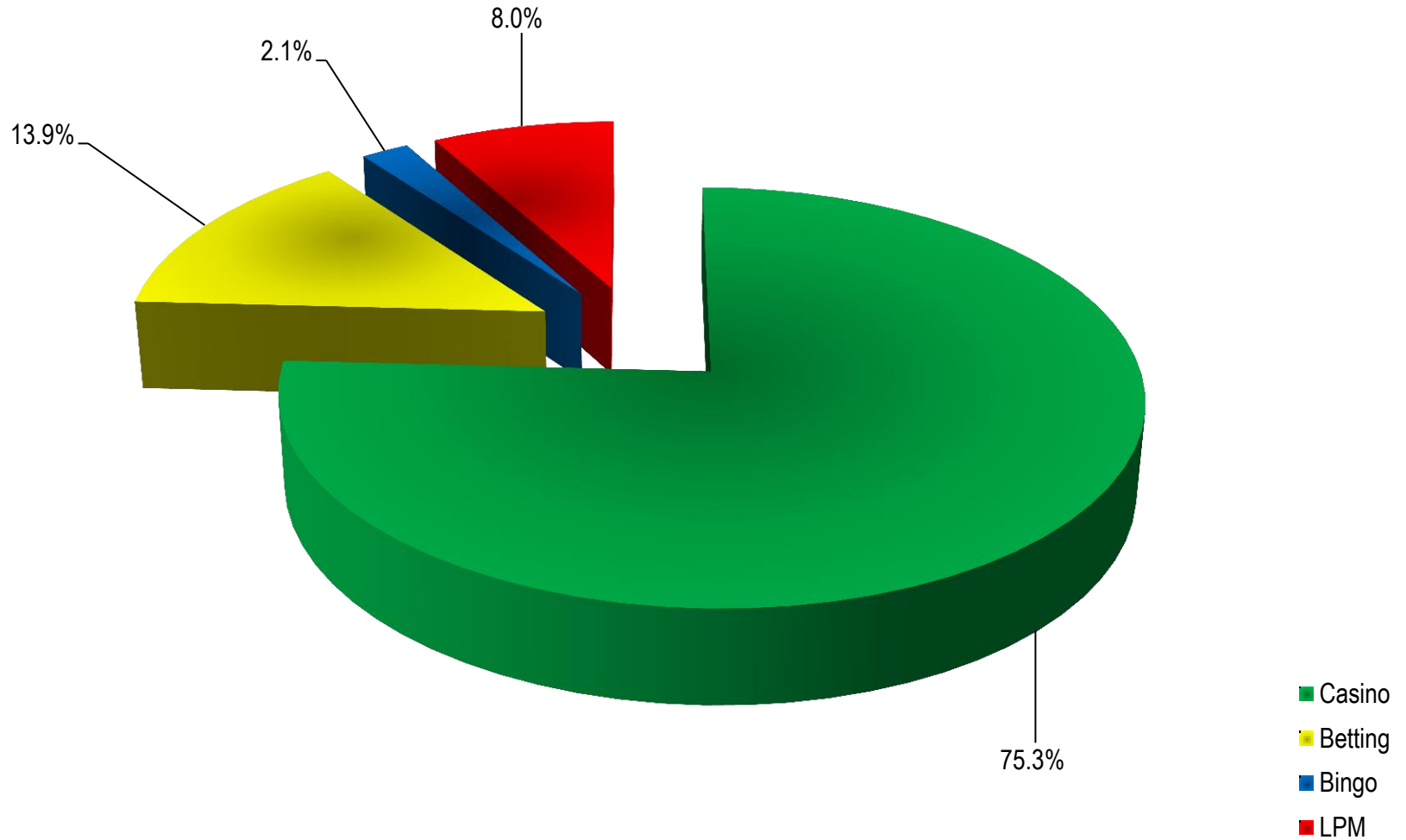

Taxes/levies contribution per gambling mode – FY2013

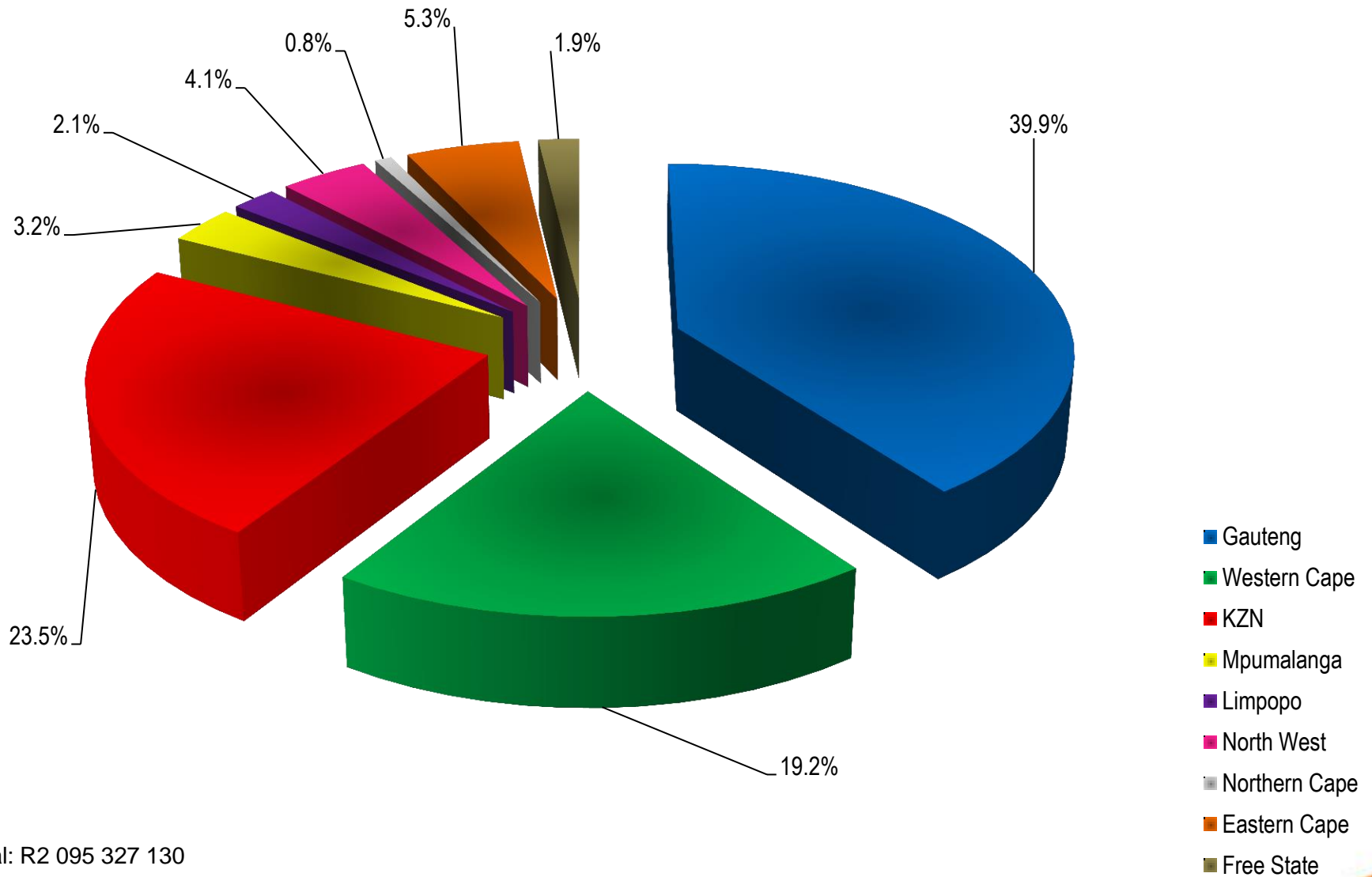
Gambling tax levied and collected by PLAs

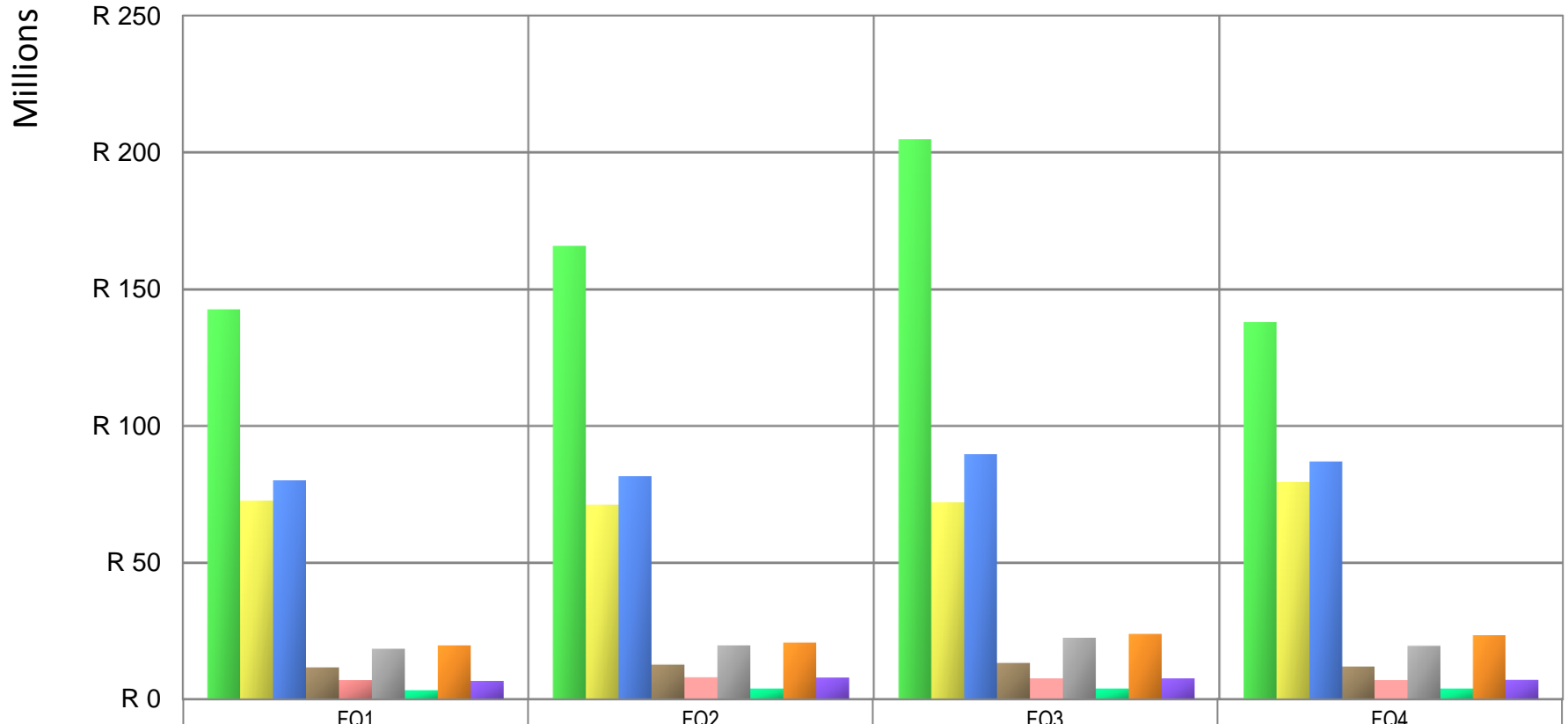
Taxes/levies contribution per province – FY2013

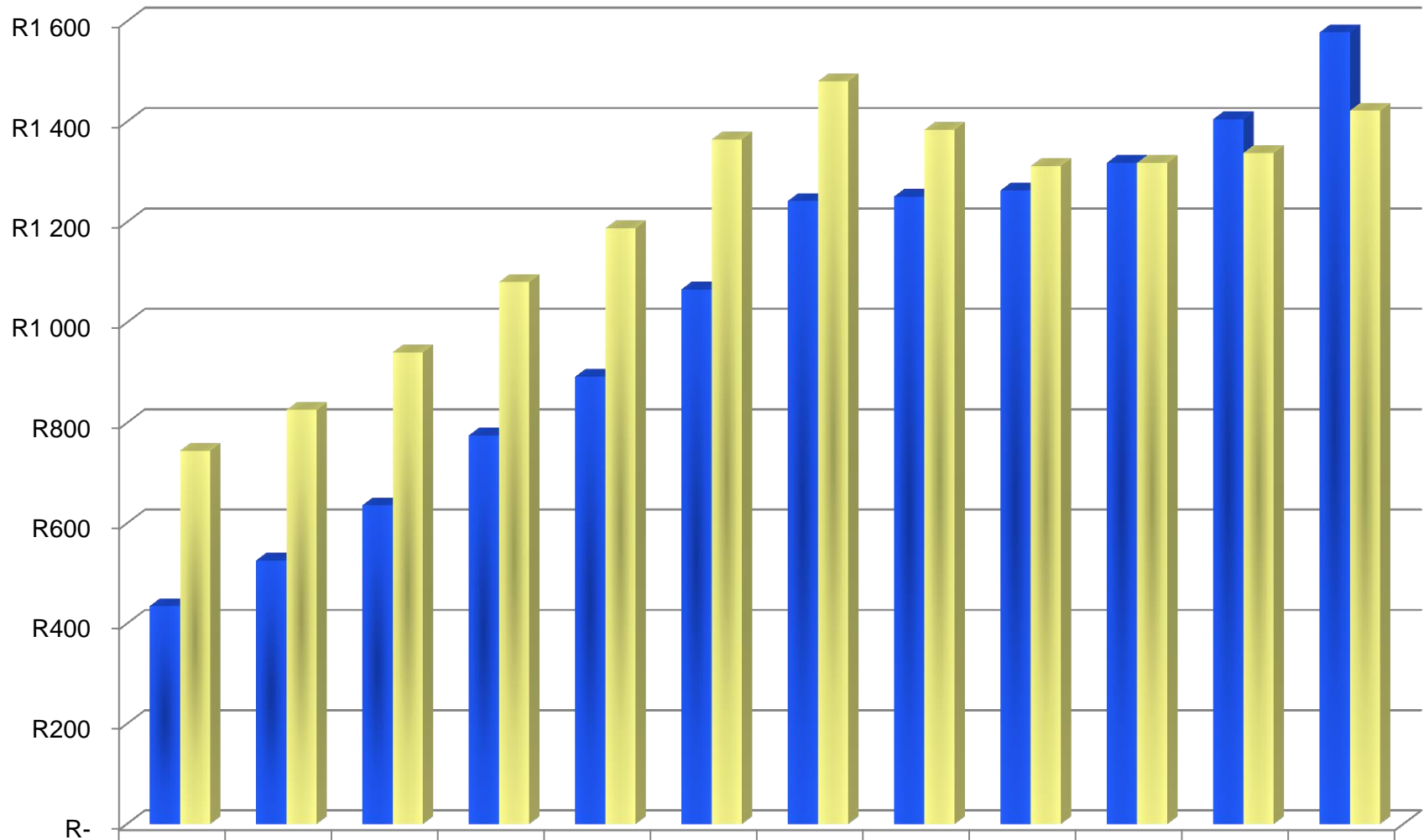

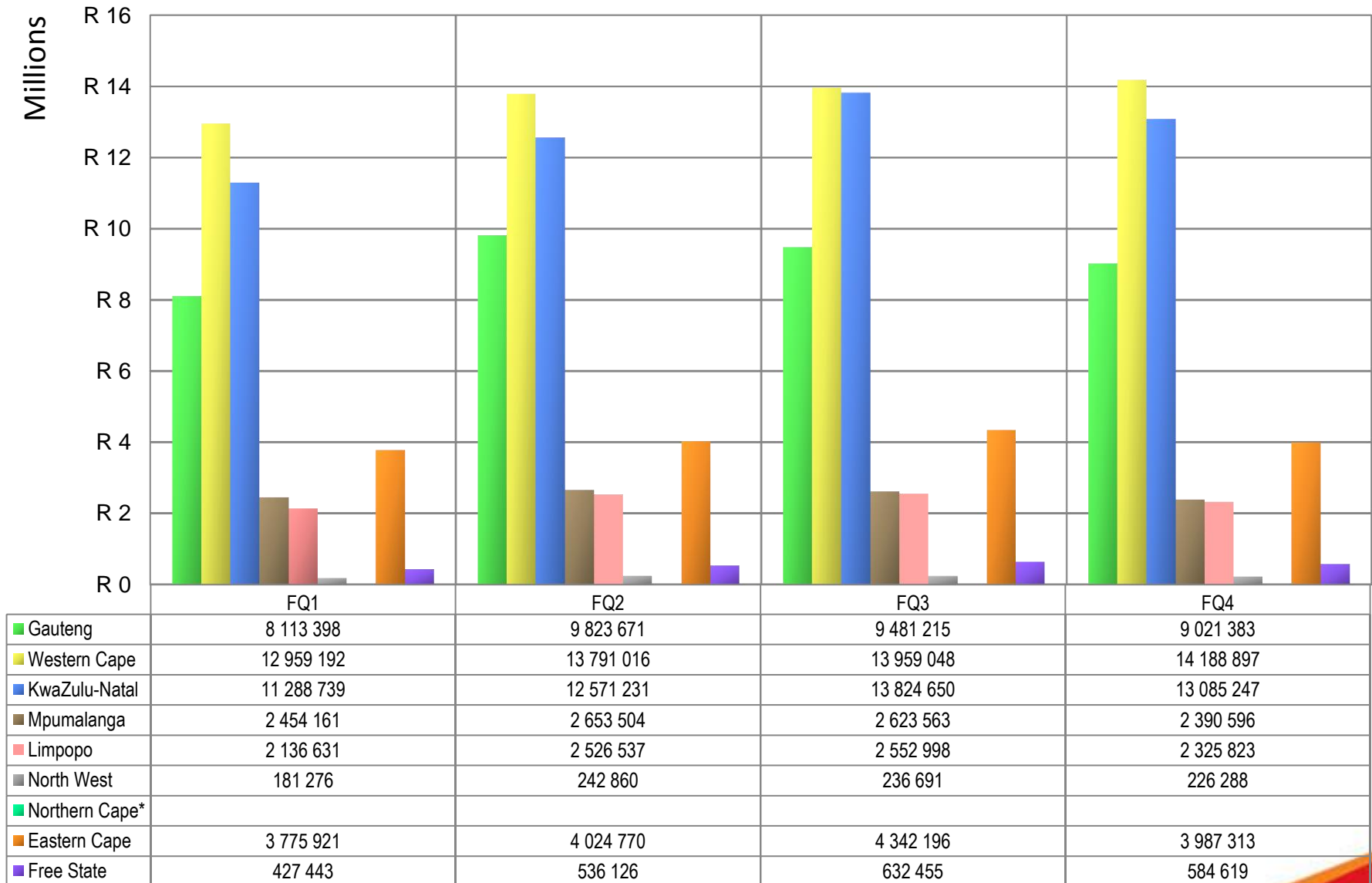

Quarterly LPM taxes/levies - FY2013*

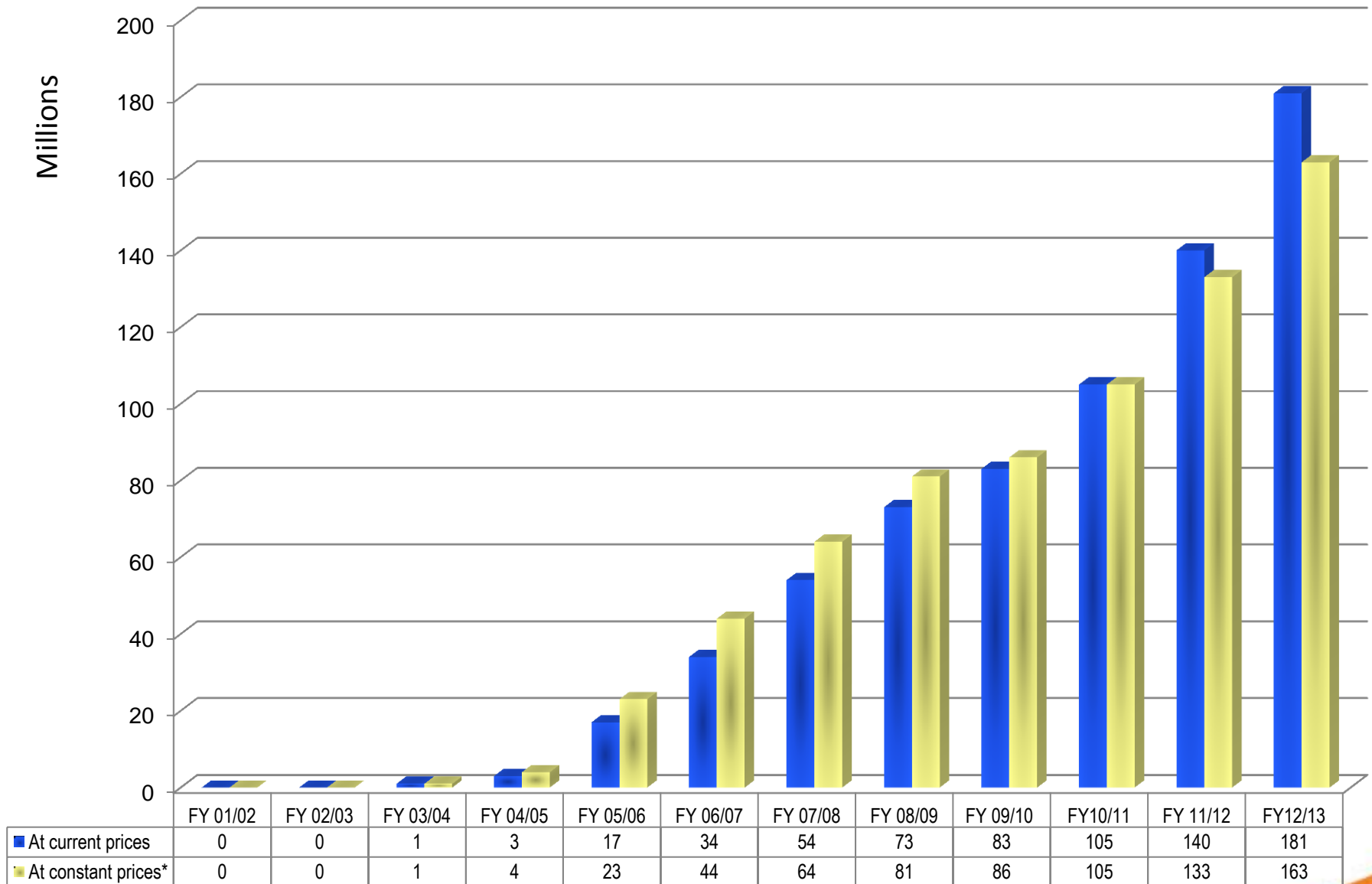

Trend in LPM taxes/levies – FY01/02 to FY12/13

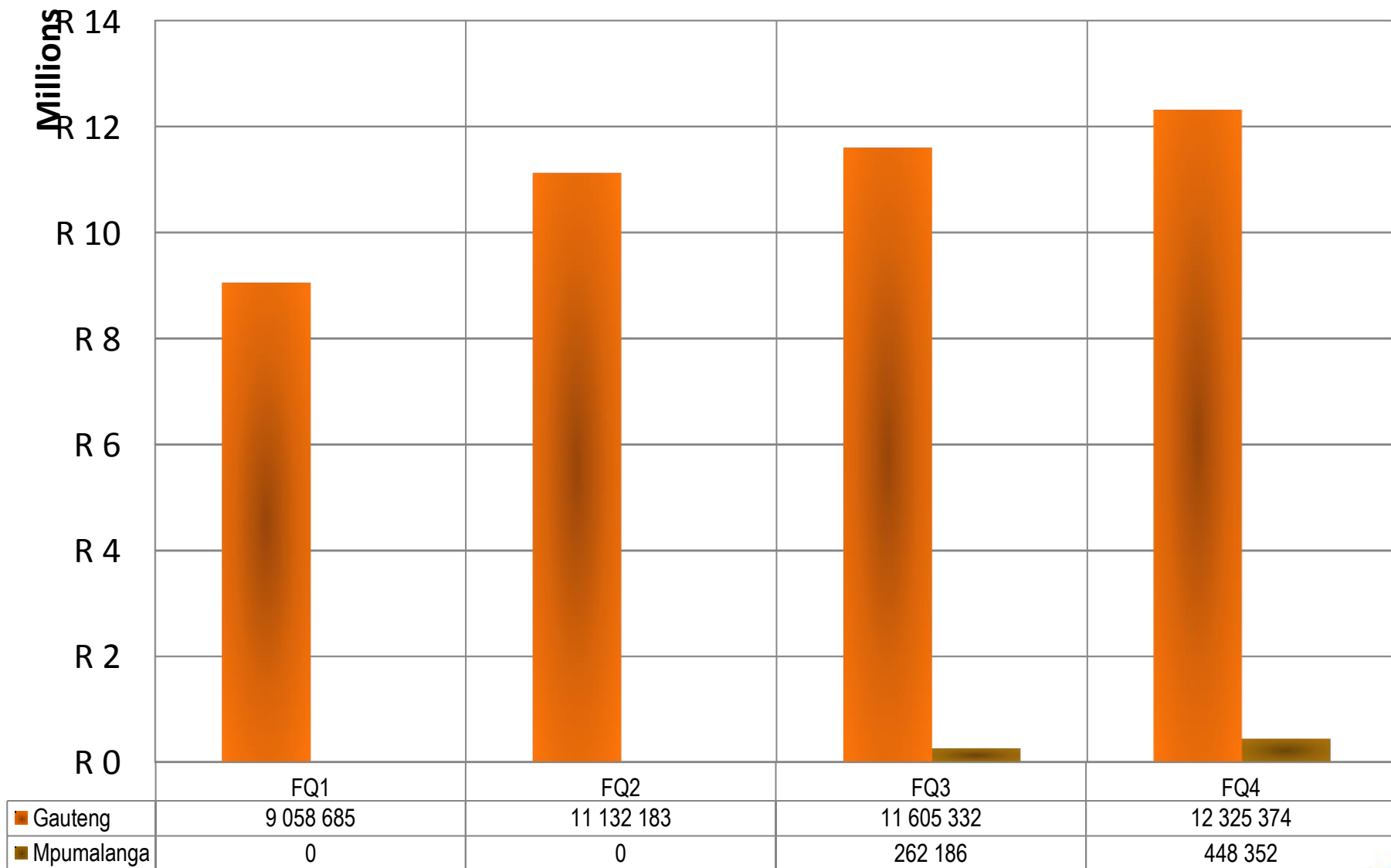

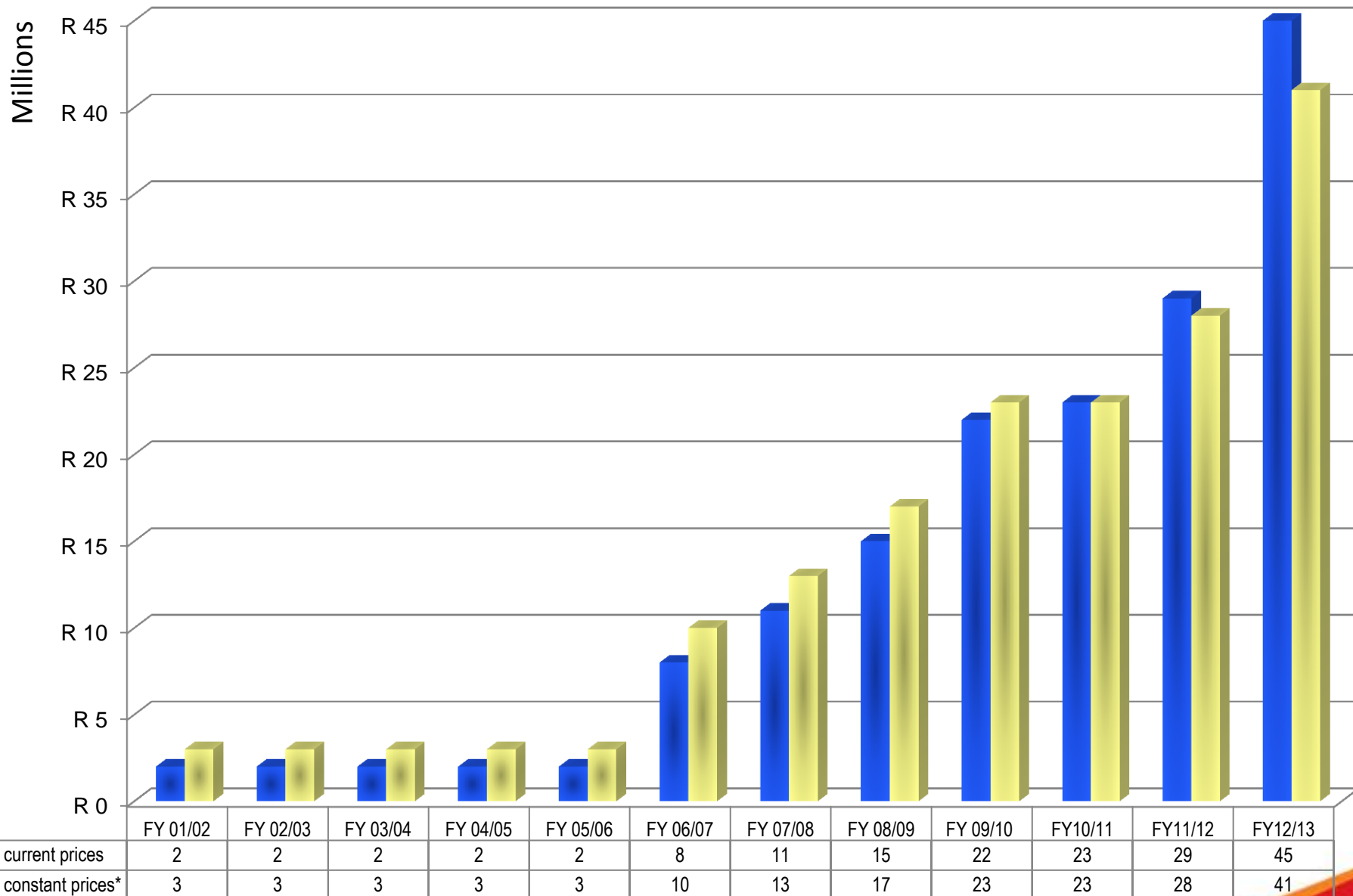

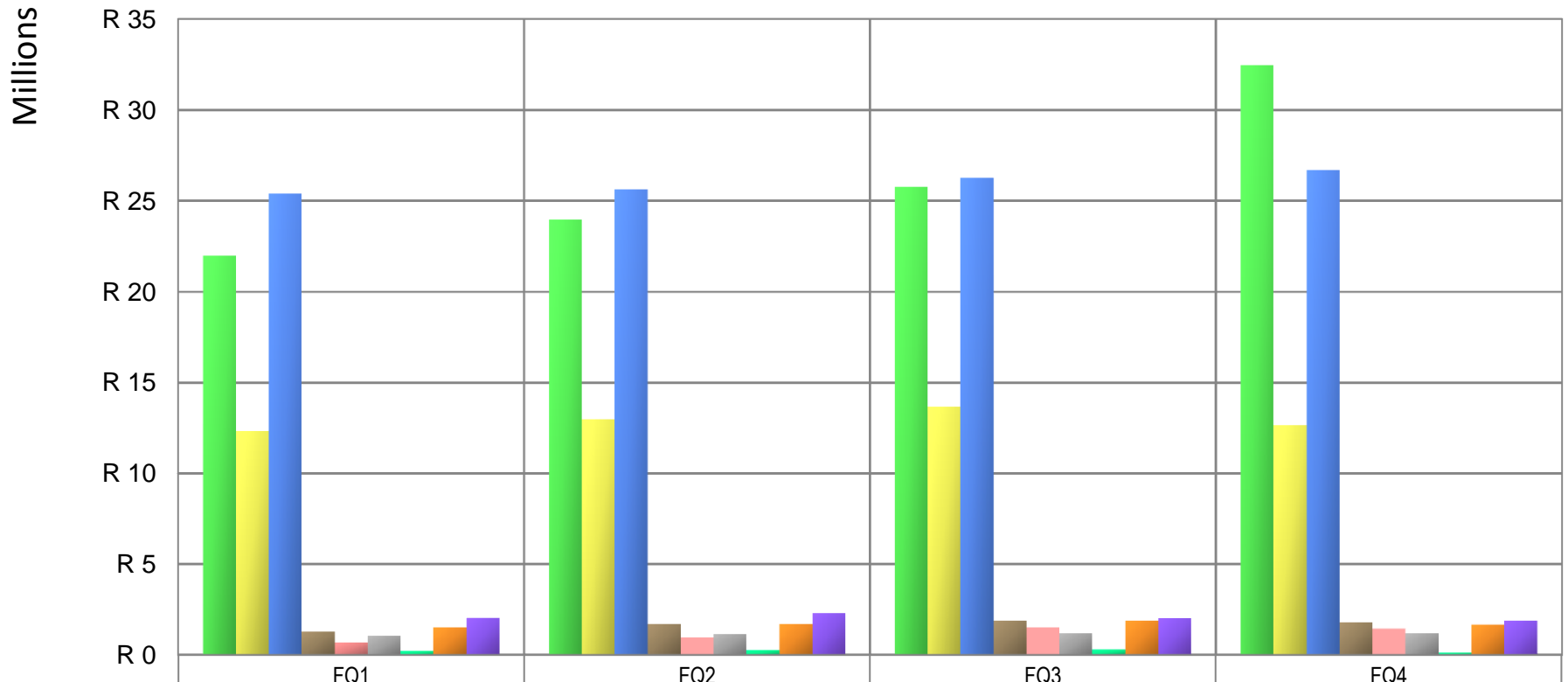

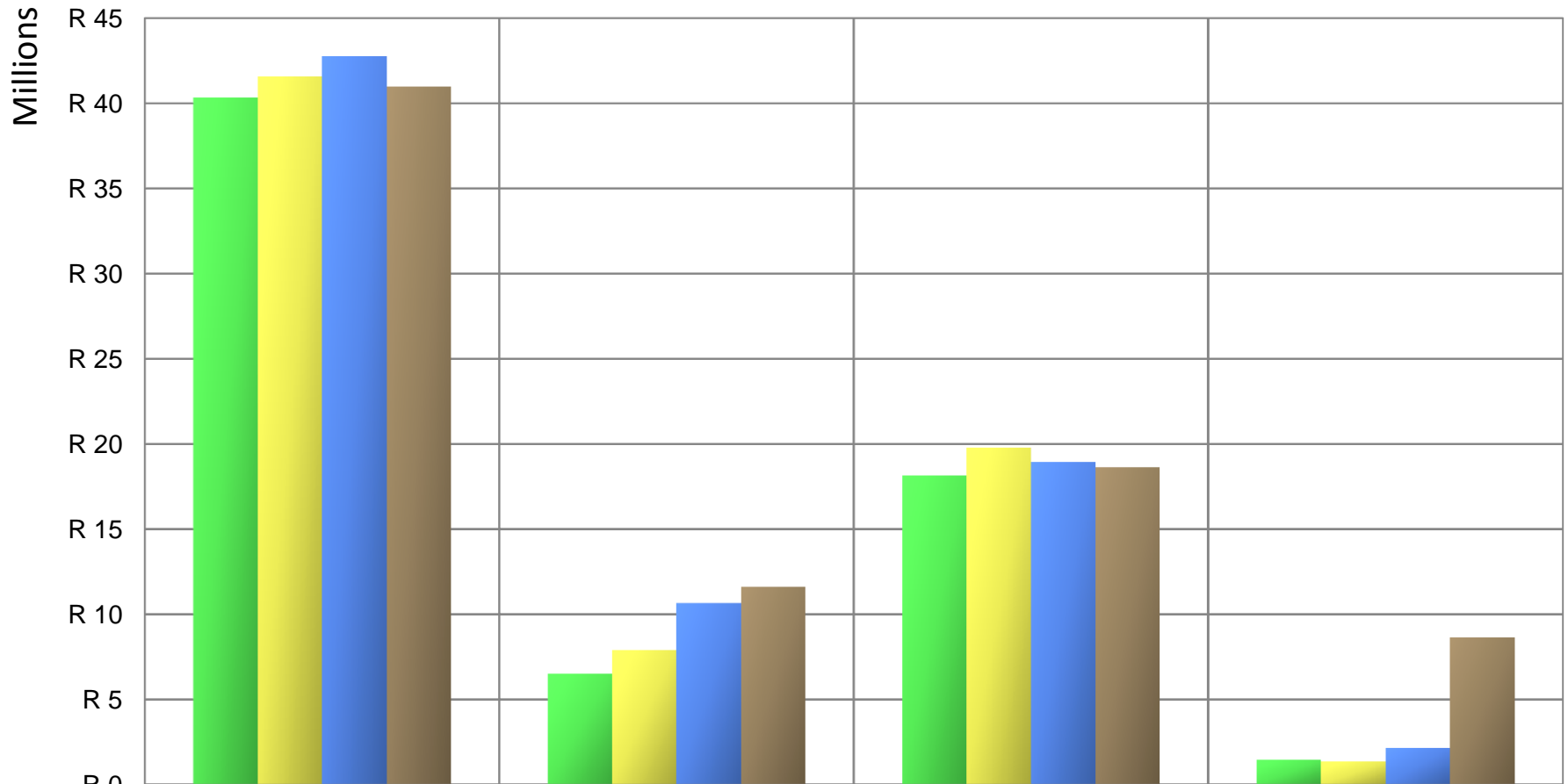

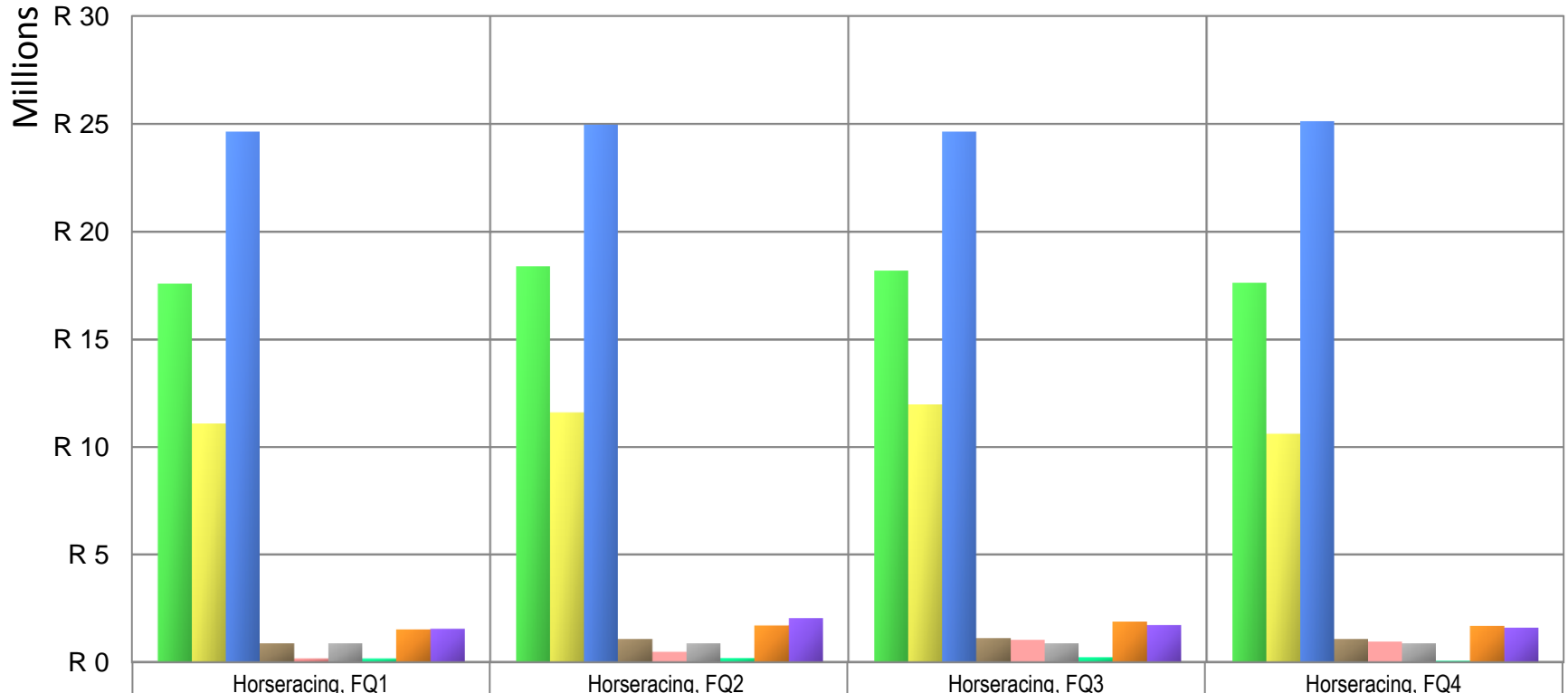

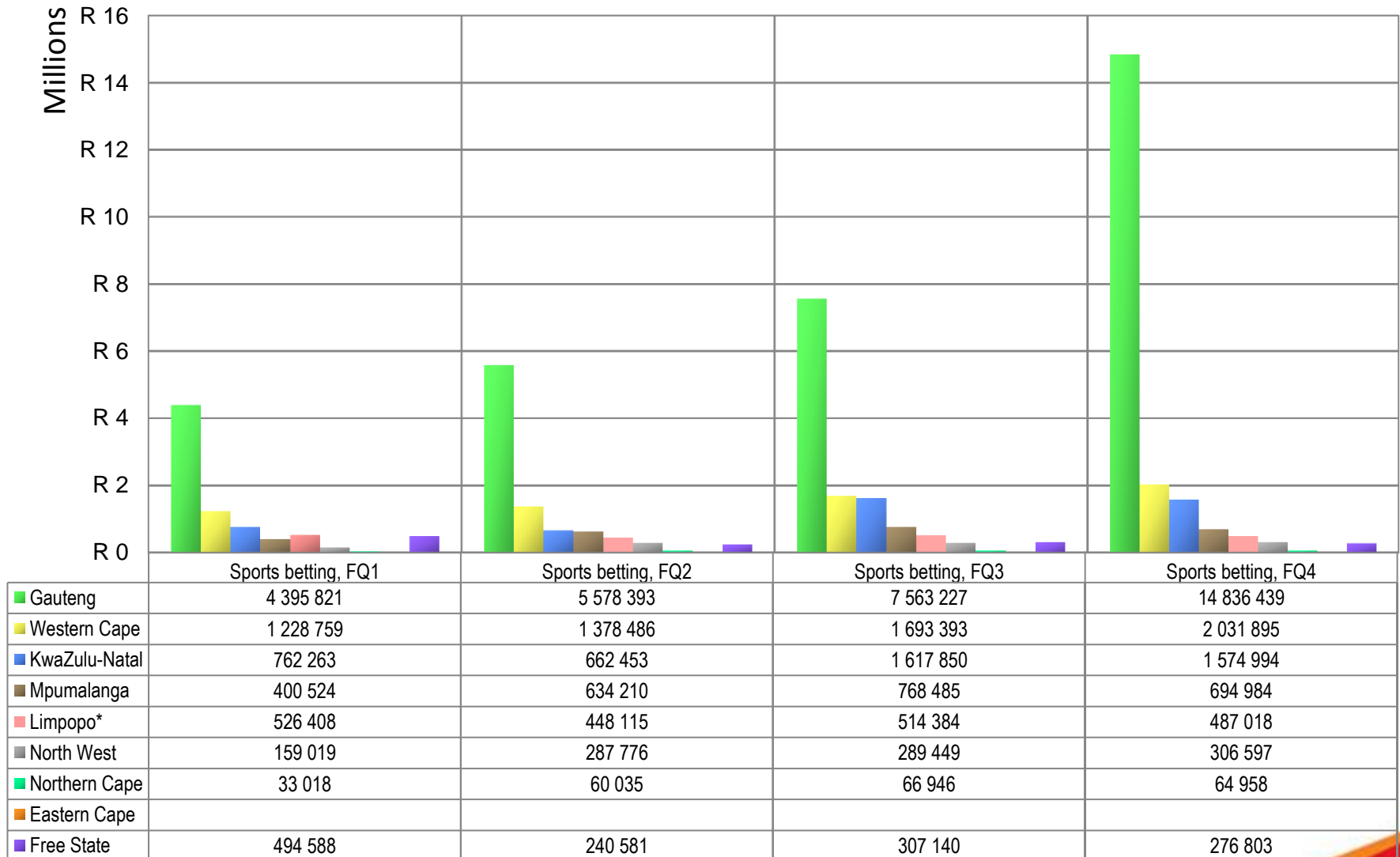

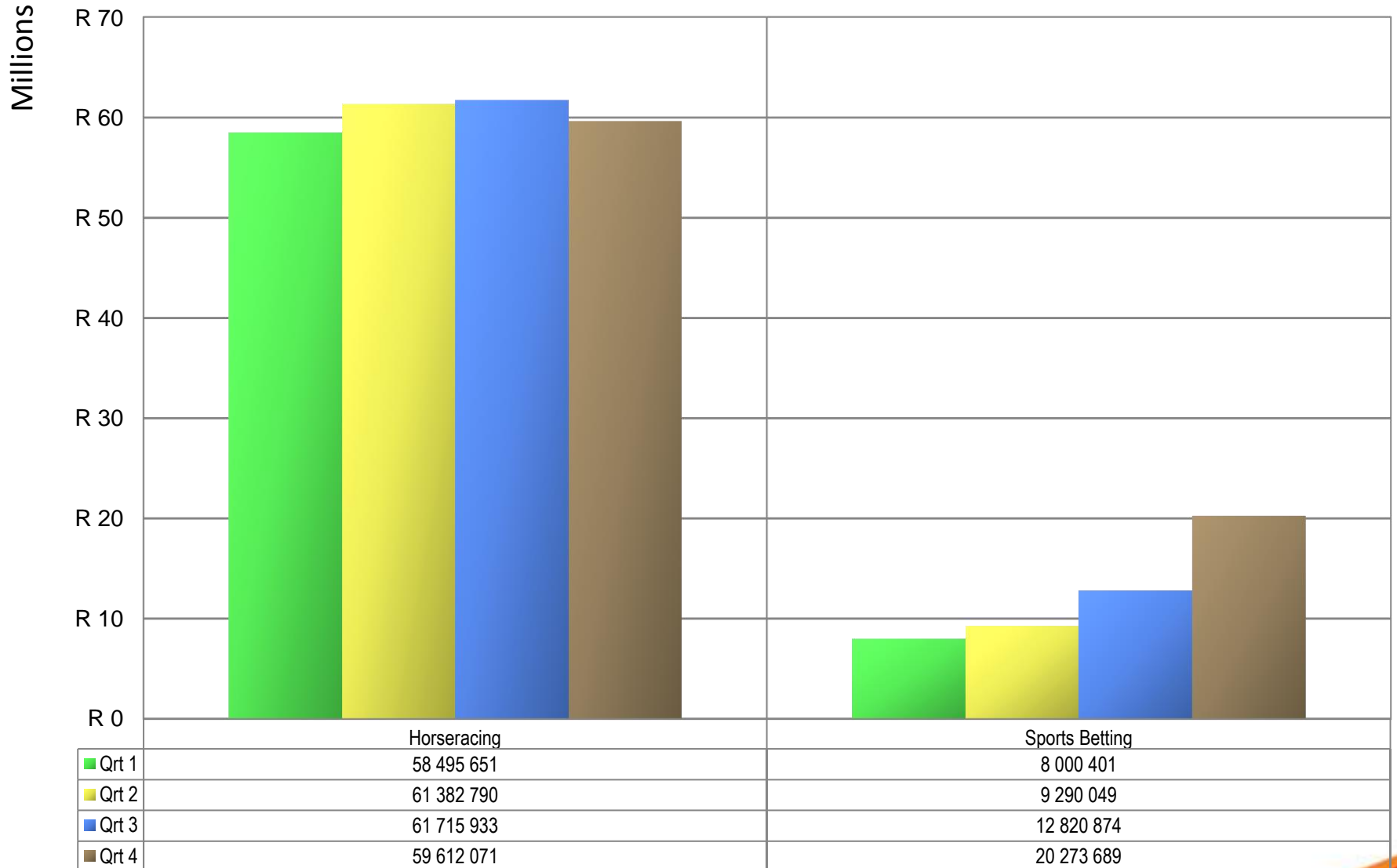

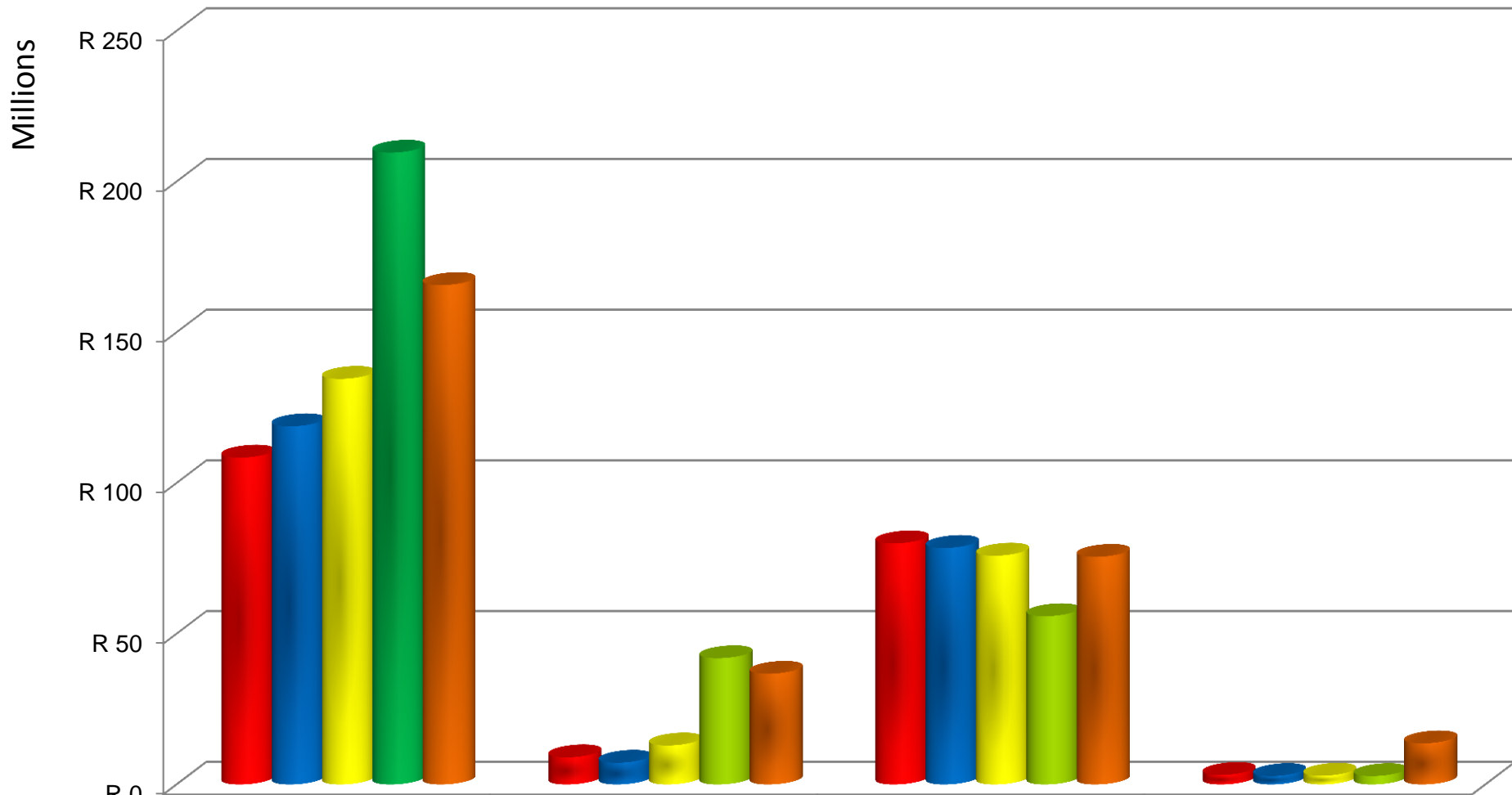

Trend in taxes/levies, bookmakers & totalisators, FY09 to FY13

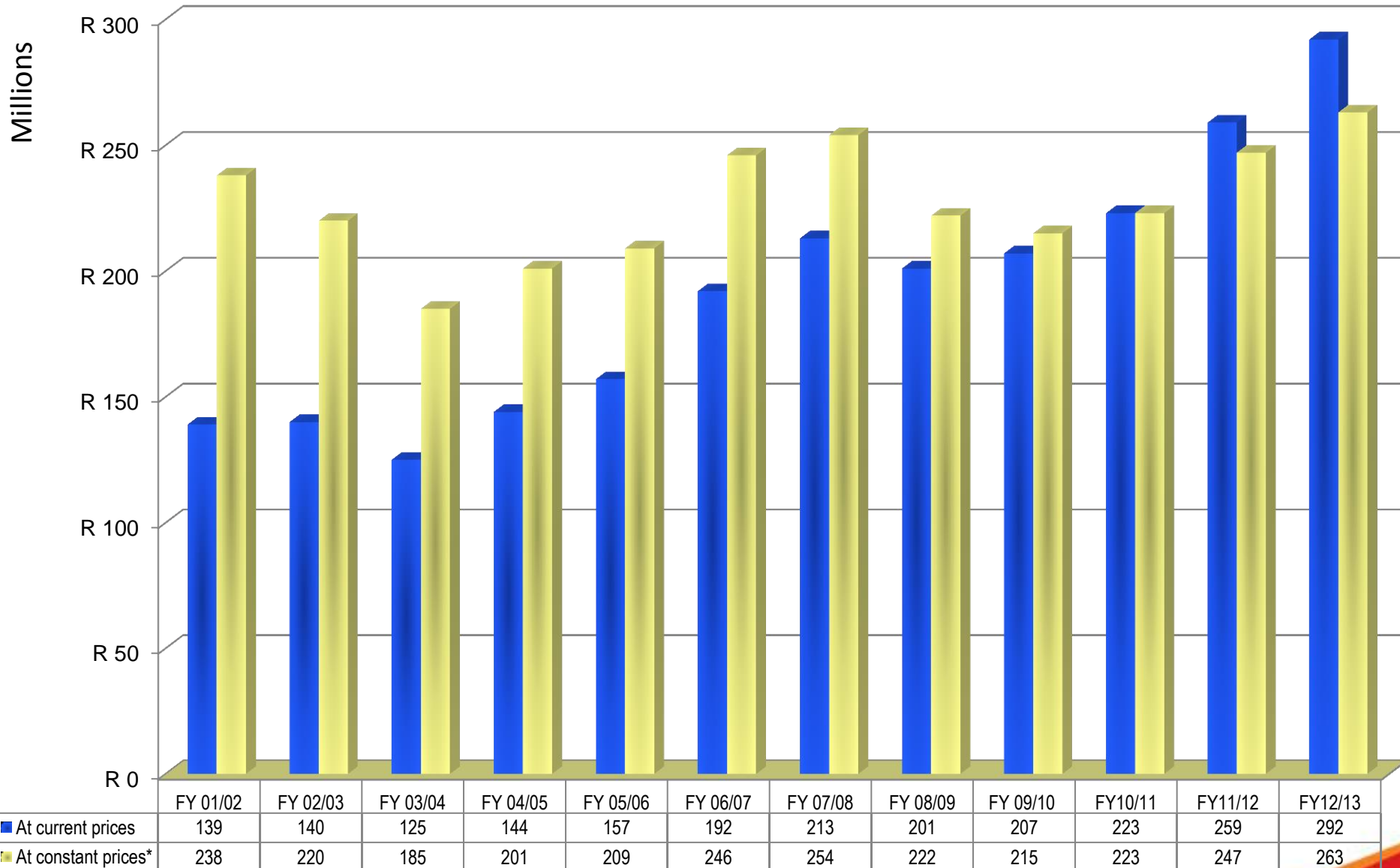

Trend in betting taxes/levies – FY01/02 to FY12/13

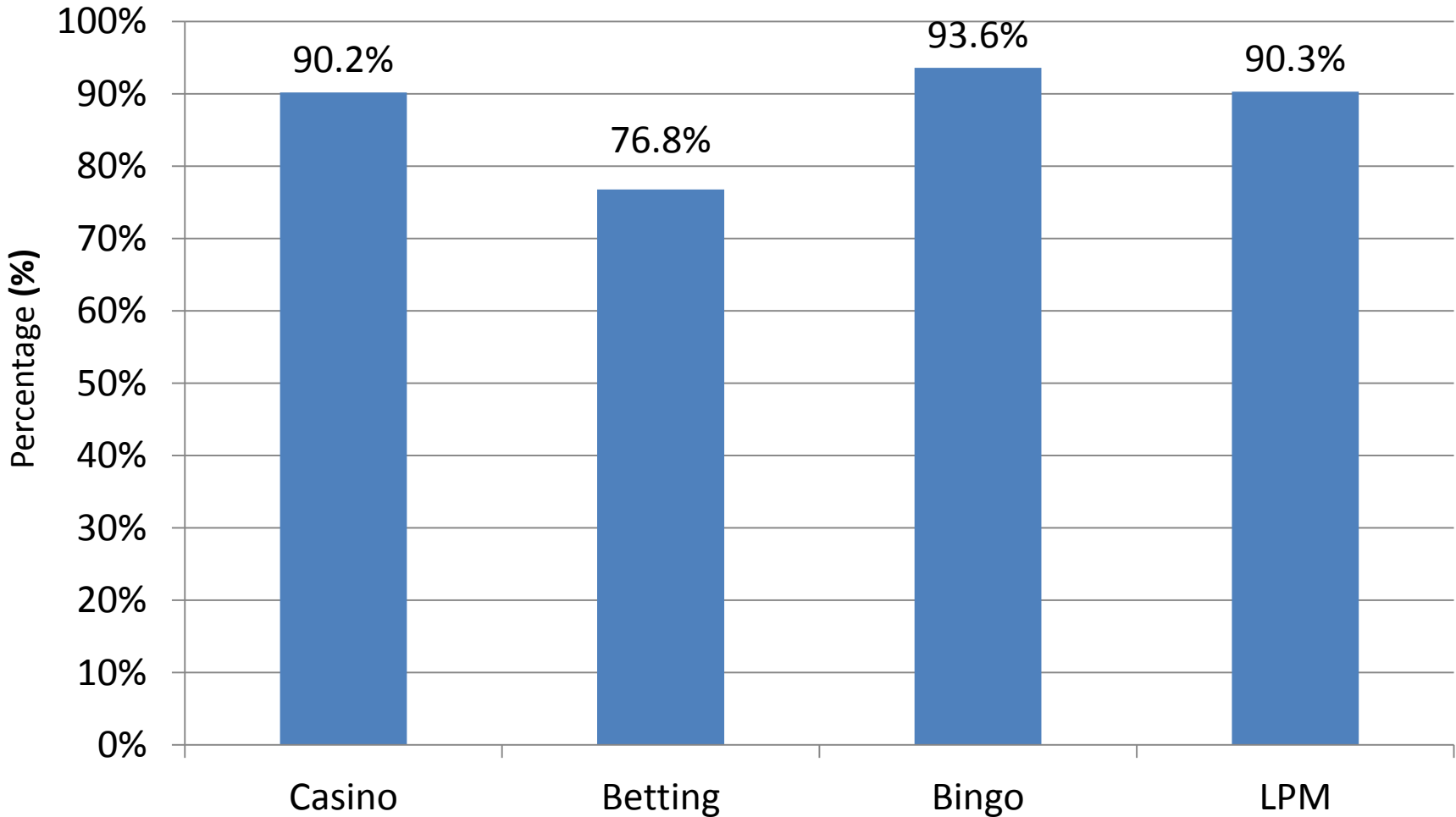

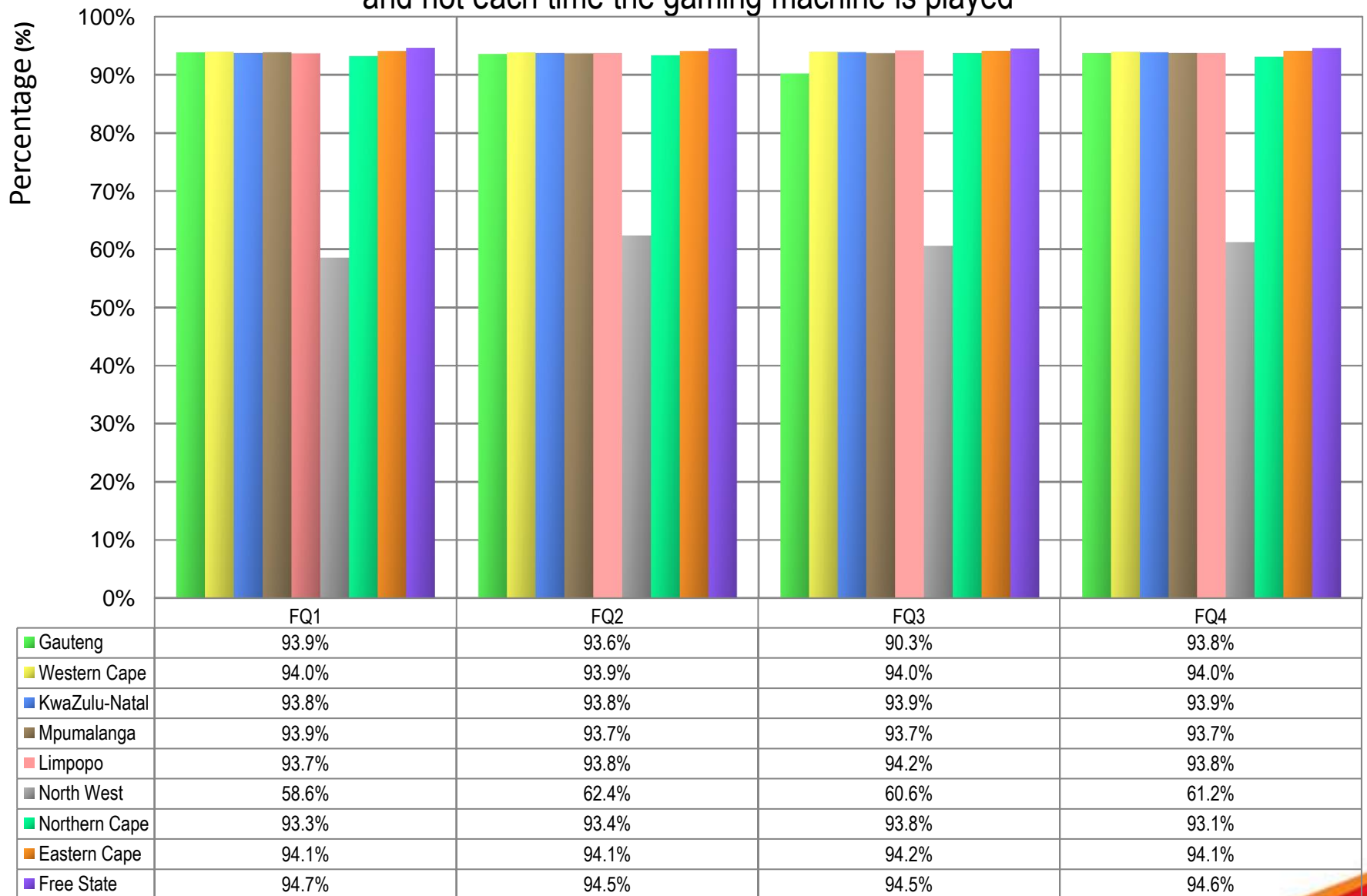
Average RTP % per gambling mode – FY2013

Return to Player is an average achieved over a significant number of game plays* and not each time the gaming machine is played



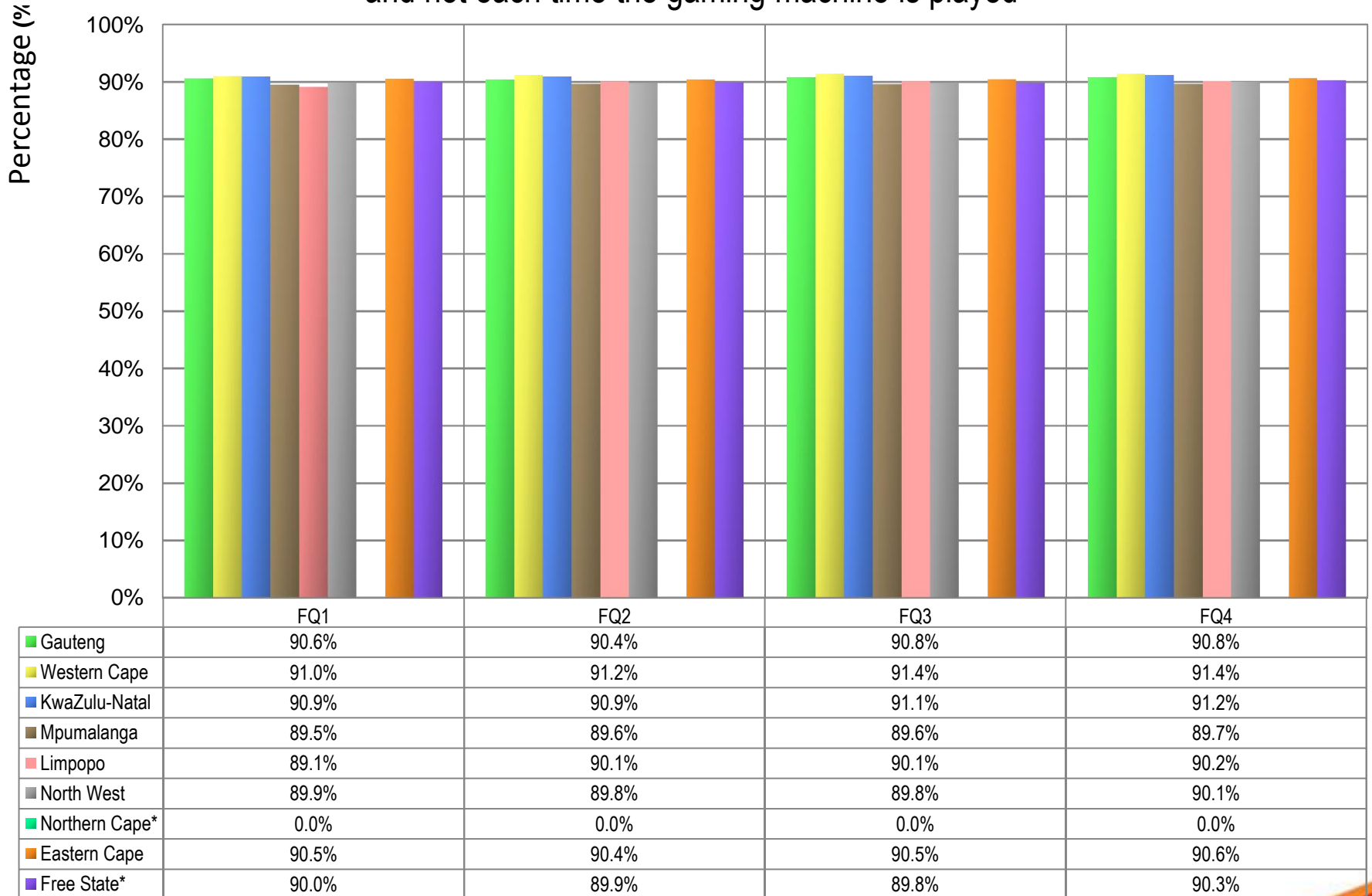
Quarterly casino RTP % - FY2013

Quarterly LPM RTP % - FY2013*

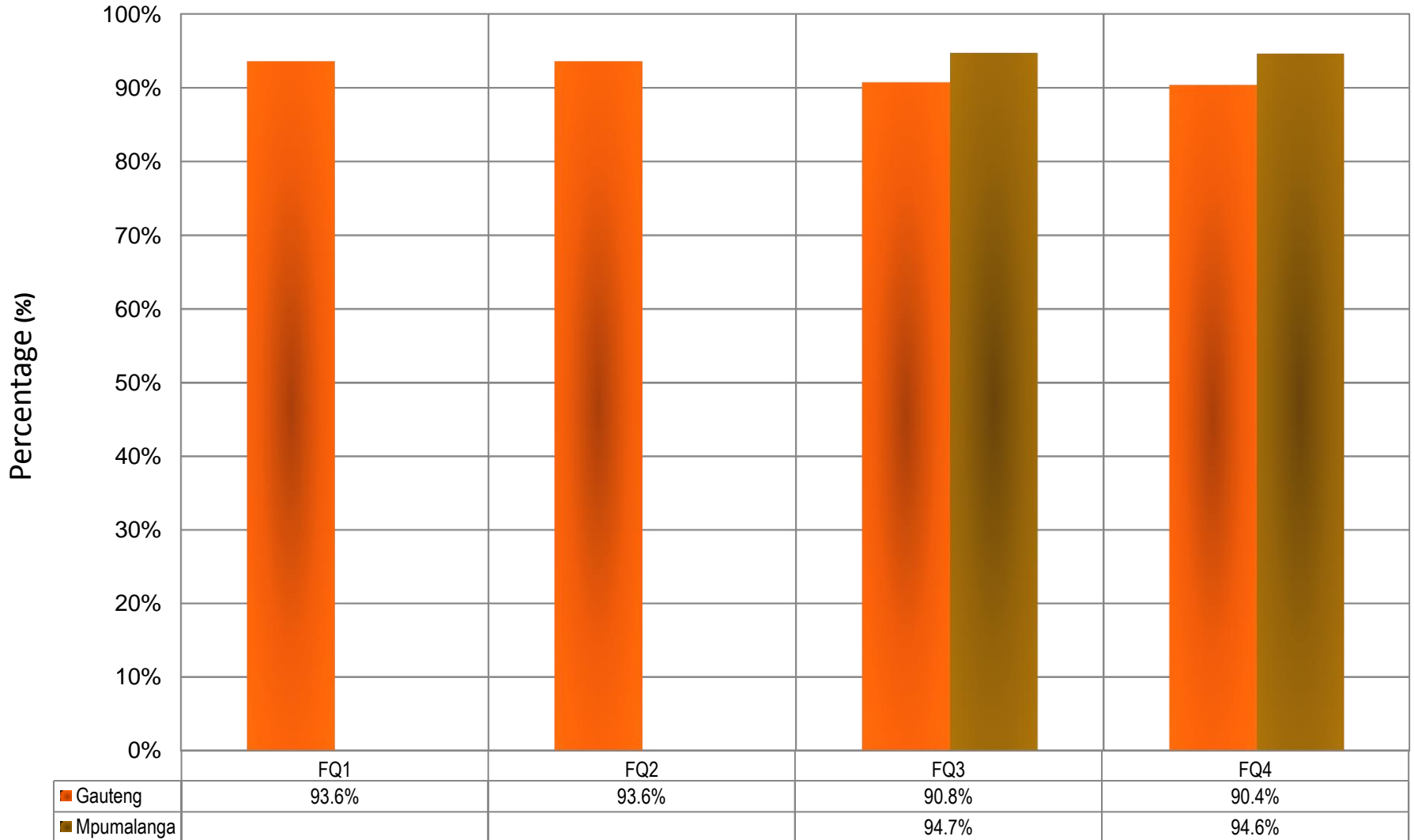

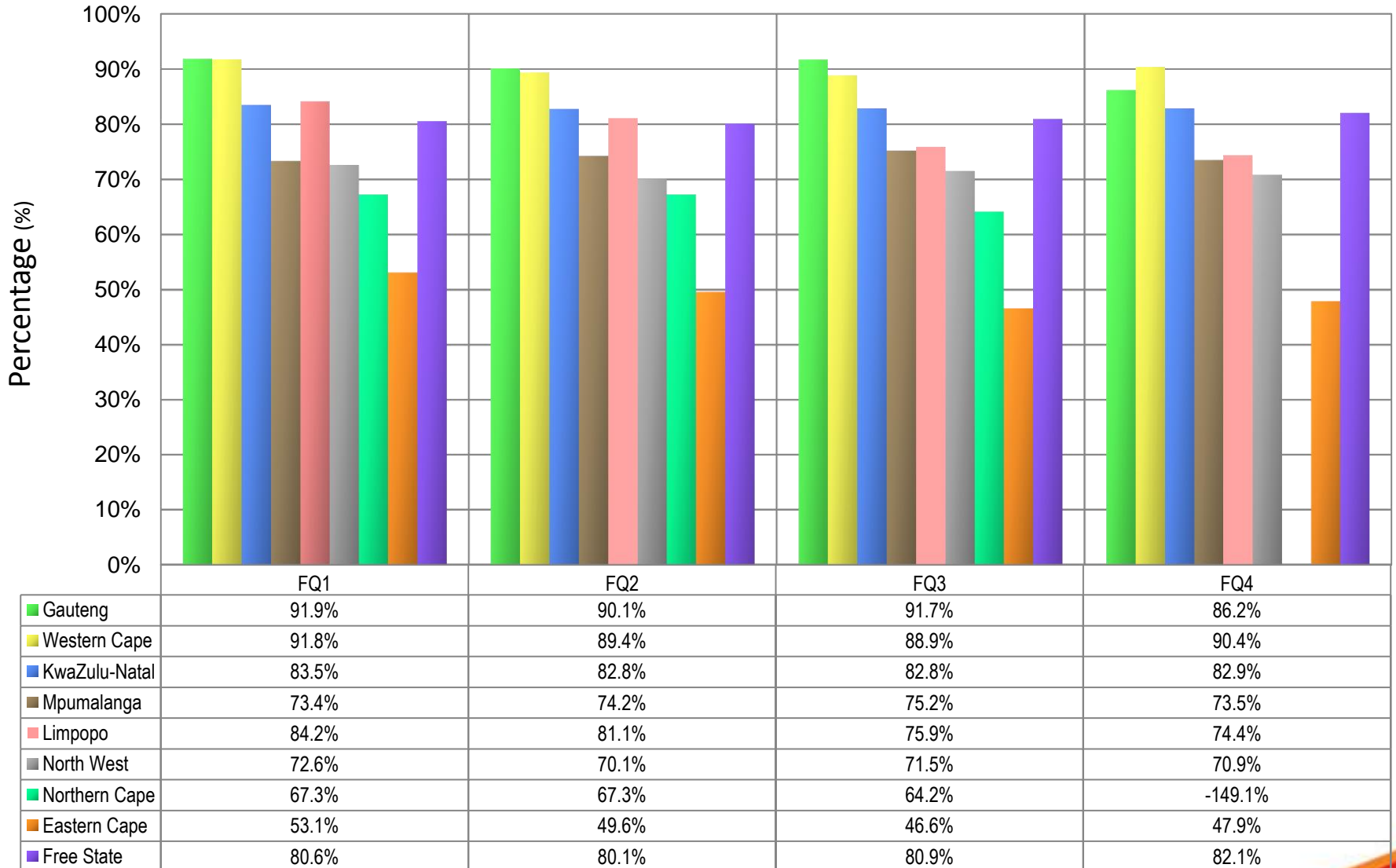

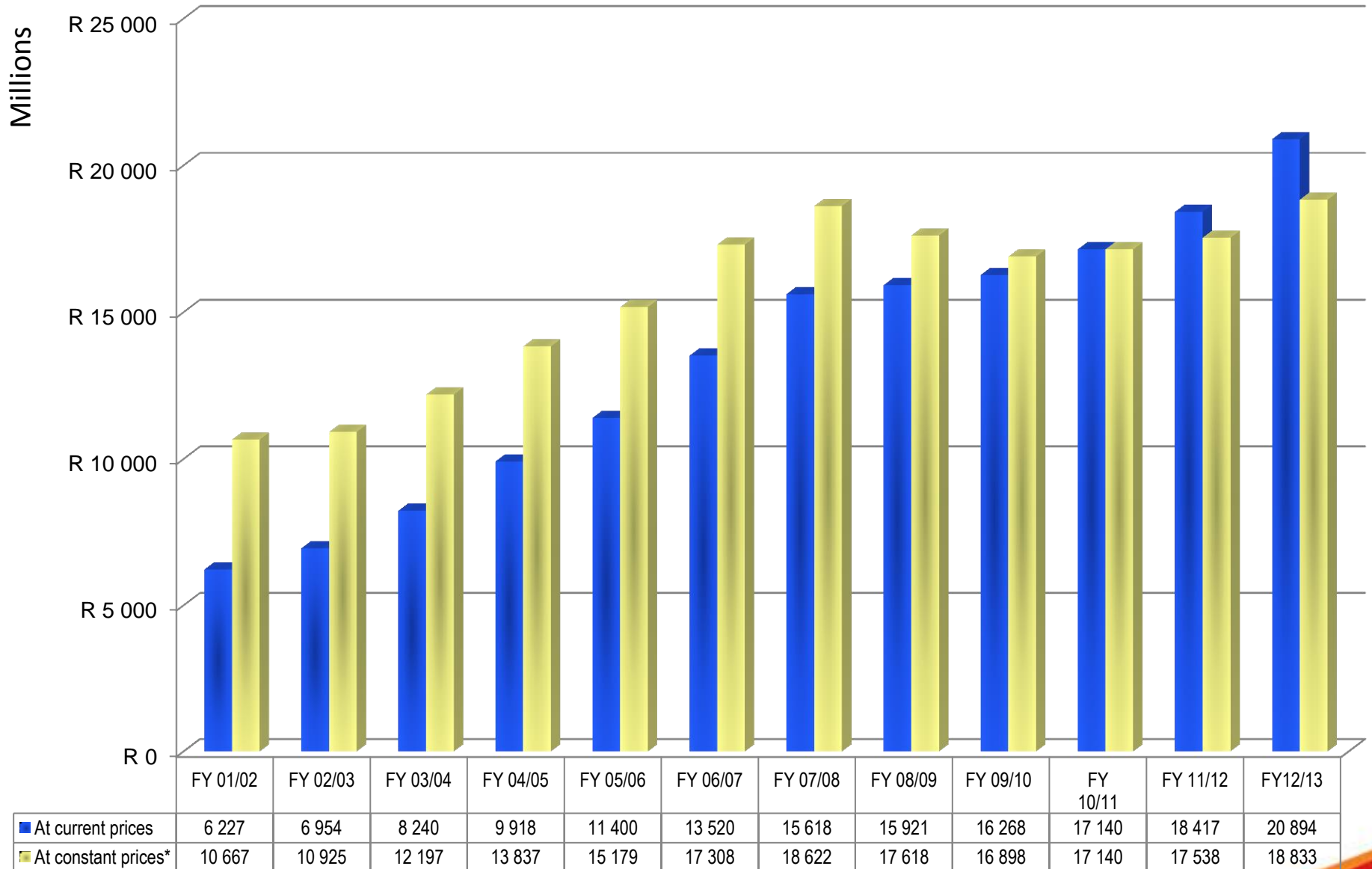
Quarterly betting RTP % - FY2013

Trend in GGR – FY01/02 to FY12/13 [all modes]

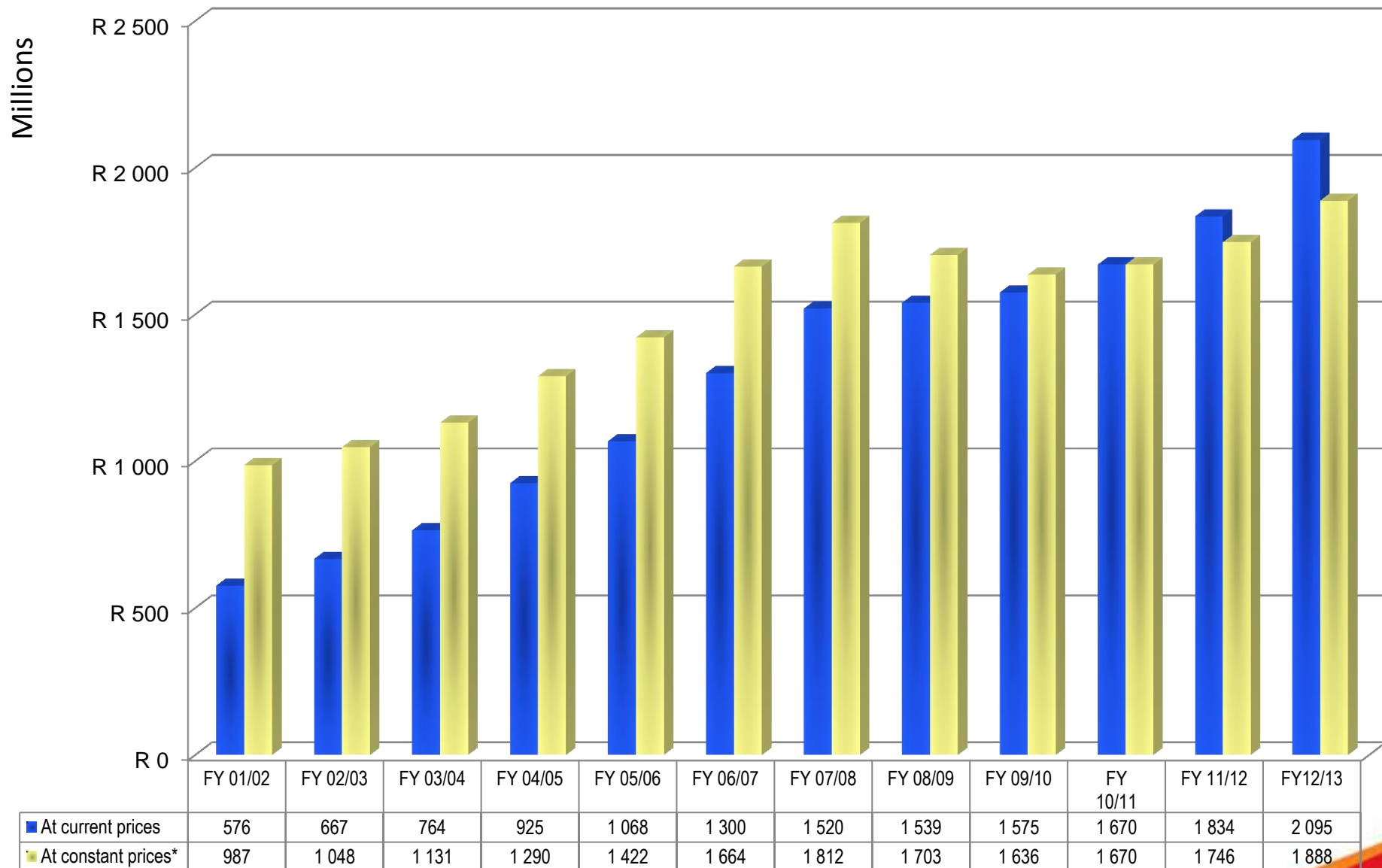
