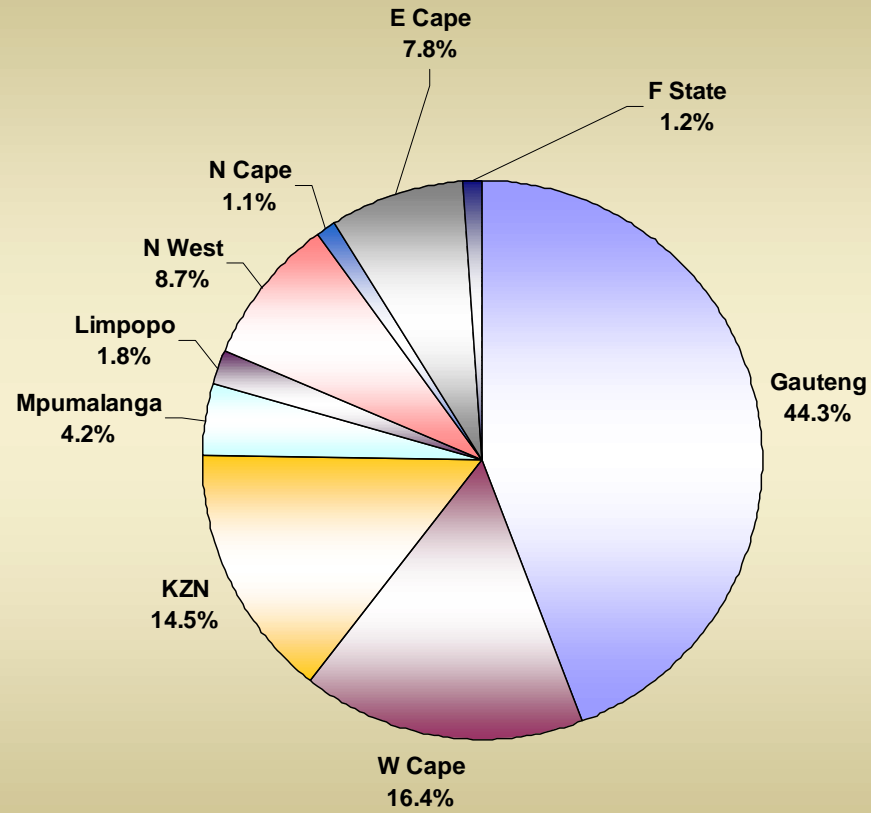

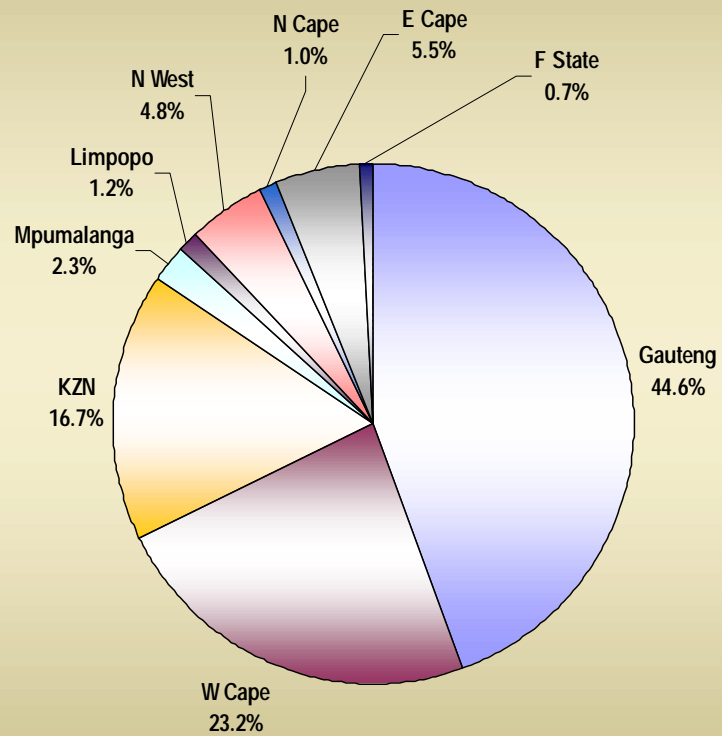

Total: R 1 932,0 million

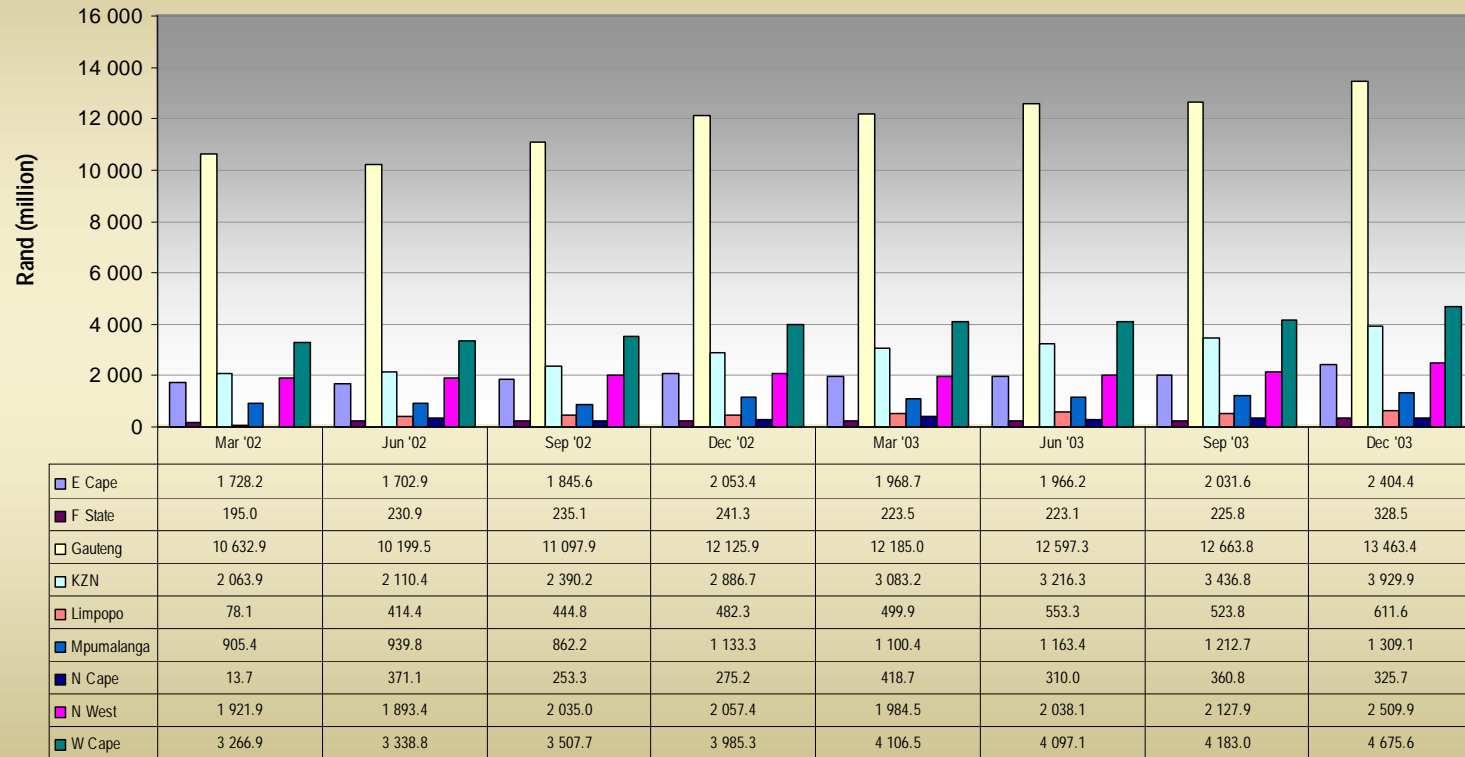
Casino gambling tax by province - Q3 of the financial year ending 31 March 2004

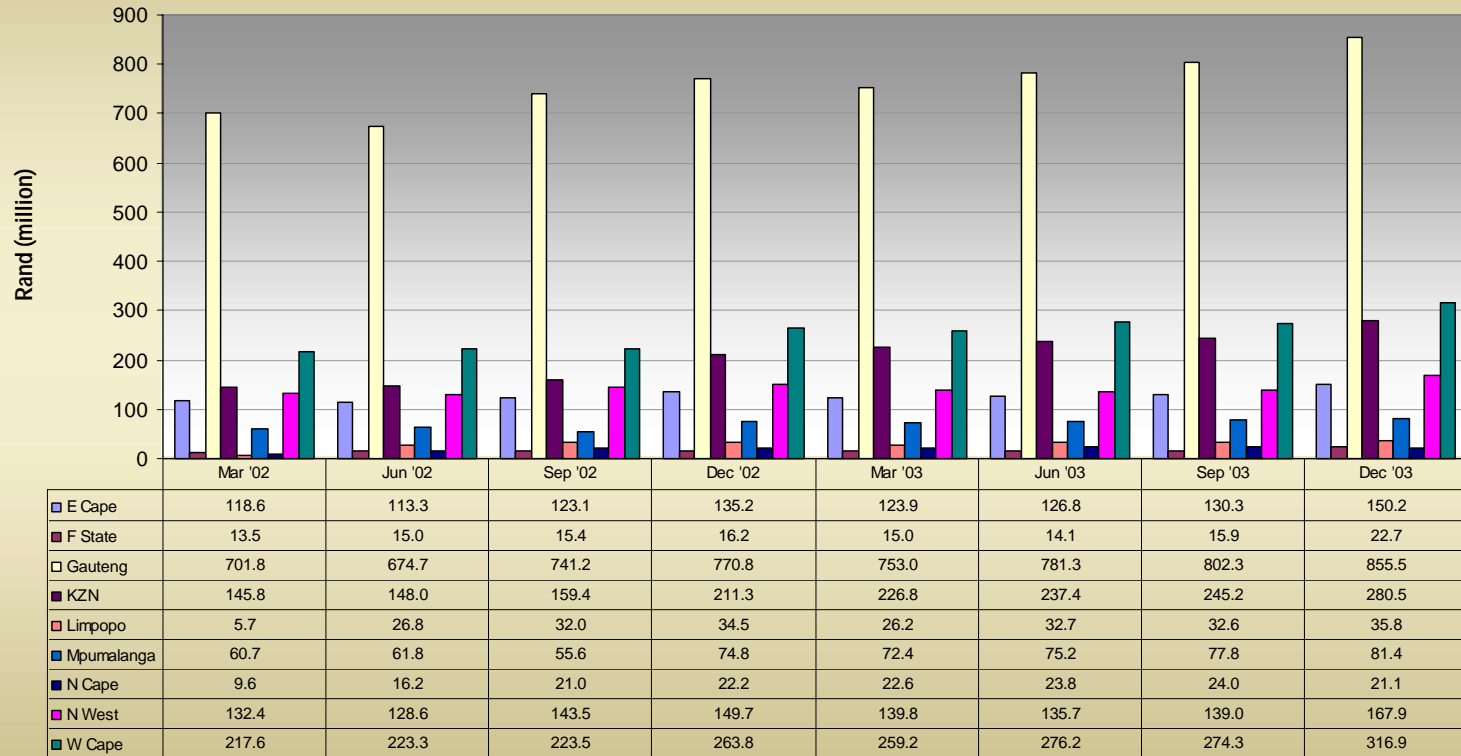

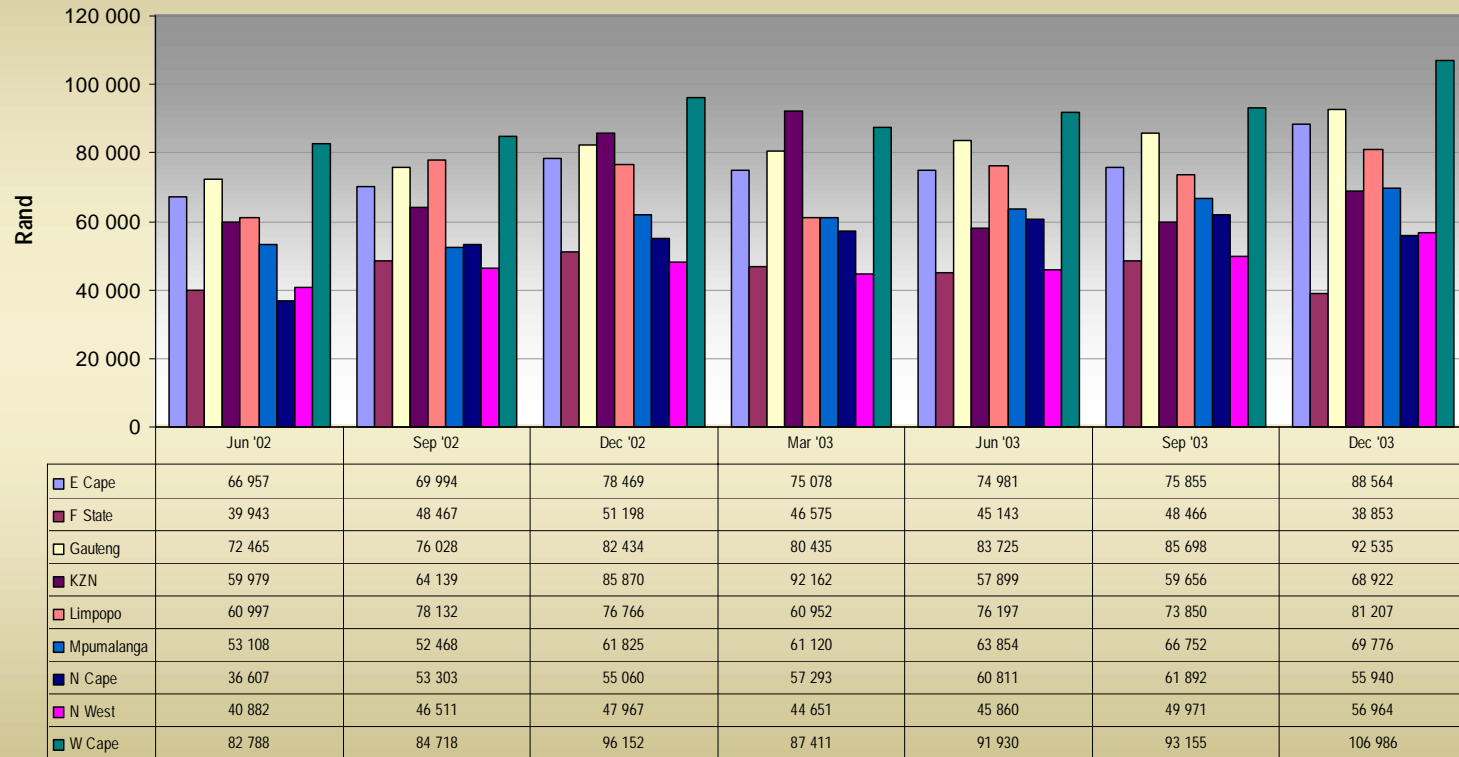

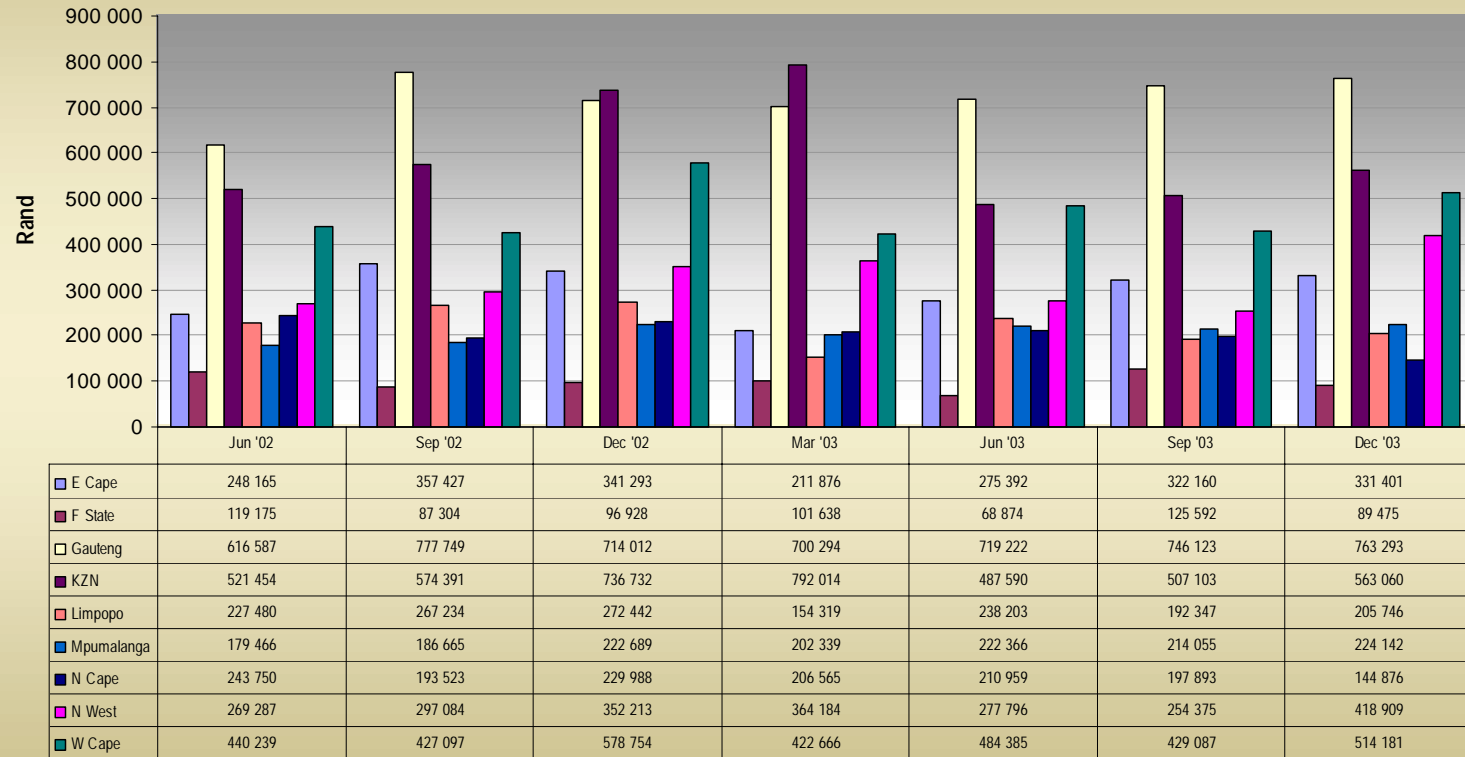

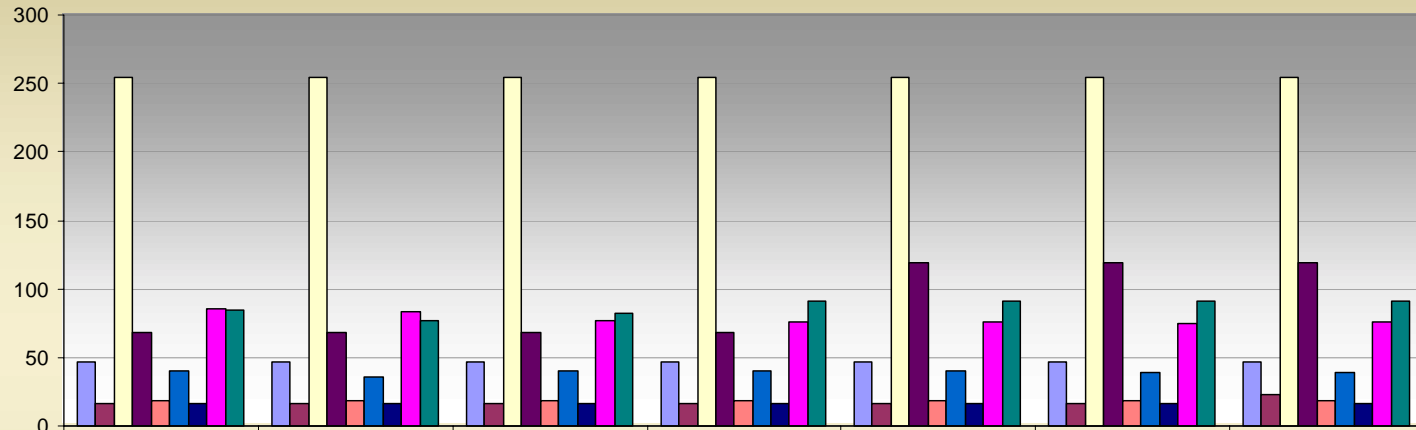

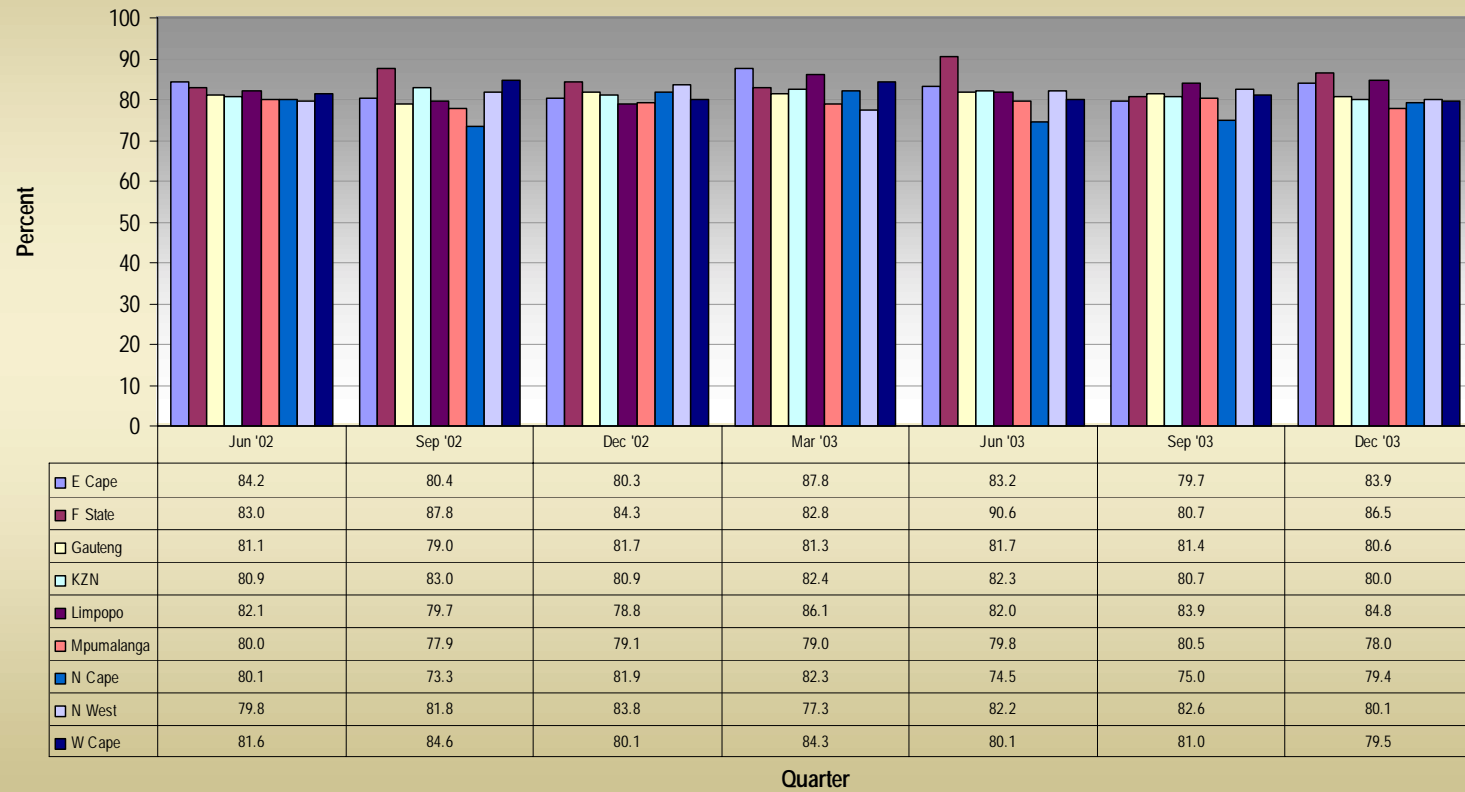

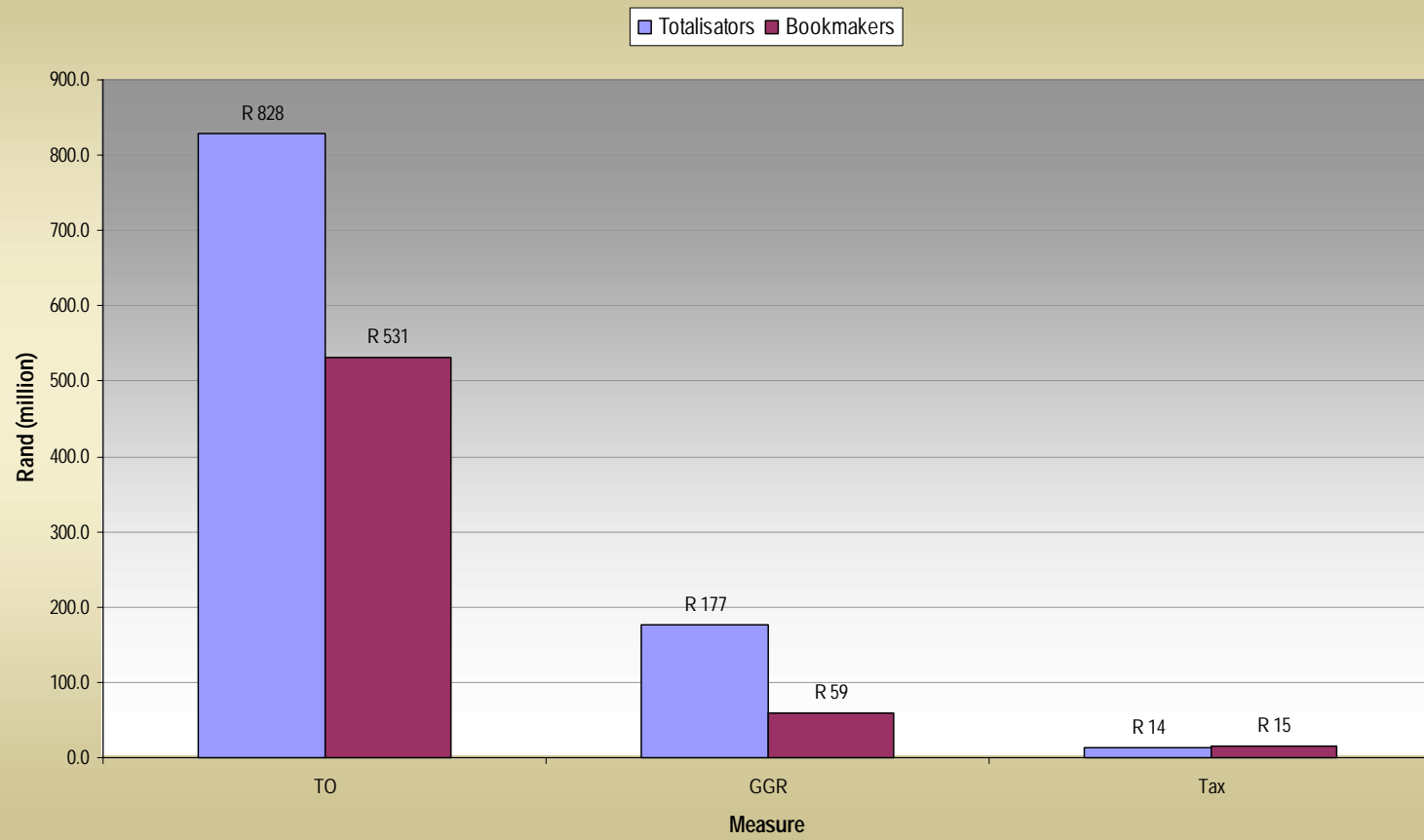
