UWRF will integrate sustainability principles in institutional structure, policies, programs, and resources to enhance the quality and well-being of the university and community.

Academics

Faculty and staff have integrated sustainability into several aspect of our curriculum. UWRF offers a variety of sustainability-focused majors, minors, and certificates as well as immersive experiences focusing on sustainability through the education abroad offerings. Additionally, faculty and instructional academic staff can receive incentives for developing sustainability-focused or sustainability-related courses or integrating sustainability into existing course.

Engagement

Staff and students have worked hard to integrate sustainability into numerous aspects of campus life and within the broader River Falls community. Employees and students serve in educator roles to educate our campus and community on sustainability related topics. Sustainability is included in new student and employee orientation. Students and the broader campus community engage with sustainability-related information through a variety of outreach materials and publications coordinated through the Office of Sustainability. We have numerous campus and community partnerships and offer some sustainability programming through the Continuing Education department.





Operations

UWRF has achieved increased building energy efficiency using energy saving strategies and strategic monitoring of energy use on campus. The campus works closely with the City of River Falls and Wisconsin Department of Natural Resources to ensure that we are adequately addressing rainwater and utilizing low impact development practices.

Planning and Administration

The Office of Sustainability works with external organizations to review and verify our sustainability-related reports. Students and employees have access to wellness programs and activities as well as counseling services and employee assistance programs. UWRF prohibits smoking and tobacco use on campus.
