Measurement of Radiative Bhabha and Quasi-Real Compton Scattering

Abstract

We report on a study of radiative Bhabha and quasi-real Compton scattering at centre-of-mass energies between 50 GeV and 170 GeV, and 20 GeV and 140 GeV, respectively, using the L3 detector at LEP. The analysis is based on data corresponding to an integrated luminosity of 232:2 pb1 . A total of 2856 radiative Bhabha and 4641 Compton scattering events are collected. Total and differential cross sections for both reactions are presented and found to be in good agreement with QED expectations. Our measurement of Compton scattering at the highest energies obtained so far is used to derive exclusion limits on the coupling λ for the on-shell production of an excited electron e ? decaying into a ^e pair in the mass range 20 GeV $< m_{e^{\star}} < 170$ GeV.

Introduction

At LEP, Bhabha scattering has been measured at centre-of-mass energies, \sqrt{s} , between 88 GeV and 172 GeV [1]. The energy range from 12 GeV to 60 GeV is covered by data from experiments at PEP, PETRA and TRISTAN [2]. The energy region between TRISTAN and LEP1 is not explored by direct measurements and the LEP2 energy points are sparse. However, all regions can be studied using events with hard initial-state radiation in which the fermion pair is produced at lower energies as has been performed for the reaction $e^+e^-\to \mu^+\mu^-\left(\gamma\right)$ [5].

Due to the effect of initial-state bremsstrahlung, lower energy beam electrons¹⁾ are produced accompanied by a high energy photon collinear to the beam direction. Either the electron or the photon can react with the other beam particle in a hard scattering process, resulting in either Bhabha or Compton scattering. Both reactions are illustrated in Figure 1.

For Bhabha scattering with initial-state radiation the visible cross section is described by a convolution of the improved Born Bhabha cross section, o_{ee}^{2e} , with a radiator function, $\kappa(s\,,s),$ where s is the reduced centre-of-mass energy squared $[4]$:

$$
\sigma(s) = \int_{4m_e^2}^s \mathrm{d} s' R(s',s) \ \sigma_{\mathrm{ee}}^{\mathrm{Born}}(s') \ .
$$

The unconvoluted Bhabha cross section at a reduced centre-of-mass energy is extracted by measuring the differential cross section of initial-state radiation:

$$
\frac{\mathrm{d}\sigma}{\mathrm{d}s'}=R(s',s)\,\sigma^{\scriptscriptstyle\mathrm{Born}}_{\mathrm{ee}}(s')\;.
$$

The cross section of quasi-real Compton scattering is described by a similar convolution given by [5]:

$$
\frac{\mathrm{d}\sigma}{\mathrm{d}s'} = f_{\gamma e}(s',s) \sigma_{\gamma e}^{\text{QED}}(s') .
$$

At lowest order, $\mathcal{O}(\alpha^2)$, the Compton cross section at Born-level, $\sigma_{\gamma e}^{\gamma - \alpha}$, is folded with the equivalent photon spectrum, $f_{\gamma e}$. The $\sqrt{s'}$ spectrum of the selected events is then used to measure the unconvoluted Compton cross section at a reduced centre-of-mass energy.

In the following the analysis of the L3 data taken at the Z resonance and at energies up to 183 GeV is described and the measurement of the total and the differential cross sections of Bhabha and Compton scattering are presented.

The Compton scattering process in particular is sensitive to the production of an on-shell excited electron, e ? , decaying into an electron-photon pair. The measurements are used to derive upper fimits on the e e γ coupling for masses of the excited electron almost up to the γ centre-of-mass energy of the e+e - collision, covering a mass range from 20 GeV to 170 GeV.

Analysis Techniques

Electron Photon Identication

The L3 detector and its performance is described elsewhere [6]. The program BHAGENE3 [7] is used to simulate Bhabha scattering. The Monte Carlo prediction of Compton scattering is based on Monte Carlo events generated with the program TEEGG [8], taking into account

corrections of order $\mathcal{O}(\alpha^4)$. The following Monte Carlo event generators are used to simulate the various background reactions: N ORALZ [9] (e+e \rightarrow τ + τ (γ)), GGG [10] (e+e \rightarrow $\gamma\gamma$ (γ)) and DIAG30 ± 1 (e+e \rightarrow e+e e+e). The response of the L3 detector is modelled with the GEANT [12] detector simulation program.

The identification of electrons and photons requires clusters in the electromagnetic calorimeter with an energy larger than 2 GeV and consistent with an electromagnetic shower shape. A cluster is defined as an electron, if

- there is a reconstructed track within 5° to the cluster direction in azimuthal angle ϕ ,
• or if more than 20% of the signals expected for an electron are present in the vertex
- chamber within a 1 cm wide road in the $r \phi$ plane centred around the cluster direction.

A cluster is defined as a photon, if

- it is not identified as an electron,
- and the separation to the next electron candidate is larger than 8° .

Reconstruction of the Effective Centre-of-Mass Energy

For three-particle final states the particle momenta are obtained from the measured directions using energy and momentum conservation. Assuming that one undetected particle, either an electron or a photon, is radiated along the beam axis, its energy, E_{mis} , is given by the polar and α and α and α of the detected particles:

$$
E_{\rm mis} = \sqrt{s} \frac{|\sin(\theta_1 + \theta_2)|}{\sin \theta_1 + \sin \theta_2 + |\sin(\theta_1 + \theta_2)|} \,. \tag{1}
$$

In this case, the energies of the scattered particles, E_1^+ and $E_2^-,$ are also determined by the polar angles:

$$
E_{1,2}^{a} = \sqrt{s} \frac{\sin(\theta_{2,1})}{\sin \theta_1 + \sin \theta_2 + |\sin(\theta_1 + \theta_2)|} \tag{2}
$$

The effective centre-of-mass energy of the hard scattering process is calculated using the energy of the missing particle:

$$
s' = s \left(1 - 2 \frac{E_{\text{mis}}}{\sqrt{s}} \right) \tag{3}
$$

This procedure improves the resolution on ^s 0 as compared to the direct energy measurement. This is particularly important for data taken at $\sqrt{s} \approx m_Z$ where the radiative part of the cross section is small.

The interpretation of the reconstructed $\sqrt{s'}$ as the effective centre-of-mass energy after initial-state radiation is valid to the extent that interference effects between initial and final state radiation are negligible. The interference effects on Bhabha scattering are studied using the program TOPAZ0 [13]. They are found to be less than 0.05% of the total cross section for radiative events and are therefore negligible.

Bhabha Scattering with Initial-State Radiation

Event Selection

The selection of Bhabha scattering events requires two identified electrons inside the polar angular range of $|\cos \theta| < 0.72$. The particle energies, E, measured in the calorimeter are compared to the values, E^{π} , reconstructed from the polar angles of the two electrons using Equation 2. For the particle with the higher energy, E_1 , a cut on the ratio, $E_1/E_1^* > 0.85$, is used to reduce background mainly coming from tau-pair production. Distributions of this ratio are shown in Figures 2a and 2b with further cuts applied as described below.

For events with a three particle final-state, where one of the particles escapes along the beam axis, the two particles detected in the calorimeter should be back-to-back in the $r - \phi$ plane. Therefore, the two detected particles are required to have an acoplanarity angle of less than 3° .

Final state radiation can change the polar angle of the emitting electron and may cause a wrong reconstruction of the effective centre-of-mass energy. Events containing a third electromagnetic cluster with an energy larger than 2 GeV and an angular separation of more than 8[°] from any of the two identified electrons are therefore removed.

Events with a reduced energy, $\sqrt{s'/s}$ < 0.95, are used for further analysis. The fraction of the scattering basic radiative Bhabha scattering pass this cut amounts to 2.0% for the data taken taken to at the Z resonance. This fraction varies from 18% to 14% for centre-of-mass energies between 130 GeV and 183 GeV. Figure 3 shows the resulting $\sqrt{s'}$ -distributions for Bhabha scattering at the different centre-of-mass energies. Good agreement between data and the Monte Carlo prediction is observed. The distributions are combined to determine the total cross sections at reduced centre-of-mass energies.

Total Cross Sections

The data sample was recorded in the years 1991 to 1997 and corresponds to a total integrated luminosity of 232.2 pb¹, including a luminosity of 88.3 pb¹ recorded at energies between 130 GeV and 183 GeV. The luminosities recorded at the various centre-of-mass energies and the number of selected events are listed in Table 1. The sample contains in total 2856 radiative Bhabha events with a reconstructed $\sqrt{s'}$ value between 35 GeV and 175 GeV. They are used to measure cross sections in 11 bins of $\sqrt{s'}$.

The Born cross section at an effective centre-of-mass energy is measured by scaling the theoretical cross section, $\sigma_{\rm ee}^{\rm ee}$, with the ratio between the number of selected events, $N_{\rm ee},$ corrected for the expected background, N_bg , and the Monte Carlo prediction for Bhabha scattering, $N_{\rm ee}$:

$$
\sigma(\langle \sqrt{s'} \rangle) = \sigma_{\rm ee}^{\rm Born}(\langle \sqrt{s'} \rangle) \frac{N_{\rm ee} - N_{\rm bg}^{\rm MC}}{N_{\rm ee}^{\rm MC}} \ . \tag{4}
$$

The value $\langle \sqrt{s'} \rangle$ is the mean of the reconstructed effective centre-of-mass energies of the data in the corresponding energy bin. The background contribution from tau-pair production amounts to 2.0% of the remaining sample. The background contributions from the processes $e^+e^-\to$ e e e e and e e \rightarrow $\gamma\gamma$ (γ) are found to be less than 0.1% and are therefore negligible.

The number of selected events, N_{ee} , and the cross sections for the 11 different energy bins are listed in Table 2. The quoted systematic errors account for the limited Monte Carlo statistics. Other systematic errors are negligible.

The results are shown in Figure 4a and compared to the improved Born calculation. The measurements are in good agreement with the theoretical prediction. Also shown are our inclusive cross section measurements near and above the Z-pole energy [14]. They are corrected for the effect of initial-state radiation using the program TOPAZ0.

Differential Cross Section

The scattering angle, σ , of the electron, e., in the centre-of-mass system is given by:

$$
\cos \theta^* = \frac{\sin(\theta_{e^+} - \theta_{e^-})}{\sin \theta_{e^+} + \sin \theta_{e^-}}.
$$

Electron and positron are distinguished using the charge information from the central tracking system. Since Bhabha scattering is dominated by t-channel photon exchange for centre-of-mass energies well below the Z resonance, the shape of the angular distribution is insensitive to the energy. Therefore, all events selected with an effective centre-of-mass energy between 40 GeV and 80 GeV are combined to measure the differential cross section. Each cross section point is determined by comparing the number of observed events with the Monte Carlo prediction:

$$
\frac{d\sigma}{d\cos\theta^*} = \frac{d\sigma_{ee}^{\text{Born}}}{d\cos\theta^*} \cdot \frac{N_{ee} - N_{bg}^{\text{MC}}}{N_{ee}^{\text{MC}}} \tag{5}
$$

The results are shown in Figure 4b. The preference for forward scattering of the e due to the dominant t-channel exchange is clearly observed and in agreement with expectations.

Compton Scattering of Quasi-Real Photons

Event Selection

In case of quasi-real Compton scattering one of the incoming beam electrons remains inside the beam pipe and is not detected. The energy depositions in the calorimeter are caused by the Compton scattered electron and photon.

For the selection of Compton scattering events both electron and photon are required to be observed within $|\cos \theta|$ < 0.94. The scattering angle in the centre-of-mass system of the γe pair has to he inside $|\cos \theta| < 0.8$ to reduce the contribution from low angle Bhabha scattering.

The ratio E_1/E_1 is required to be greater than 0.7. All events containing a third electro-1magnetic cluster with an energy larger than 2 GeV and an angular separation of more than δ -from the identified electron are removed. To ensure the selection of quasi-real photons, the transverse momentum of the final state system has to be lower than 15% of the beam energy. This cut restricts the momentum transfer to the photon, suppressing the contribution from offshell photons. The photons of the remaining sample have an average Q^2 between 2 GeV² and 9 GeV² dependent on the centre-of-mass energy resulting in a small average virtuality Q^2/s' of the order 10^{-3} .

Higher background contributions are expected when the effective centre-of-mass energy is close to \sqrt{s} from either photon conversion in the reaction $e^+e^- \rightarrow \gamma\gamma(\gamma)$ in case that the two resulting tracks are not resolved or from Bhabha scattering if one track is lost. To remove these backgrounds the energy of the lower energetic cluster of the γe pair, E_2 , is required to be less than 85% of the beam energy. The beam energy is the distributions of E2=Ebeam are shown in Figures 2c and α

2d. Figure 5 shows the resulting $\sqrt{s'}$ -distributions for Compton scattering which are found to be in good agreement with the Monte Carlo expectations. The total cross sections at reduced centre-of-mass energies are derived from the combined distributions.

Total Cross Sections

In total 4641 candidates for Compton scattering are selected from the data sample. The total cross sections are calculated as in the analysis of Bhabha scattering (Equation 4) rescaling the theoretical cross section, $\sigma_{\gamma e}^{\infty}$, determined from the QED calculation. The background contributions from Bhabha scattering and from the process $e^+e^-\to \gamma\gamma(\gamma)$ are found to be less than 0.5% of the expected events.

Table 3 contains the numbers of selected events, $N_{\gamma e}$, and the measured total cross sections of Compton scattering for 10 different $\sqrt{s'}$ bins. The quoted systematic error is dominated by the limited Monte Carlo statistics. Figure 6a shows the results compared with the QED prediction for the Compton scattering cross section. The measurements are in good agreement with the theoretical prediction.

Differential Cross Section

The scattering angle, σ , of the photon in the centre-of-mass system is given in the case of γe scattering by:

$$
\cos \theta^* = \frac{\sin(\theta_{\rm e^-} - \theta_\gamma)}{\sin \theta_{\rm e^-} + \sin \theta_\gamma}.
$$

Since the polar angles θ_{γ} and θ_{e^-} are measured with respect to the direction of the incoming electron (e), the scattering angle is defined by $\pi-\theta^+$ in case of γ e+ scattering.

Combining all energy bins from 20 GeV to 80 GeV the differential cross section of Compton scattering is derived. The results are shown in Figure 6b. The measurement exhibits the preference for backward scattering in the centre-of-mass system, which is characteristic for unpolarized Compton scattering.

Production of Single Excited Electrons

 \rm{M} odels including excited leptons [15] predict that the production of excited electrons in e+e \rm{m} collisions is extremely peaked in the forward direction. Therefore, the electron in the process $e^+e^- \to e^+e^-$ can be lost in the beam pipe whereas the γe decay products of the excited electron would be seen inside the detector. Consequently, an exclusion limit on the production of excited electrons can be derived from the measurement of Compton scattering.

 N ithin the theoretical model for excited leptons, the coupling $e^+e^- \gamma$ is described by one γ dimensionless parameter λ [16]. The cross section for the production of an excited electron e $^\circ$ in electron-photon collisions, decaying into an γe pair is then given by [17]:

$$
\sigma(\mathbf{e}\,\gamma \to \mathbf{e}^{\star} \to \mathbf{e}\,\gamma)(m_{\mathbf{e}^{\star}}) = \frac{4\pi^2\alpha\,\lambda^2}{m_{\mathbf{e}^{\star}}^2} \frac{\Gamma(\mathbf{e}^{\star} \to \mathbf{e}\,\gamma)}{\Gamma_{\mathbf{e}^{\star}}}.
$$

This expression is valid assuming a narrow width for the excited electron. The partial width for the radiative decay is given by [17]:

$$
\Gamma(e^* \to e \gamma) = \frac{1}{2} \lambda^2 \alpha m_{e^*} .
$$

The total width, I_{e^*} , also takes into account the partial widths for the decays $e \rightarrow \nu W$ and $e^a \rightarrow e$ z for masses $m_{e^{\star}}$ above the masses of the W and Z bosons [18].

Within an interval $m_{e^*} \pm \Delta$, the number of observed γ e pairs and the expected contribution from Compton scattering, $N_{\gamma e}$, are determined. These numbers are used to calculate the 95% condence level upper limit for the number of events that could come from such a narrow e resonance, $N_{\rm e\star}$. The interval width Δ is chosen as twice the invariant mass resolution of typically 1%. Taking into account the expected angular distribution in the e ? rest frame [15],

$$
\frac{1}{\sigma} \frac{d\sigma}{d\cos\theta} = \frac{1 + \cos\theta}{2} ,
$$

the upper limit for the coupling λ is determined by satisfying the inequality

$$
\frac{N_{\rm e^{\star}}}{N_{\gamma \rm e}} \sigma_{\gamma \rm e}^{\rm QED}(m_{\rm e^{\star}}) > \frac{\epsilon_{\rm e^{\star}}}{\epsilon_{\gamma \rm e}} \frac{\pi^2 \alpha \lambda^2}{2 m_{\rm e^{\star}} \Delta} \left(c_{\rm max} - c_{\rm min} + \frac{c_{\rm max}^2 - c_{\rm min}^2}{2} \right) \frac{\Gamma(\rm e^{\star} \to \rm e \, \gamma)}{\Gamma_{\rm e^{\star}}}.
$$

This uses the QED prediction for the Compton scattering cross section, $\sigma_{\gamma e}^2$, at an enective centre-of-mass energy given by the mass m_{e^*} . The limit on the coupling parameter λ takes into account the emclencies $\epsilon_{\rm e^{\star}}$ and $\epsilon_{\gamma{\rm e}}$ and the acceptance cuts in the e^ rest frame, $c_{\rm min} < \cos \sigma <$

 $c_{\text{max}}.$ The result is shown in Figure 7. A comparable limit has been derived from our dedicated search for excited electrons based on data collected at energies up to 161 GeV [19]. For comparison, the upper limit for the e^e γ coupling from our analysis of the QED reaction e+e \rightarrow $\gamma\gamma(\gamma)$ is also shown $|20|$. From our analysis of the pair production e^+e^- in the channel $e^-\gamma\gamma$, a lower mass limit of 79.7 GeV at 95% condence level is derived [19]. The results from previous experiments using the process of quasi-real Compton scattering at e+ e colliders [21] and the upper limits from the experiments at the HERA ep collider [22] are included for comparison.

Conclusions

The effect of initial-state radiation in the reaction $e^+e^- \rightarrow e^+e^-$ (γ) is studied. The selected events are used to measure Bhabha scattering at effective centre-of-mass energies between 50 GeV and 170 GeV. The measurements show good agreement with the Standard Model predictions.

Electron-photon events are identied as Compton scattering of quasi-real photons. We measure this process in the centre-of-mass energy range from 20 GeV to 140 GeV which is the highest energy at which Compton scattering has been studied so far. The total rate and the observed differential cross sections are in good agreement with the theoretical expectations.

An upper limit for a hypothetical coupling e e γ as a function of m_{e^\star} is derived from the measurement of Compton scattering. No indications for the existence of an excited electron are found in the data. The 95% confidence level limit on the coupling parameter λ is of the order 10 \degree to 10 \degree for the mass region 20 GeV $< m_{\rm e^{\star}} <$ 170 GeV.
