

First-Order Sequent Calculi of Logics of Quasiary Predicates with Extended Renominations and Equality

Abstract

The paper considers new classes of software-oriented logical formalisms – pure first-order logics of partial quasiary predicates with extended renominations and predicates of strong equality and of weak equality, denoted respectively $L_i^{Q=}$ and $L_i^{Q\neq}$. The characteristic features of the studied logics are using of composition of extended renomination, and special 0-ary predicate compositions that detect if the subject variables or predicates of equality have assigned values. We specify two kinds of equality predicates: the predicate of weak (up to definedness) equality $=_{xy}$, and the predicate of strong equality \equiv_{xy} . For the considered logics, main properties of their compositions are given, their languages are described, and various variants of logical consequence relations are defined. For the language $L_i^{Q=}$ we obtain only one correct relation $\overset{P}{|}=\!_{IR}$, at the same time for $L_i^{Q\neq}$ we have relations $\overset{P}{|}=\!_{IR}$, $\overset{P}{|}=\!_T$, $\overset{P}{|}=\!_F$, $\overset{P}{|}=\!_{TF}$, $\overset{R}{|}=\!_{TF}$. We describe properties of the introduced relations, paying special attention to those connected with equality predicates. As sequent calculi formalise logical consequence relations for sets of formulas, properties of the latter become the semantic basis for construction of the respective calculi. Thus, for $\overset{P}{|}=\!_{IR}$ we get calculus $C_i^{Q=IR}$; relations $\overset{R}{|}=\!_{TF}$, $\overset{P}{|}=\!_{TF}$, $\overset{P}{|}=\!_T$, $\overset{P}{|}=\!_F$, and $\overset{P}{|}=\!_{IR}$ induce calculi $C_i^{Q\neq TFR}$, $C_i^{Q\neq TF}$, $C_i^{Q\neq T}$, $C_i^{Q\neq F}$, and $C_i^{Q\neq IR}$ respectively. We specify basic sequent forms (rules) for the presented calculi, and conditions for sequent closedness. Description of the derivation procedure via sequent tree is given, using of rules concerning equality predicates explained. The counter-model existence theorems are considered; on the example of calculus $C_i^{Q\neq TFR}$ we illustrate a counter-model construction by an unclosed path in the sequent tree. For the introduced calculi, the soundness and completeness theorems are proved; the proof of the completeness theorems is based on construction of the respective counter-models.

1. Introduction

Methods of mathematical logic have proved to be effective in various applications in computer science and programming. Many different logic systems have been created (see, for example, [1,2]); usually the classical logic of predicates [3] and special logics based on it are employed for this purpose. At the same time, classical logic has fundamental limitations [4], which complicate its use. This brings to the fore the problem of building new, software-oriented logics. Such are logics, built on the basis of a compositional-nominative approach common for logic and programming – composition-nominative logics of partial quasiary predicates (CNL). A number of different classes of CNL are described in, for example, [4–10]. This work is dedicated to studying of new classes of CNL – pure first-order logics of partial quasiary predicates with extended renominations and equality; for such logics various variants of calculi of sequent type are proposed. Gentzen-style sequent calculi provide

efficient proof searching procedures to solve a number of problems that arise in information and software systems.

Pure first-order logics of quasiary predicates (PCNL) are called L^Q (logics of quantifier level). PCNL with extended renominations are called \perp PCNL, and also L_{\perp}^Q ; PCNL with predicates of strong equality and weak equality are called $L_{\perp}^{Q=}$ and $L_{\perp}^{Q\neq}$ respectively; \perp PCNL with predicates of strong equality and weak equality are called $L_{\perp}^{Q=}$ and $L_{\perp}^{Q\neq}$ respectively. PCNL and their calculi are described in [4, 5, 11]; \perp PCNL and their calculi are introduced in [6, 12]; L^Q and $L^{Q=}$ are investigated in [7, 8]; free-quantifier composition renominative logics with extended renominations and equality predicates are studied in [9, 10].

The purpose of this work is to investigate logical consequence relations in $L_{\perp}^{Q=}$ and $L_{\perp}^{Q\neq}$, and to construct their sequent calculi. These calculi generalize sequent calculi both for \perp PCNL [12], L^Q and $L^{Q=}$ [7]. For the constructed calculi, we specify basic sequent forms (rules) and sequent closedness conditions. The soundness and completeness theorems are proved; the proof of the completeness theorems is based on the counter-model existence theorems.

2. Composition predicate algebras of logics $L_{\perp}^{Q=}$ and $L_{\perp}^{Q\neq}$.

To facilitate reading, we provide the necessary definitions for further presentation. Concepts that are not defined in this paper are interpreted in the sense of [5, 8, 12].

Let ${}^V A$ be a set of all V - A -nominative sets and $\{T, F\}$ is a set of Boolean values. We define V - A -quasiary predicate as a partial many-valued function $Q : {}^V A \rightarrow \{T, F\}$.

Let V be a set of names (variables) and A be a set of values. V - A -nominative set is defined [4, 5] as a partial single-valued function $d : V \rightarrow A$. Nominative sets can be presented in the form $[v_1 \mapsto a_1, \dots, v_n \mapsto a_n, \dots]$, where $v_i \in V$, $a_i \in A$, $v_i \neq v_j$ when $i \neq j$.

For nominative sets we define set theory operations \cap and \setminus , and parametric operations $\|Z$ and $\|_{-Z}$ [4, 5] $\|_{-Z}$ for components with names from $Z \subseteq V$:

$$d \| Z = \{v \ a \ a \in d \mid v \in Z\}; \quad d \|_{-Z} = \{v \ a \ a \in d \mid v \notin Z\}.$$

The parametric operation of extended renomination $\Gamma_{x_1, \dots, x_n, u_1, \dots, u_m}^{\perp} : {}^V A \rightarrow {}^V A$, where $v_i, x_i, u_j \in V$, is specified as $\Gamma_{x_1, \dots, x_n, u_1, \dots, u_m}^{\perp}(d) = d \|_{-\{v_1, \dots, v_n, u_1, \dots, u_m\}} \cup [v_1 \ a \ d(x_1), \dots, v_n \ a \ d(x_n)]$. In particular, $\Gamma^{ua \ \perp}(d) = d \|_{-u}$.

We use a special symbol $\perp \notin V$ that denotes the absence of the variable value; $d(x_i) \uparrow$ means that a component with the name v_i is absent.

A simpler notation for sequences y_1, \dots, y_n will be used: \bar{y} . Thus, instead of $\Gamma_{x_1, \dots, x_n, u_1, \dots, u_m}^{\perp}$, we will write $\Gamma_{\bar{x}, \perp}^{\bar{u}}$.

Given $d(z) \uparrow$, we obtain $\Gamma_{\bar{x}, \perp, z}^{\bar{u}, y}(d) = \Gamma_{\bar{x}, \perp, \perp}^{\bar{u}, y}(d)$ and $\Gamma_{\bar{x}, \perp, \perp}^{\bar{u}, z}(d) = \Gamma_{\bar{x}, \perp}^{\bar{u}}(d)$.

Successive renominations $\Gamma_{\bar{x}, \bar{a}, \perp, \perp}^{\bar{u}, \bar{s}, \bar{w}, \bar{t}}$ and $\Gamma_{\bar{y}, \bar{c}, \perp, \perp}^{\bar{v}, \bar{s}, \bar{z}, \bar{t}}$ can be represented [6] by one renomination denoted $\Gamma_{\bar{x}, \bar{a}, \perp, \perp}^{\bar{u}, \bar{s}, \bar{w}, \bar{t}} \circ \Gamma_{\bar{y}, \bar{c}, \perp, \perp}^{\bar{v}, \bar{s}, \bar{z}, \bar{t}}$; we call it the *convolution* of $\Gamma_{\bar{x}, \bar{a}, \perp, \perp}^{\bar{u}, \bar{s}, \bar{w}, \bar{t}}$ and $\Gamma_{\bar{y}, \bar{c}, \perp, \perp}^{\bar{v}, \bar{s}, \bar{z}, \bar{t}}$. For any $d \in {}^V A$ we get $\Gamma_{\bar{x}, \bar{a}, \perp, \perp}^{\bar{u}, \bar{s}, \bar{w}, \bar{t}} \circ \Gamma_{\bar{y}, \bar{c}, \perp, \perp}^{\bar{v}, \bar{s}, \bar{z}, \bar{t}}(d) = \Gamma_{\bar{p}, \bar{q}, \bar{y}, \perp, \perp, \perp}^{\bar{u}, \bar{s}, \bar{v}, \bar{w}, \bar{z}, \bar{t}}(d)$.

In this work we construct sequent calculi for logics of many-valued (non-deterministic) predicates of *relational* type (R -predicates): R -predicates are interpreted as mappings (relations) from ${}^V A$ to $\{T, F\}$. Each R -predicate Q is unequivocally defined by two sets: its *truth* domain $T(Q) = \{d \mid T \in Q(d)\}$ and *falsity* domain $F(Q) = \{d \mid F \in Q(d)\}$, where $Q(d)$ denotes the set of values which Q assumes on argument $d \in {}^V A$.

A name $x \in V$ is *unessential* for R -predicate Q , if for any $d_1, d_2 \in {}^V A$ we have: $d_1 \|_{-x} = d_2 \|_{-x} \Rightarrow Q(d_1) = Q(d_2)$.

V - A -quasiary R -predicate Q is:

- partial single-valued, or P -predicate, if $T(Q) \cap F(Q) = \emptyset$;
- total, or T -предикат, if $T(Q) \cup F(Q) = {}^V A$;
- total single-valued, or TS -predicate, if $T(Q) \cap F(Q) = \emptyset$ and $T(Q) \cup F(Q) = {}^V A$;

- irrefutable, or partially true, if $F(Q) = \emptyset$; all irrefutable predicates are P -predicates;
- totally true (denoted T), if $F(Q) = \emptyset$ and $T(Q) = V_A$;
- totally false (denoted F), if $T(Q) = \emptyset$ and $F(Q) = V_A$;
- totally undefined (denoted \perp), if $T(Q) = F(Q) = \emptyset$;
- totally ambivalent (denoted Υ), if $T(P) = F(P) = V_A$;
- monotonic, if $d_1 \subseteq d_2 \Rightarrow Q(d_1) \subseteq Q(d_2)$; antitonic, if $d_1 \subseteq d_2 \Rightarrow Q(d_1) \supseteq Q(d_2)$.

We will denote classes of V - A -quasiary R -predicates, P -predicates, T -predicates and TS -predicates Pr^{V-A} , PrP^{V-A} , PrT^{V-A} and $PrTS^{V-A}$ respectively. The class $PrTS^{V-A}$ is degenerate: all TS -predicates, except constant T and F, are non-monotonic.

Considering the duality of classes PrP^{V-A} and PrT^{V-A} , and the degeneracy of $PrTS^{V-A}$ [5], it is enough to concentrate on logics of R -predicates and P -predicates, whence the following \perp PCNL classes:

- L_{\perp}^Q and L_{\perp}^{QP} – \perp PCNL of R -predicates and \perp PCNL of P -predicates;
- $L_{\perp}^{Q=}$ and $L_{\perp}^{Q=P}$ – \perp PCNL of R -predicates with weak equality and \perp PCNL of P -predicates with weak equality;
- L_{\perp}^Q and $L_{\perp}^{Q.P}$ – \perp PCNL of R -predicates with strong equality and \perp PCNL of P -predicates with strong equality.

A tuple (V_A, Pr^{V-A}, C_B) , where C_B is a set of basic compositions, is called a composition predicate system; it forms a semantic basis for CNL. Each such system defines a data algebra (V_A, Pr^{V-A}) and a composition predicate algebra (Pr^{V-A}, C_B) .

Sets of basic compositions for different classes of \perp PCNL are introduced as follows: $C_{L_{\perp}^Q} = \{\neg, \vee, R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}, \exists x, Ex\}$ for L_{\perp}^Q and L_{\perp}^{QP} , $C_{L_{\perp}^{Q=}} = C_{L_{\perp}^Q} \cup \{=\}_{\{x,y\}}$ for $L_{\perp}^{Q=}$ and $L_{\perp}^{Q=P}$, $C_{L_{\perp}^Q} = C_{L_{\perp}^Q} \cup \{=\}_{\{x,y\}}$ for L_{\perp}^Q and $L_{\perp}^{Q.P}$. Let us specify the basic compositions.

Logical connectives \neg and \vee are defined by the truth and falsity domains of the respective predicates:

$$T(\neg P) = F(P); \quad F(\neg P) = T(P); \quad T(P \vee Q) = T(P) \cup T(Q); \quad F(P \vee Q) = F(P) \cap F(Q).$$

We specify the composition of extended renomination $R_{\bar{x}, \perp}^{\bar{v}, \bar{u}} : Pr^{V-A} \text{ } \mathbb{A} \text{ } Pr^{V-A}$ as follows:

$$R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}(P)(d) = P(r_{\bar{x}, \perp}^{\bar{v}, \bar{u}}(d)).$$

A convolution of the renomination compositions is defined by a convolution of the corresponding renomination operations:

$$R_{\bar{y}, \perp}^{\bar{v}, \bar{t}} \circ R_{\bar{x}, \perp}^{\bar{u}, \bar{t}}(P)(d) = (R_{\bar{y}, \perp}^{\bar{v}, \bar{t}}(R_{\bar{x}, \perp}^{\bar{u}, \bar{t}}(P)))(d) = P(r_{\bar{x}, \perp}^{\bar{u}, \bar{t}} \circ r_{\bar{y}, \perp}^{\bar{v}, \bar{t}}(d)).$$

We define the quantifier (composition of quantification) $\exists xP : Pr^{V-A} \text{ } \mathbb{A} \text{ } Pr^{V-A}$ as follows:

$$T(\exists xP) = \bigcup_{a \in A} \{d \mid d \downarrow_{-x} \cup x \text{ a } a \in T(P)\}; \quad F(\exists xP) = \bigcap_{a \in A} \{d \mid d \downarrow_{-x} \cup x \text{ a } a \in F(P)\}.$$

A 0-ary predicate Ez indicates whether a component $z \in V$ has a value on a given data [5]:

$$T(Ez) = \{d \mid d(z) \downarrow\}; \quad F(Ez) = \{d \mid d(z) \uparrow\}.$$

Predicates Ez are total, single-valued, and non-monotonic. Each $x \in V$ such that $x \neq z$, is unessential for Ez .

Predicates of weak equality (up to definedness) $=_{\{x,y\}}$ are specified as follows [7]:

$$T(=_{\{x,y\}}) = \{d \mid d(x) \downarrow, d(y) \downarrow \text{ and } d(x) = d(y)\}; \\ F(=_{\{x,y\}}) = \{d \mid d(x) \downarrow, d(y) \downarrow \text{ and } d(x) \neq d(y)\}.$$

Predicates of strong equality $\equiv_{\{x,y\}}$ are defined as follows [7]:

$$T(\equiv_{\{x,y\}}) = \{d \mid d(x) \downarrow, d(y) \downarrow \text{ and } d(x) = d(y)\} \cup \{d \mid d(x) \uparrow \text{ and } d(y) \uparrow\}; \\ F(\equiv_{\{x,y\}}) = \{d \mid d(x) \downarrow, d(y) \downarrow \text{ and } d(x) \neq d(y)\} \cup \{d \mid d(x) \downarrow, d(y) \uparrow \text{ or } d(x) \uparrow, d(y) \downarrow\}.$$

We will further denote the predicates $=_{\{x,y\}}$ and $\equiv_{\{x,y\}}$ as $=_{xy}$ and \equiv_{xy} respectively; note that such predicates are traditionally denoted as $x = y$ and $x \equiv y$.

Predicates \equiv_{xy} are total single-valued, non-monotonic and non-antitonic. Every name $z \in V \setminus \{x, y\}$ is unessential for $\equiv_{\{x,y\}}$.

Predicates $=_{xy}$ are partial single-valued and monotonic (equitone). Every name $z \in V \setminus \{x, y\}$ is unessential for $=_{\{x,y\}}$.

The special case for $=_{\{x,y\}}$ and $\equiv_{\{x,y\}}$ is the situation, when x and y represent the same name; the

corresponding predicates $=_{\{x\}}$ and $\equiv_{\{x\}}$ will be denoted as $=_{xx}$ and \equiv_{xx} (in traditional form $x=x$ and $x \equiv x$). Every name $z \in V \setminus \{x\}$ is unessential for $=_{xx}$ and \equiv_{xx} .

For predicate \equiv_{xx} we have $T(\equiv_{xx}) = {}^V A$ and $F(\equiv_{xx}) = \emptyset$, whence $\equiv_{xx} = T$. For predicate $=_{xx}$ we have $F(=_{xx}) = \emptyset$, whence $=_{xx}$ is irrefutable.

Thus, the following predicate composition algebras of \downarrow PCNL can be specified:

- $A_i^Q = ({}^V A, Pr^{V-A}, C_{\perp Q})$ and $A_i^{QP} = ({}^V A, PrP^{V-A}, C_{\perp Q})$, wherein A_i^{QP} is a subalgebra of A_i^Q ;
- $A_i^{Q=} = ({}^V A, Pr^{V-A}, C_{\perp Q=})$ and $A_i^{Q=P} = ({}^V A, PrP^{V-A}, C_{\perp Q=})$, wherein $A_i^{Q=P}$ is a subalgebra of $A_i^{Q=}$;
- $A_i^{Q\cdot} = ({}^V A, Pr^{V-A}, C_{\perp Q\cdot})$ and $A_i^{Q\cdot P} = ({}^V A, PrP^{V-A}, C_{\perp Q\cdot})$, wherein $A_i^{Q\cdot P}$ is a subalgebra of $A_i^{Q\cdot}$.

The main properties of the \downarrow PCNL compositions. Properties of propositional compositions and quantifiers, unrelated to renominations, correspond to those of classical logical connectives and quantifiers [4, 5].

Let us specify basic simplification properties for the composition of extended renomination:

- R_iI) $R_{z, \bar{x}, \perp}^{z, \bar{v}, \bar{u}}(P) = R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}(P)$ – identical renomination can be eliminated;
- R_iU) $z \in V$ is unessential for predicate $P \Rightarrow R_{y, \bar{x}, \perp}^{z, \bar{v}, \bar{u}}(P) = R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}(P)$;
- R_i↑) given $d(z) \uparrow$ we have $R_{\bar{x}, \perp, z}^{\bar{v}, \bar{u}, y}(P)(d) = R_{\bar{x}, \perp, \perp}^{\bar{v}, \bar{u}, y}(P)(d)$ and $R_{\bar{x}, \perp, \perp}^{\bar{v}, \bar{u}, z}(P)(d) = R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}(P)(d)$;
- R_iE) $R_{\bar{x}, \perp, y}^{\bar{v}, \bar{u}, z}(Ez) = Ey$; given $z \notin \{\bar{v}, \bar{u}\}$ we have $R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}(Ez) = Ez$.

Properties related to renomination R, R_iR, R_i¬, R_i∨ and quantification compositions are given in [6, 9, 12].

Let us consider properties of equality predicates. Note that the symmetric property of equality lies within notation, as pairs \equiv_{xy} and \equiv_{yx} , $=_{xy}$ and $=_{yx}$ are essentially the same predicates.

We define the reflexivity properties as follows:

- Rf₌) each predicate $=_{xx}$ is irrefutable; moreover, $=_{xx}$ can be denoted as $=_{xx} = Ex \vee$;
- Rf_≡) each predicate \equiv_{xx} is totally true, i.e. $\equiv_{xx} = T$.

The transitivity properties are specified as follows:

Tr₌) for all $d \in {}^V A$ we have: $=_{xy}(d) = T$ and $=_{yz}(d) = T \Rightarrow =_{xz}(d) = T$; whence $=_{xy} \& =_{yz} \rightarrow =_{xz}$ is irrefutable.

Tr_≡) for all $d \in {}^V A$ we have: $\equiv_{xy}(d) = T$ and $\equiv_{yz}(d) = T \Rightarrow \equiv_{xz}(d) = T$; whence $\equiv_{xy} \& \equiv_{yz} \rightarrow \equiv_{xz} = T$.

Let us consider properties of renominations for weak equality predicates (properties of the type R_i=):

- R_i=_{xx}) $R_{\bar{w}, \perp, z}^{\bar{v}, \bar{u}, x}(=_{xx}) = =_{zz}$; R_i=₂) $R_{\bar{w}, \perp, z, s}^{\bar{v}, \bar{u}, x, y}(=_{xy}) = =_{zs}$;
- R_i=₁) given $y \notin \{\bar{u}, \bar{v}\}$, $x \neq y$ we have $R_{\bar{w}, \perp, z}^{\bar{v}, \bar{u}, x}(=_{xy}) = =_{zy}$;
- R_i=₀) given $x, y \notin \{\bar{u}, \bar{v}\}$ we have $R_{\bar{w}, \perp}^{\bar{v}, \bar{u}}(=_{xy}) = =_{xy}$; in particular, given $x \notin \{\bar{u}, \bar{v}\}$ we have $R_{\bar{w}, \perp}^{\bar{v}, \bar{u}}(=_{xx}) = =_{xx}$;
- R_i=₁) $R_{\bar{w}, \perp, \perp}^{\bar{v}, \bar{u}, x}(=_{xy}) =$; in particular, $R_{\bar{w}, \perp, \perp}^{\bar{v}, \bar{u}, x}(=_{xx}) =$.

For weak equality predicates we have properties of substitution of equals and elimination of pair of equals in renominations:

=eR_i) for all $P \in PrP^{V-A}$ and $d \in {}^V A$ we have: $=_{xy}(d) = T \Rightarrow R_{\bar{w}, \perp, y}^{\bar{v}, \bar{u}, x}(P)(d) = R_{\bar{w}, \perp}^{\bar{v}, \bar{u}}(P)(d)$.

Properties of renominations for strong equality predicates (properties of the type R_i≡):

- R_i≡_{xx}) $R_{\bar{w}, \perp, z}^{\bar{v}, \bar{u}, x}(\equiv_{xx}) = \equiv_{zz}$; R_i≡₂) $R_{\bar{w}, \perp, z, s}^{\bar{v}, \bar{u}, x, y}(\equiv_{xy}) = \equiv_{zs}$;
- R_i≡_{2E}) $R_{\bar{w}, \perp, z, \perp}^{\bar{v}, \bar{u}, x, y}(\equiv_{xy}) = \neg Ez$;
- R_i≡₁) for all $y \notin \{\bar{u}, \bar{v}\}$, $x \neq y$ we have $R_{\bar{w}, \perp, z}^{\bar{v}, \bar{u}, x}(\equiv_{xy}) = \equiv_{zy}$;

R_{\equiv_0}) for all $x, y \notin \{\bar{u}, \bar{v}\}$ we have $R_{\bar{w}, \perp}^{\bar{v}, \bar{u}}(\equiv_{xy}) = \equiv_{xy}$; in particular, $R_{\bar{w}, \perp}^{\bar{v}, \bar{u}}(\equiv_{xx}) = \equiv_{xx}$ given $x \notin \{\bar{u}, \bar{v}\}$;

R_{\equiv_1}) $R_{\bar{w}, \perp, \perp, \perp}^{\bar{v}, \bar{u}, x, y}(\equiv_{xy}) = T$; in particular, $R_{\bar{w}, \perp, \perp}^{\bar{v}, \bar{u}, x}(\equiv_{xx}) = T$.

Properties of substitution of equals and elimination of pair of equals in renominations for strong equality predicates:

$\equiv_{R_{\equiv_1}}$) for all $P \in PrP^{V-A}$ and $d \in V A$ we have: $\equiv_{xy}(d) = T \Rightarrow R_{\bar{w}, \perp, x}^{\bar{v}, \bar{u}, z}(P)(d) = R_{\bar{w}, \perp, y}^{\bar{v}, \bar{u}, z}(P)(d)$ – substitution of equals;

$\equiv_{eL_{R_{\equiv_1}}}$) for all $P \in PrP^{V-A}$ and $d \in V A$ we have: $\equiv_{xy}(d) = T \Rightarrow R_{\bar{w}, \perp, y}^{\bar{v}, \bar{u}, x}(P)(d) = R_{\bar{w}, \perp}^{\bar{v}, \bar{u}}(P)(d)$.

3. Logical consequence relations for $L_{\perp}^{Q=}$ and L_{\perp}^Q .

Let us describe languages of \perp PCNL. We will concentrate on the language of L_{\perp}^Q , languages of $L_{\perp}^{Q=}$ and L_{\perp}^Q are defined in the similar manner.

An alphabet of the language of L_{\perp}^Q consists of a set of names (variables) V , a set of predicate symbols Ps , and a set of basic compositions' symbols $Cs = \{\neg, \vee, R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}, \exists x, Ex, \equiv_{xy}\}$. We define inductively the set of formulas (denoted Fr):

– each $p \in Ps$, each Ex , and each \equiv_{xy} is a formula; such formulas are called atomic;

– let $\Phi, \Psi \in Fr$; then $\neg\Phi \in Fr$, $\vee\Phi\Psi \in Fr$, $R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}\Phi \in Fr$, $\exists x\Phi \in Fr$.

We specify a set $V_T \subseteq V$ of totally unessential names (unessential for any $p \in Ps$) and extend it [5, 6, 8] to formulas: $\nu : Fr \rightarrow 2^V$ to get a set of *guaranteed* unessential names for formulas.

If $x \in \nu(\Phi)$, then x is unessential for Φ [5, 6].

We call a formula primitive, if it is atomic or has a form $R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}p$, where $p \in Ps$, $\{\bar{v}, \bar{u}\} \cap \nu(p) = \emptyset$ and there are no identical pair of names in $R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}$. Formulas of the form $R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}\Phi$ are called R -formulas.

The set of names $x \in V$ that occur in Φ is denoted $nm(\Phi)$.

For any $\Gamma \subseteq Fr$ we denote: $nm(\Gamma) = \bigcup_{\Phi \in \Gamma} nm(\Phi)$; $\nu(\Gamma) = \bigcap_{\Phi \in \Gamma} \nu(\Phi)$; $fu(\Gamma) = V_T \setminus nm(\Gamma)$.

We interpretate the language of L_{\perp}^Q on composition systems $CS = (V A, Pr^{V-A}, C_{\perp Q})$.

Symbols in Cs are interpreted as corresponding compositions; symbols Ex – as variable assignment predicates Ex ; symbols \equiv_{xy} – as corresponding predicates of strong equality \equiv_{xy} .

We specify a total single-valued mapping $I : Ps \rightarrow Pr^{V-A}$, and extend it to formulas as an interpretation mapping $I : Fr \rightarrow Pr^{V-A}$:

$I(\neg\Phi) = \neg(I(\Phi))$, $I(\vee\Phi\Psi) = \vee(I(\Phi), I(\Psi))$, $I(R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}\Phi) = R_{\bar{x}, \perp}^{\bar{v}, \bar{u}}(I(\Phi))$, $I(\exists x\Phi) = \exists x(I(\Phi))$.

Let the tuple $\mathbf{J} = (CS, \Sigma, I)$, where $\Sigma = (V, V_T, Cs, Ps)$ is an extended signature of the language, be an *interpretation* of the language of L_{\perp}^Q (further shortened to $\mathbf{J} = (A, I)$).

Predicate $I(\Phi)$ is a value of a formula in the interpretation \mathbf{J} (further denoted $\Phi_{\mathbf{J}}$).

Name $x \in V$ is unessential for a formula Φ , if x is unessential for $\Phi_{\mathbf{J}}$ for any interpretation \mathbf{J} .

The language for $L_{\perp}^{Q=}$ is specified in the same manner (changing \equiv_{xy} to $=_{xy}$).

For the language for L_{\perp}^Q we omit everything connected with \equiv_{xy} .

Classes of interpretations of a language are also called *semantics*. Specifying of subalgebras of P -predicates in algebras A_{\perp}^Q , $A_{\perp}^{Q=}$, A_{\perp}^Q leads to the following respective semantics: $\perp\mathbf{R}$ and $\perp\mathbf{P}$, $\perp\mathbf{R}^=$ and $\perp\mathbf{P}^=$, $\perp\mathbf{R}^{\neq}$ and $\perp\mathbf{P}^{\neq}$.

Formula Φ is irrefutable in the interpretation \mathbf{J} (denoted $\mathbf{J} \models \Phi$), if $\Phi_{\mathbf{J}}$ is a irrefutable predicate.

Formula Φ is irrefutable in the semantics α (denoted $\models \Phi$), if $\mathbf{J} \models \Phi$ for any interpretation $\mathbf{J} \in \alpha$.

Formula Φ totally true in the interpretation \mathbf{J} (denoted $\mathbf{J} \models_{id} \Phi$), if $\Phi_{\mathbf{J}}$ is a totally true predicate.

Formula Φ totally true in the semantics α (denoted $\models_{id} \Phi$), if $\mathbf{J} \models_{id} \Phi$ for any interpretation $\mathbf{J} \in \alpha$.

Let us call *constant* formulas that are always interpreted as constant predicates T, F, ... For example, $Ex \vee \neg Ex$, \equiv_{xx} , $\exists xEx$, $R_{\perp, \perp}^{x,z}$ (\equiv_{xz}) are \top -formulas; $R_{\bar{x}, \perp, \perp}^{\bar{y}, \bar{u}, z}$ (Ez) is an \top -formula, $R_{\bar{x}, \perp, \perp}^{\bar{y}, \bar{u}, z}$ (\equiv_{zy}) is a \perp -formula.

Un-equivalent formulas. Let $R_{\bar{x}, \bar{y}, \bar{z}, \perp, \perp}^{\bar{u}, \bar{v}, \bar{w}, z}$ (Φ) be an R -formula, such that $\{\bar{u}, \bar{w}\} \subseteq v(\Phi)$. Let us call an Rs -form of an R -formula $R_{\bar{y}, \perp, \perp}^{\bar{v}, \bar{z}}$ (Φ) the R -formula obtained from $R_{\bar{x}, \perp, \perp}^{\bar{u}, \bar{v}, \bar{z}}$ (Φ) by all possible simplifications of external renomination based on properties R, R.I, R.U, and properties of the type R_{\equiv} .

We will call Rs -formulas Rs -forms of R -formulas. If Θ is an Rs -form of an R -formula Ψ , then $\Theta_J = \Psi_J$ for all J .

Let $Un \subseteq V$ be a set of indefinite names.

Let us call formulas Ψ and Θ *Un-equivalent* (denoted $\Psi \sim_{Un} \Theta$), if for all $J = (A, I)$ and $d \in {}^V A \parallel_{-Un}$ we have $\Psi_J(d) = \Theta_J(d)$.

Statement 1 (implied from R \uparrow). Let $z \in Un$, then $R_{\bar{x}, \perp, z}^{\bar{y}, \bar{u}, y} \Phi : Un$ $R_{\bar{x}, \perp, \perp}^{\bar{y}, \bar{u}, y} \Phi$ and $R_{\bar{x}, \perp, \perp}^{\bar{y}, \bar{u}, z} \Phi : Un$ $R_{\bar{x}, \perp, \perp}^{\bar{y}, \bar{u}} \Phi$.

Every Rs -formula can be presented in the form $R_{\bar{y}, \bar{y}, \bar{s}, \perp, \perp}^{\bar{z}, \bar{x}, \bar{r}, \bar{u}, \bar{w}} \Phi$, where $\{\bar{y}, \bar{r}, \bar{s}, \bar{u}\} \subseteq Un$, $\{\bar{v}, \bar{x}, \bar{w}\} \cap Un = \emptyset$.

Un-form $R_{\bar{y}, \perp, \perp}^{\bar{z}, \bar{x}, \bar{w}} \Phi$ (also called *Un-formula*) can be obtained transforming an Rs -formula $R_{\bar{y}, \bar{y}, \bar{s}, \perp, \perp}^{\bar{z}, \bar{x}, \bar{r}, \bar{u}, \bar{w}} \Phi$ in such a manner.

Statement 2. If Ψ is an *Un-form* of a formula Φ , then $\Phi \sim_{Un} \Psi$.

Logical consequence relations. Let us extend logical consequence relations $P \models_{IR}, P \models_T, P \models_F, P \models_{TF}, R \models_{TF}$ defined on formulas of the language L^Q [5] to formulas of the languages $L_{\perp}^Q, L_{\perp}^{Q=}$ and $L_{\perp}^{Q\neq}$.

Firstly, let us specify the following logical consequence relations for two sets of formulas in the interpretation J :

- IR -consequence, or irrefutable $J \models_{IR} : \Phi \models_{IR} \Psi \Leftrightarrow T(\Phi_J) \cap F(\Psi_J) = \emptyset$;
- T -consequence (on truth) $J \models_T : \Phi \models_T \Psi \Leftrightarrow T(\Phi_J) \subseteq T(\Psi_J)$;
- F -consequence (on falsity) $J \models_F : \Phi \models_F \Psi \Leftrightarrow F(\Psi_J) \subseteq F(\Phi_J)$;
- TF -consequence, or strong $J \models_{TF} : \Phi \models_{TF} \Psi \Leftrightarrow \Phi \models_T \Psi$ and $\Phi \models_F \Psi$.

The corresponding logical τ -consequence relations in the semantics α are defined as follows:

$\Phi \models_{\tau} \Psi$, if $\Phi \models_J \Psi$ for every interpretation $J \in \alpha$.

We define a logical τ -equivalence relation in the interpretation J as follows:

A logical τ -equivalence relation in the semantics α are defined as follows:

$\Phi \sim_{\alpha} \Psi$, if $\Phi \models_{\alpha} \Psi$ and $\Psi \models_{\alpha} \Phi$.

Note the importance of the relation $J \sim_{TF} : \Phi \sim_{TF} \Psi \Leftrightarrow T(\Phi_J) = T(\Psi_J)$ and $F(\Phi_J) = F(\Psi_J) \Leftrightarrow \Phi_J = \Psi_J$.

Consequence and logical consequence relations for a pair of formulas can be extended on pairs of sets of formulas.

Let $\Sigma, \Gamma, \Delta \subseteq Fr$ be sets of formulas, J be an interpretation. We will further denote:

$\bigcap_{\theta \in \Sigma} T(\theta_J)$ as $T^c(\Sigma_J)$, $\bigcup_{\theta \in \Sigma} T(\theta_J)$ as $T^v(\Sigma_J)$, $\bigcap_{\theta \in \Sigma} F(\theta_J)$ as $F^c(\Sigma_J)$, $\bigcup_{\theta \in \Sigma} F(\theta_J)$ as $F^v(\Sigma_J)$.

Δ is an IR -consequence of Γ in the interpretation J (denoted $\Gamma \models_{IR} \Delta$), if $T^c(\Gamma_J) \cap F^c(\Delta_J) = \emptyset$.

Δ is T -consequence of Γ in the interpretation J (denoted $\Gamma \models_T \Delta$), if $T^v(\Gamma_J) \subseteq T^v(\Delta_J)$.

Δ is F -consequence of Γ in the interpretation J (denoted $\Gamma \models_F \Delta$), if $F^c(\Delta_J) \subseteq F^c(\Gamma_J)$.

Δ is TF -consequence of Γ in the interpretation J (denoted $\Gamma \models_{TF} \Delta$), if $\Gamma \models_T \Delta$ and $\Gamma \models_F \Delta$.

The corresponding logical τ -consequence relations in the semantics α are defined as follows:

$\Gamma \models_{\alpha} \Delta$, if $\Gamma \models_J \Delta$ for every interpretation $J \in \alpha$.

Here α denotes one of the semantics: $\mathbf{R}, \mathbf{P}, \mathbf{R}^{\neq}, \mathbf{P}^{\neq}, \mathbf{R}^{\neq}, \mathbf{P}^{\neq}$. Thus, there is a total of 24 logical consequence relations.

Some of them coincide, some are degenerate, and the relations $P^{\neq} \models_T, P^{\neq} \models_F, P^{\neq} \models_{TF}, R^{\neq} \models_{TF}$ are incorrect [5, 7, 8]. Therefore, there remain the following undegenerate correct relations in the logics $L_{\perp}^Q, L_{\perp}^{Q=}, L_{\perp}^{Q\neq}$:

$P \models_{IR}, P \models_T, P \models_F, P \models_{TF}, R \models_{TF}; \quad P^{\neq} \models_{IR}; \quad P \models_{IR}, P \models_T, P \models_F, P \models_{TF}, R \models_{TF}.$

We will use $P^\#$ to denote one of the $P, P=, P\equiv; R^\#$ to denote one of the $R, R=, R\equiv; \sim_{TF}$ to denote one of the $R^\# \sim_{TF}, P^\# \sim_{TF}$; and $|\equiv$ to denote one of the $P^\# |\equiv_{IR}, P^\# |\equiv_T, P^\# |\equiv_F, P^\# |\equiv_{TF}, R^\# |\equiv_{TF}$. Also the meaning of the notations $\bar{|\equiv}$ and $\cdot|\equiv$ should be obvious.

Properties of logical consequence relations. As sequent calculi formalise logical consequence relations, properties of the latter become the semantic basis for construction of the respective calculi. Such properties are described in [5–12]. Let us consider only specific for $L_i^{Q=}$ and L_i^Q properties, needed for construction of sequent calculi.

Traditional properties of formulas decomposition are specified in detail in [5].

For Ez and their renominations we have properties of carrying \neg to the other side of a relation:

Properties of equivalent transformations connected with extended renominations hold for $P^\# |\equiv_{IR}, P^\# |\equiv_T, P^\# |\equiv_F, P^\# |\equiv_{TF}, R^\# |\equiv_{TF}$, they are based on the predicates properties $R, R_I, R_U, R_\uparrow, R_\neg, R_\vee, R_{\neg R}$ and R_E . Each of $R, R_I, R_U, R_\neg, R_\vee, R_{\neg R}$ induces 4 corresponding properties for a logical consequence relation, depending on the position of a formula or its negation (either in the left or in the right side of the relation) [6, 10, 12].

R_\uparrow induces the following two foursomes of properties:

R_E induces the next 4 properties of simplification of external renomination of predicates-indicators:

Let us describe properties which guarantee the specified logical consequence relation. There is a general for all considered relations property C and property CF , connected with constant F -formulas (see R_{EF}):

Let us consider properties, connected with $=_{xy}$. Transitivity of the weak equality relation does not hold for $P^\# |\equiv_F$ and $P^\# |\equiv_T$ [7, 8], which implies it does not hold for $P^\# |\equiv_{TF}$ and $R^\# |\equiv_{TF}$ as well. Therefore, $P^\# |\equiv_{IR}$ is the only correct relation in $L_i^{Q=}$.

Transitive property for $=_{xy}$:

4. Sequent calculi for $L_i^{Q=}$ and L_i^Q .

Let us construct calculi of sequent type which formalize logical consequence relations for sets of formulas for $L_i^{Q=}$ and L_i^Q . We will obtain the calculus $C_i^{Q=IR}$ for the relation $P \Vdash_{IR}$ in $L_i^{Q=}$, and calculi $C_i^{Q=TFR}$, $C_i^{Q=TF}$, $C_i^{Q=T}$, $C_i^{Q=F}$, $C_i^{Q=IR}$ for the relations $R \Vdash_{TF}$, $P \Vdash_{TF}$, $P \Vdash_T$, $P \Vdash_F$, $P \Vdash_{IR}$. These calculi extend the calculi for $P \Vdash_{IR}$, $P \Vdash_T$, $P \Vdash_F$, $P \Vdash_{TF}$, $R \Vdash_{TF}$ in L_i^Q [12] and generalize the calculi for logical consequence relations in L^Q [5, 11]. We treat sequents as finite sets of formulas signed (marked, indexed) by symbols \vdash (T -formulas) and \dashv (F -formulas). Sequent is denoted $\vdash \Gamma \dashv \Delta$ (in abbreviated form Σ), where Γ and Δ are the sets of T -formulas and F -formulas respectively.

Sequent calculus is defined by basic sequent forms and closure conditions for sequents.

Closed sequents are axioms of the sequent calculus. The closedness of $\vdash \Gamma \dashv \Delta$ must guarantee $\Gamma \Vdash \Delta$.

Rules of sequent calculus are called sequent forms. They are syntactical analogues of the semantic properties of the corresponding logical consequence relations. The derivation in sequent calculi has the form of a tree, the vertices of which are sequents; such trees are called sequent trees. A sequent tree is closed if every its leaf is a closed sequent. A sequent Σ is derivable if there exists a closed sequent tree with the root Σ , called a derivation of the sequent Σ .

For a set of signed formulas $\Sigma = \vdash \Gamma \dashv \Delta$ let us introduce sets of *defined* and *undefined* names (*val*-variables and *unv*-variables): $val(\vdash \Gamma \dashv \Delta) = \{x \in V \mid Ex \in \Gamma\}$; $unv(\vdash \Gamma \dashv \Delta) = \{x \in V \mid Ex \in \Delta\}$.

Also we specify a set of *undistributed* names for Σ : $ud(\Sigma) = nm(\Sigma) \setminus (val(\Sigma) \cup unv(\Sigma))$.

Closure conditions for a sequent $\vdash \Gamma \dashv \Delta$ correspond to conditions that guarantee a certain logical consequence relation. Thus, we get the following closure conditions for a sequent $\vdash \Gamma \dashv \Delta$.

Construction of a sequent tree. The main action during the process of derivation (construction of a sequent tree) is decomposition or simplification of a formula chosen from the sequent.

Let us describe all stages of the procedure for a given *finite* sequent Σ , for the calculus $C_1^{Q, TFR}$. For the other calculi the process is similar.

We start from the root Σ . On the initial stage *primary distribution* of names is performed: we obtain all the possible distributions of names from $ud(\Sigma)$ to defined and undefined by applying Ed-form (more details in [5, 12]).

Let us describe derivation of an unclosed sequent leaf η ; this implies building a finite subtree with the node η . We activate all non-primitive formulas in the sequent η . A corresponding main form is applied to each active formula. During the process, every time the situation arise, appropriate *auxiliary* forms of the types $R, R_I, R_U, R_{\uparrow}, \equiv eIR$ are used for simplifications.

Forms of the type R_{\uparrow} are applied to primitive formulas and their negations. After that, all primitive formulas in the sequent and their negations become *Un*-formulas, where *Un* is a set of all *unv*-variables of formulas in sequents in the path from root to the current sequent.

Forms of the type $\equiv R_I$ (substitution of equals) are applied every time the following pair of formulas appears: one of the type $\vdash x \equiv y$, another – of the type either $\vdash R_{w,l,x}^{\bar{v}, \bar{u}, z}(p)$, $\vdash R_{w,l,x}^{\bar{v}, \bar{u}, z}(p)$, $\vdash \neg R_{w,l,x}^{\bar{v}, \bar{u}, z}(p)$, or $\vdash \neg R_{w,l,x}^{\bar{v}, \bar{u}, z}(p)$, note that at least one the pair should be *new* for the sequent. Forms of the type $Tr \equiv$ are applied every time the pair of formulas $\vdash \equiv_{xy}$ and $\vdash \equiv_{yz}$ appears, and at least one of them is *new* for the sequent.

During each stage, \exists_T -forms are applied before \exists_F -forms. With each application of \exists_T , a *new* (absent in the path from root to the current sequent) $z \in V_T$ is taken. Each \exists_F -form should be used repeatedly for each defined y of formulas in the path from Σ to the current sequent.

Resulting formula(s) become(s) *passive* after application of a main form and implicated simplifications: at this stage main forms can not be used on them. The obtained sequent should be checked for closedness after applying a form. If a sequent leaf Ω is unclosed, it has to be checked whether Ω is a final sequent.

Unclosed sequent node Ω is called *final*, if there is no applicable form to it or no *new* (differing from formulas on the path ρ from Σ to Ω) formula can be obtained using applicable forms. It signals that the sequent tree has an *unclosed* path (from root to the current final sequent, all its nodes are unclosed sequents): the derivation process ended *negatively*.

Thus, during construction of a sequent tree for a finite sequent, the following cases are possible:

- 1) the construction procedure is completed positively; we obtained a finite closed tree;
- 2) the construction procedure is completed negatively; we obtained a finite unclosed tree. Such tree has at least one unclosed path, all nodes of which are unclosed sequents.
- 3) the construction procedure is not completed; we obtained an infinite unclosed tree. König's lemma [2] states that such tree has at least one infinite path. All its nodes should be unclosed sequents, otherwise this path would finish. Hence, there is an infinite unclosed path in the tree.

During the construction of a sequent tree for a given *countable* sequent Σ , the process also has its stages and starts from the root Σ . There is a finite set of *available* on the current stage formulas; forms can be applied only to these formulas. More on the procedure can be found in [5, 11, 12].

For a sequent tree for a countable sequent the notion of a final node does not make sense, thus only two outcomes are possible:

- 1) the construction procedure is completed positively; we obtained a finite closed tree;
- 2) the construction procedure is not completed; we obtained an infinite unclosed tree with an infinite unclosed path: every formula of the sequent Σ will appear in this path and become available.

For all the introduced calculi the *soundness theorem* holds, with the same formulation and style of proof. The calculi $C_1^{Q, TFR}, C_1^{Q, TF}, C_1^{Q, T}, C_1^{Q, F}, C_1^{Q, IR}, C_1^{Q=IR}$ correspond to the respective logical consequence relations $R \models_{TF}, P \models_{TF}, P \models_T, P \models_F, P \models_{IR}, P \models_{IR}$.

Theorem 2 (soundness). Let the sequent $\vdash_{\Gamma} \Delta$ be derivable in the calculus $C^{\#}$, then $\Gamma \models \Delta$.

If $\perp\Gamma\perp\Delta$ is derivable in the calculus $C^\#$, then a finite closed tree was constructed for this sequent. For any node of the tree $\perp\Lambda\perp K$ we have $\Lambda\models K$. For leaves it is implied from the notion of a closed sequent; by Theorem 1, sequent forms preserve logical consequence relation bottom up. Hence, for the root $\perp\Gamma\perp\Delta$ we also have $\Gamma\models\Delta$.

The counter-model existence theorems. The completeness of sequent calculi is proved on the basis of theorems of the existence of a counter-model for the set of formulas of an unclosed path in the sequent tree. In this case the method of Hintikka (model) sets is used. The proof of the counter-model theorems below is similar to the proof of the corresponding theorems for PCNL [5, 11]. Let us consider the counter-model existence theorem for the calculus $C_{\perp}^{Q, TFR}$.

Theorem 3. Let \wp be an unclosed path in the derivation tree constructed for $\perp\Gamma\perp\Delta$, let H be the set of all specified formulas of this path. Then there exist interpretations $\mathbf{A} = (S, I_A)$, $\mathbf{B} = (S, I_B)$ and data $\delta \in {}^V S$ such that:

We continuously apply forms to sequents of the path \wp while we can: eventually, every non-primitive formula of the path \wp (or its negation) will be decomposed or simplified.

All the sequents of the path \wp are unclosed, therefore the closure condition $C \vee CF \vee C_{Rf} \vee C_{R\cdot} \vee C_{E\cdot L} \vee C_{E\cdot R}$ does not hold. Therefore, for the set H the following correctness conditions hold:

For predicates-indicators and equalities in the interpretations \mathbf{A} and \mathbf{B} we have:

Other clauses connected with Ez and equality predicates are proved likewise.

The rest of clauses can be proved by induction on the formula structure according to the definition of H .

The counter-model existence theorems for the calculi $C_i^{Q,T}$, $C_i^{Q,F}$, $C_i^{Q,TF}$, $C_i^{Q,IR}$, $C_i^{Q,IR}$ can be formulated and proved in the same manner. Below, we will provide the theorems for the calculi $C_i^{Q,TF}$ and $C_i^{Q,IR}$.

Theorem 4. Let \wp be an unclosed path in the sequent tree constructed in $C_i^{Q,TF}$ for $\vdash \Gamma \neg \Delta$, let H be the set of all specified formulas of the path \wp . Then there exist interpretations $\mathbf{A} = (S, I_A)$, $\mathbf{B} = (S, I_B)$ and data $\delta \in {}^V S$ such that:

- $H_T^S \vdash \Phi \in H \Rightarrow \Phi_A(\delta) = T$ and $\neg \Phi \in H \Rightarrow \Phi_A(\delta) \neq T$;
- $H_F^S \vdash \Phi \in H \Rightarrow \Phi_B(\delta) \neq F$ and $\neg \Phi \in H \Rightarrow \Phi_B(\delta) = F$.

The pairs (\mathbf{A}, δ) and (\mathbf{B}, δ) are called T^P -counter-model and F^P -counter-model for $\vdash \Gamma \neg \Delta$ respectively.

In the formulations of the counter-model theorems, for the calculus $C_i^{Q,T}$ only the interpretation $\mathbf{A} = (S, I_A)$ and clause H_T^S remain, while for the calculus $C_i^{Q,T}$ only the interpretation $\mathbf{B} = (S, I_B)$ and clause H_F^S remain.

Theorem 5. Let \wp be an unclosed path in the sequent tree constructed in $C_i^{Q,IR}$ for $\vdash \Gamma \neg \Delta$, let H be the set of all specified formulas of the path \wp . Then there exist an interpretation $\mathbf{A} = (S, I)$ and data $\delta \in {}^V S$ such that:

- $H_C \vdash \Phi \in H \Rightarrow \Phi_A(\delta) = T$ and $\neg \Phi \in H \Rightarrow \Phi_A(\delta) = F$.

The pair (\mathbf{A}, δ) is called $IR \equiv$ -counter-model for the sequent $\vdash \Gamma \neg \Delta$.

For the calculus $C_i^{Q,IR}$, the formulation of the counter-model existence theorem matches with the Theorem 5.

The completeness theorem. The theorems of the existence of a counter-model allow us to obtain the corresponding *completeness theorems* with the same formulation for all of the introduced here calculi.

Theorem 6 (completeness). Let $\Gamma \models \Delta$, then the sequent $\vdash \Gamma \neg \Delta$ is derivable in the calculus $C^\#$.

Let us show the proof for the relation $R_{\vdash} \models_{TF}$ and calculus $C_i^{Q,TFR}$ (for more similar proofs see [5, 12]).

Assume that $\Gamma \models_{TF} \Delta$, but the sequent $\vdash \Gamma \neg \Delta$ is not derivable. In this case the sequent tree for $\vdash \Gamma \neg \Delta$ is not closed, thus, an unclosed path \wp exists in this tree. Let H be the set of all signed formulas of this path. By the Theorem 3, there exist a T -counter-model (\mathbf{A}, δ) and an F -counter-model (\mathbf{B}, δ) such that:

- $\vdash \Phi \in H \Rightarrow \delta \in T(\Phi_A)$ and $\neg \Phi \in H \Rightarrow \delta \notin T(\Phi_A)$; $\vdash \Phi \in H \Rightarrow \delta \notin F(\Phi_B)$ and $\neg \Phi \in H \Rightarrow \delta \in F(\Phi_B)$.

For T -counter-model, by $\vdash \Gamma \neg \Delta \subseteq H$ for all $\Phi \in \Gamma$ we have $\delta \in T(\Phi_A)$, for all $\Psi \in \Delta$ we have $\delta \notin T(\Psi_A)$. Whence $\delta \in T(\Gamma_A)$ and $\delta \notin T(\Delta_A)$, therefore $T(\Gamma_A) \subseteq T(\Delta_A)$ does not hold. This contradicts to

$\Gamma_A \models_T \Delta$, so it contradicts to $\Gamma^R \models_{TF} \Delta$.

For F -counter-model, by $\perp \Gamma \Delta \subseteq H$ for all $\Phi \in \Gamma$ we have $\delta \notin F(\Phi_B)$, for all $\Psi \in \Delta$ we have $\delta \in F(\Psi_B)$. Whence $\delta \notin F(\Gamma_B)$ and $\delta \in F(\Delta_B)$, therefore $F(\Delta_B) \subseteq F(\Gamma_B)$ does not hold. This contradicts to $\Gamma_B \models_F \Delta$, so it contradicts to $\Gamma^R \models_{TF} \Delta$.

5. Conclusion

We study new classes of software-oriented logical formalisms – pure first-order logics of partial quasiary predicates with extended renominations and predicates of strong equality and of weak equality, denoted respectively L_i^Q - and $L_i^{Q=}$. For the considered logics, main properties of their compositions are given, and their languages are described. We define various variants of logical consequence relations and describe their properties, paying special attention to those connected with equality predicates. For the introduced logical consequence relations we construct calculi of sequent type. We specify basic sequent forms for the presented calculi and conditions for sequent closedness, and describe the derivation procedure via a sequent tree. The counter-model existence theorems are considered; an example illustrating a counter-model construction by an unclosed path in the sequent tree is provided. For the studied calculi, the soundness and completeness theorems are proved; the proof of the completeness theorems is based on a construction of the respective counter-models. In the future we plan to investigate extending the logic L_i^Q with the composition of predicate complement.
