- ✓ If you can only provide two public documents, submit Form DS-60, Affidavit Regarding a Change of Name, from two or more people who can swear or affirm that they have known you by both names and that your new name has been used exclusively for five years or more.

An affidavit is not needed if an applicant presents a court order or marriage certificate documenting the change of name. The Department will retain the completed affidavit, and requests for copies of the affidavit should be made at the time of its execution. Final determination of the name(s) to be shown in the U.S. passport will be made by the Department of State based on all submitted evidence.
